DRAFT ORDINANCES.

MINUTE.

The following Draft of a proposed Ordinance is published for general information:---

> An Ordinance for making provision for the Public and the Railway Services, and the Electrical Undertakings for the financial year 1937-38.

BE it enacted by the Governor of Ceylon, with the advice and consent of the State Council thereof, as follows:-

Short title.

1 This Ordinance may be cited as the Appropriation of 1937. Ordinance, No.

Appropriation for the financial year 1937-38.

2 Without prejudice to any other law authorising any expenditure, sums not exceeding ninety-nine million and fifty-five thousand three hundred and eleven rupees, twenty million eight hundred and forty-five thousand five hundred and ten rupees and two million eight hundred and ninety-four thousand three hundred and twenty-nine rupees are hereby declared to be payable for the service of the financial year beginning on October 1, 1937, and ending on September 30, 1938, out of the revenue and other funds of the Island, the Ceylon Government Railway and the Electrical Undertakings respectively; and the said sums may be expended as specified in the Schedules to this Ordinance.

Objects and Reasons.
