9. The lessee shall not assign, transfer, or sublet the premises without the written consent of the Government Agent, Western Province.

10. Entry into and exit from the Infectious Diseases Hospital premises, Angoda, will be by permit to be obtained from the Medical Superintendent, Infectious Diseases Hospital, Angoda, who will have the power to suspend the use of the permit for the time being if the necessity for such a step arises. If the lessee incurs any loss by reason of such suspension a reasonable refund of the rent as compensation will be made to the lessee who shall be bound to accept the Government Agent's decision as to the amount as final.

11. On expiry or earlier termination of the lease the lessee shall deliver quiet possession of the land to any person acting under the orders of the Government Agent, Western Province.

12. The Government Agent reserves the right to reject any or all of the tenders.
