#### GOVERNMENT NOTIFICATIONS.

Customs Notification (Tariff) No. 37/7.

THE PUBLIC REVENUE PROTECTION ORDINANCE, No. 33 of 1921.

THE following Order, made by His Excellency the Officer Administering the Government in pursuance of the powers vested in the Governor by Section 2 of the Public Revenue Protection Ordinance, No. 33 of 1921, is hereby published for general information.

The Public Revenue Protection Ordinance, No. 33 of 1921, Order under Section 2.

WHEREAS I, Maxwell MacLagan Wedderburn, the Officer Administering the Government of Ceylon, have, during the present session of the State Council, approved of the introduction into that Council of a Resolution whereby the Import Duties now payable on the goods, wares, or merchandise specified in Column I of the Schedule hereto shall be altered.

Now, therefore, in pursuance of the powers vested in the Governor by Section 2 of the Public Revenue Protection Ordinance, No. 33 of 1921, and by Article 93 of the Ceylon (State Council) Order in Council, 1931, I, the Officer Administering the Government, do hereby order the Principal Collector of Customs from four o'clock in the afternoon of July 28, 1937, to demand and to levy on the goods, wares, or merchandise specified in Column I of the Schedule hereto the respective Import Duties set out in Column II in lieu of the Import Duties payable thereon under the existing law.
