KNOW Ye that We, the Officer Administering the Government of Ceylon, in the exercise of the powers vested in the Governor by Article 4 of the Ceylon Importation of Textiles (Quotas) Orders in Council, 1934 and 1936, do hereby proclaim that of the classes of textile goods severally described in the first column of the schedule hereto, and manufactured in the foreign countries mentioned in the second column of that schedule the total quantities which may be imported into the Island, during the quota period specified at the head of the third column of that schedule, shall be the amounts expressed in yards of standard width in the corresponding entries in the third column of that schedule.

THE CEYLON IMPORTATION OF TEXTILES (QUOTAS) ORDERS IN COUNCIL, 1934 AND 1936.

(Textiles (Quotas) Notification No. 37/2.)

REGULATION

The Textile Quotas Regulations, 1934, published in Gazette Extraordinary No. 8,069 of July 31, 1934, are hereby amended in Regulation 4 (1) thereof as follows:

- (i.) by the substitution, in Column I. of the Table subjoined to that regulation, for the words "grey or bleached" wherever they occur, of the word "bleached"; and
 (ii.) by the omission from Column I. of the aforesaid Table, of the words "Shirting (grey)".

MISCELLANEOUS DEPARTMENTAL

Notice to Importers.

THE effect of the exclusion of grey cotton piece goods from the above Proclamation is to exempt them from regulation.

- 2. Licences will still be required for importation during 1938 of bleached, dyed and printed cotton and artificial silk piece goods from China, France, Germany, Holland, Italy, Japan, Switzerland, and the United States of America.
- 3. The principles on which licences shall be issued for 1938 are as yet unsettled, but it is contemplated that the occasion of the increase of the quotas by 50 per cent. may be utilized to introduce a wider distribution of licences.
- 4. The earliest possible notice will be given to importers by this department of the general method of allocation of licences for 1938.
