# PROCLAMATIONS BY THE GOVERNOR.

BY HIS EXCELLENCY THE GOVERNOR.

A PROCLAMATION.

## A. CALDECOTT.

KNOW Ye that by virtue of the powers vested in me by section 31 of the Births and Deaths Registration Ordinance, 1895, and by Article 93 of the Ceylon (State Council) Order in Council, 1931, I, Andrew Caldecott, Governor of Ceylon, do by this Proclamation—

- (a) amend the Proclamation under the said section, dated September 12, 1935, and published in the Supplement to Gazette No. 8,146 of September 20, 1935, in the manner set out in the schedule hereto; and
- (b) declare that this Proclamation shall come into effect on the First day of January, 1938.

#### SOHEDULE.

Schedule I to the Proclamation dated September 12, 1935, is hereby amended by the substitution, for the definition of Trincomalee Town in the Trincomalee District of the Eastern Province, therein appearing and reproduced in Column I, of the definition appearing in Column II hereunder.

#### Column I.

Limits as defined by Proclamation dated September 12, 1935.

Trincomalee Town comprising the area within the

following boundaries:

North: From a point 191 chains north-west of the 3rd milestone on the Anuradhapura road eastwards along the landmarked boundary to its junction with Love lane; thence along the western side of Love lane as far as its junction with the North Coast road; thence along the western side of the North Coast road to a point 37 links south of the 3rd milestone on the said road; and thence north-eastwards along the landmarked boundary to the

East: From the last mentioned point southwards along the edge of the sea until it meets the common boundary between Fort Frederick and the Esplanade, thence southwards along the said boundary until it meets the sea, and thence along the edge of Dutch Bay to a point 16 chains

south-east of the Residency.
South: From the last mentioned point westwards along the boundary defined with War Department Stones, thence across Court road, thence along the northern bank of the water-course, thence along the northern side of the Inner Harbour to a point 25 links west of the beacon to the south-west of Orr's hill.

West: From the last mentioned point north-eastwards along the eastern side of Yard Cove until it meets the Anuradhapura road, thence north-westwards along the southern side of the said road to the starting point of the northern boundary.

#### Column II.

Limits as defined by this Proclamation.

Trincomalee Town comprising the area within the

following boundaries:

North: From a point on the southern boundary of the Anuradhapura road 191 chains north-west of the 34th milestone eastwards along the landmarked boundary to its junction with Love lane; thonce along the western side of Love lane as far as its junction with the North Coast road; thence along the western side of the North Coast road to a point 37 links south of the 3rd milestone on the said road and thence north-eastwards along the landmarked boundary to the sea.

East: From the last-mentioned point southwards along the edge of the sea until it meets the common boundary between Fort Frederick and the Esplanade, thence southwards along the said boundary until it meets the Dutch Bay and thence along the edge of Dutch Bay to a point 16 chains south east of the Residency.

South: From the last-mentioned point westwards along the landmarked boundary to the eastern side of Court road, thence across Court road, thence along the northern bank of the water-course, thence along the northern side of the Inner Harbour to a point 25 links west of the beacon to the

south-west of Orr's hill.

West: From the last-mentioned point north-eastwards along the eastern side of Yard Cove until it meets the Anuradhapura road, thence north-westwards along the southern side of the said road as far as the southern boundary of lot 91 in F. V. P. 15, thence south westwards and northwards along the southern boundaries of lots 91 and 90, eastern and southern boundaries of lot 92, southern and western boundaries of lot 93, western and northern boundaries of lot 95A and western boundary of lot 87 in F. V. P. 15 to the southern side of the Anuradhapura road, thence north-westwards along the southern side of the said road to the starting point of the northern limit.

#### GOVERNMENT NOTIFICATIONS.

THE BIRTHS AND DEATHS REGISTRATION ORDINANCE, 1895.

BY virtue of the powers vested in me by section 6 of the Births and Deaths Registration Ordinance, 1895, and by Article 93 of the Ceylon (State Council) Order in Council, 1931, I, Andrew Caldecott, Governor of Ceylon, do by this notification-

- amend the Schedule to the notification under the said section, dated September 13, 1935, and published in the Supplement to Gazette No. 8,146 of September 20, 1935, in that part thereof which is set out under the heading "Eastern Province, Trincomalee District." in the manner following:—
  - (a) under the sub-heading "1. Trincomalee Town Division", by the substitution, for all the words from "Division Nos." to "limits of Trincomalee", of the words "The area within the administrative limits of the Trincomalee Urban District Council"; and
  - (b) under the sub-heading "2. Sampaltivu Division.", by the omission of the words "Division No. 12 (portion outside Trincomalee Urban District Council limits)." and "Maddikkali" from the list of villages therein; and
- (2) declare that this notification shall come into effect on the First day of January, 1938

### THE SMALL TOWNS SANITARY ORDINANCE, 1892,

IT is hereby notified that the Governor has, by virtue of the powers vested in him by the provise to section 9E (2) (s) (c) of the Small Towns Sanitary Ordinance, 1892, and by Article 93 of the Ceylon (State Council) Order in Council, 1931, sanctioned the levy, for the year 1938, by the Sanitary Board of the District of Kandy, of a conservancy rate of three per centum on the annual value of every house, building, land, or tenement situate within the limits of the towns of Wattegama, Pussellawa, and Kadugannawa, Kandy District, as determined for the purposes of the assessment rate levied under the Ordinance for the year 1938, provided that the amount recoverable as such conservancy rate in respect of any one house, building, land, or tenement shall not be less than three rupees or more than thirty-six rupees, and provided further, that the premises bearing the assessment numbers enumerated in the Schedule hereto shall be exempt from the payment of such conservancy rate.
