

Improvements in and relating to magnetic separators.

Abstract.—The inventors describe a magnetic separator which can be used either as a deflector type separator with gravity feed, or as a lifter type separator in which the material is fed by conveyor bands. In the embodiment described, a casting is provided carrying a central core for the coil. On this abuts a second casting having four faces machined to receive four detachable pole pieces. Two kinds of pole pieces are provided, one for each mode of operation.

In the gravity type, the separator is arranged with the longitudinal axis of core horizontal. The pole pieces are relatively blunt nosed and in each gap is provided a roller which deflects the magnetic material away from the bulk. The material is fed successively through each of the gaps which are in vertical alignment.

To use the apparatus as a lifting separator the core is disposed so that its longitudinal axis is vertical. Thus each pair of gaps is in horizontal alignment. The pole pieces are rather sharp in profile. A conveyor band feeds the material through each pair of gaps. The magnetic action lifts the magnetic material to the underside of other conveyor bands, four in number, which move horizontally at right angles to the feeding conveyors.

Improvements relating to machinery for rolling rubber and similar material.

Abstract.—The inventor states that it is customary to arrange rubber rolling machines in a battery to be driven off the same shaft and to provide reduction gearing and clutch for each machine. The object of the present invention is to eliminate independent clutches and gears.

According to the invention, corresponding rolls of individual machines are mounted in axial alignment, coupled together and driven through a common reduction gear. The rolls of each machine are coupled by suitable gear wheels. The number of teeth in the gear wheels of several machines may be varied; for example, those in the first may have an equal number of teeth, those in the second may have 16 and 24 teeth respectively to exert a rubbing as well a pressing action. Means are provided for adjusting the gap between the rolls of the machines.

Improvements in and relating to withering racks for tea and to manner of withering.

Abstract.—The inventor states that in the withering racks hitherto employed for tea the withering surfaces were arranged one above the other. Tea leaf had to be thrown in and spread by hand, and when withered had to be swept out. The clearance between the surfaces was of necessity high (about one foot) and surfaces have a tendency to sag in course of time. Endless bands arranged one above the other have been proposed, but these do not overcome the disadvantage of large clearance, and were also liable to stretch.

The inventor accordingly describes an apparatus for withering tea leaf, having a pair of posts at either end; longitudinally wires (runners) are stretched between these posts; the withering surfaces which are of light hessian are wound on rollers mounted on one pair of posts; each strip is capable of being spread by means of a cross bar attached to it sliding along a pair of runners. Transverse rods are hooked on to the runners and are so adapted that as the withering surface unrolls they take up equidistant positions underneath it and supporting it; this is

accomplised by attaching them to the cross bar by tapes, portions of which tauten at the required instants and drag the rods along; on rolling up the withering surface these transverse rods are carried along and bunched up at the roller end. Intermediate posts may be arranged to support the runners if necessary, but rollers should be provided to enable the transverse rods and cross bar to ride over the supports.

The method of operation is as follows:

The lowest surface is spread out by drawing the cross bar and fixing it in position by catches or other means to the posts at one end. The surface is now tightened up by its roller which has a pawl and ratchet arrangement for the purpose. After the leaf has been spread on this surface the next surface above is unrolled and spread with leaf and so on.

To discharge the tea leaf from a surface the cross bar is released and the roller wound up. The rollers themselves are of irregular section, or are provided with ribs so that any tendency for the withered leaf to stick is counteracted by the bending and stretching the surface undergoes over the irregular surface.

The inventor claims that by these means the clearance between the surfaces can be reduced to as much as 6". Further, no rigidity is required of the withering surface which may be of porous material allowing free circulation of air.
