## BY-LAW.

The by-laws relating to leave of absence to officers and minor employees of the Kandy Municipal Council, published in *Gazette* No. 7,219 of October 21, 1921, as last amended by by-law published in *Gazette* No. 8,203 of February 21, 1936, are hereby further amended as follows:—

(1) by the addition, immediately after by-law 23, of the following new by-law which shall have effect as by-law 23A:—

" Officer retiring while on commuted half-pay leave.

23A. When an officer retires or is invalided out of the service while on leave, he will be liable to be called upon to refund half salary in respect of any commuted half-pay leave which he may have taken since his last period of resident service." ; and

(2) by the addition, immediately after by-law 33, of the following new by-law, which shall have effect as by-law 34:—

" Leave preparatory to retirement.

34. (1) On retirement from the Municipal Service an officer shall not be granted any leave other than the vacation leave for which he is eligible.

(2) An officer whose leave preparatory to retirement commences from a date prior to April 1 in any calendar year may be granted leave calculated as follows:—

(a) The amount of ordinary vacation leave available in respect of the preceding year, plus proportionate leave for the current year at the rate of two weeks' leave for every month's service prior to the commencement of the leave; or

(b) The amount of ordinary vacation leave available in respect of the two preceding years, whichever is greater.

Any vacation leave already taken by the officer during the year in which his leave preparatory to retirement commences will be deducted from the amount of leave available under paragraph (a) or paragraph (b)."

BY-LAWS.

1. In these by-laws unless the context otherwise requires—

“Chairman” means the Chairman of the Nuwara Eliya Urban District Council;

“Council” means the Nuwara Eliya Urban District Council;

“latrine” means a sanitary convenience of any kind and includes a cesspit, catchpit, septic tank, soakagepit, and any other similar sanitary arrangement; and

“owner” in relation to any land or premises, includes a person having the charge or management of the land or premises in the absence of the owner, and an occupier who by the terms of his tenancy is responsible for all works of construction, repair or maintenance upon the land or premises.

2. No person shall build or cause to be built any latrine on any land or premises belonging to or occupied by him within the administrative limits of the Council, unless he is the holder of a written permit issued by the Chairman in that behalf.

3. The Chairman may refuse a permit if he is of opinion that the construction of the latrine is likely to give rise to a nuisance or be injurious to the health of the occupants of the neighbouring lands or premises, or should not be permitted on any other sanitary grounds.



4. Where the Chairman decides to issue a permit he may attach to the permit such conditions as he may deem necessary, including either or both of the following conditions :—

- (a) that the latrine to be constructed shall be of such type as may be specified in the permit ;  
 (b) that the latrine shall be constructed on such site as may be specified in the permit.

5. No person shall build or cause to be built a latrine in contravention of the conditions attached to the permit issued to him.

6. (1) Where any person builds or causes to be built any latrine without a permit from the Chairman or in contravention of the conditions attached to the permit issued to him, the Chairman may by written notice served on that person order him to demolish the building and to fill up any pit excavated for the purposes of the latrine, within such reasonable time as may be prescribed in such notice.

(2) Every person on whom a notice is served under paragraph (1) shall comply therewith within the time prescribed therein.

7. (1) The Chairman may by written notice served on the owner of any land or premises not provided with a latrine order him to construct upon the land or premises, a latrine of such type and size and in such position and with such connecting drains, as may be specified in the notice, within such reasonable time as may be prescribed therein.

(2) Every owner on whom a notice is served under paragraph (1) shall comply therewith within the time prescribed therein.

8. The occupier of any premises upon which any latrine stands shall keep the latrine in good repair and in a clean and sanitary state, and shall take all such measures and precautions as may be necessary to ensure that no nuisance is caused by the latrine.

9. (1) Where any latrine is structurally defective or in a condition likely to give rise to a nuisance, or does not abut upon and cannot be conveniently conserved from a conservancy lane, the Chairman may by written notice served on the owner of the land or premises on which such latrine stands, order that owner to repair, alter, or reconstruct the latrine, or to demolish the building and fill up any pit excavated for the purposes of the latrine, within such reasonable time as may be prescribed in the notice ; and the Chairman may by that notice or by a subsequent notice give further directions as to the position, level and size of any pit to be excavated for the purposes of the latrine, the materials to be used, the manner in which the construction of the latrine is to be carried out and any other details in connection with such latrine.

(2) Every owner on whom a notice is served under paragraph (1) shall comply therewith within the time prescribed therein.

10. (1) The occupier of any land or premises, upon which there is any catchpit in which dirty water collects and stagnates, shall take out such water or cause it to be taken out daily and removed to such place as the Chairman may provide or approve.

(2) Where any nuisance arises by reason of the failure of the occupier of any land or premises to remove dirty water from any catchpit situated on the land or premises, the Chairman may give written notice to the occupier that the Council will, on and after a date prescribed in such notice, undertake the daily removal of such water, free of all charges.

(3) The occupier of any land or premises to whom notice is given under paragraph (2) shall, on and after the date prescribed in the notice, permit the officers and servants of the Council to enter upon the land or premises and to remove the water collecting in the catchpit and take such other measures as may be necessary.

11. (1) No person shall carry out or cause to be carried out any work of conservancy except with the written permission of the Chairman.

(2) The Chairman may at his discretion refuse to grant the permission referred to in paragraph (1), if he is of opinion that the work of conservancy can be adequately carried out by the Council.

12. Every contravention of any of the foregoing by-laws shall be punishable with a fine not exceeding fifty rupees.

13. The by-laws relating to conservancy made by the Board of Improvement, Nuwara Eliya, published in *Gazette* No. 6,415 of December 16, 1910, and continuing in force by virtue of section 247 of the Ordinance, are hereby revoked.

occupation fee, a special fee of 50 cents for each period not exceeding one hour. Every person so using the resthouse shall desist from doing so upon being requested by the resthousekeeper, whose duty it is to consult the comfort and convenience of the occupants of the resthouse.

(2) The Chairman may permit the use of the resthouse or any portion thereof for the purpose of any lunch, dinner, garden party or other organized reception, on payment of a fee, for occupation only, of ten rupees for the first six hours and one rupee for every additional period not exceeding one hour.

2. A consolidated fee at the rate set out in the schedule hereto shall be paid by every person, using or occupying the resthouse or garage: Provided that no fee shall be charged in respect of the following:—

- (a) an infant in arms;
- (b) a servant who is in attendance on a visitor at the resthouse and sleeps within the resthouse;
- (c) a chauffeur of any car garaged in the resthouse premises, if he sleeps in the car or in the garage.

3. (1) Every visitor shall, on his admission to the resthouse, legibly write the correct name and address in the resthouse book.

(2) No visitor shall be entitled to use the resthouse or to be supplied with refreshments until he has complied with the requirements of paragraph (1).

4. No person shall occupy any portion of the resthouse for more than three consecutive days, without the special authority in writing of the Chairman of the Urban District Council.

5. No charges other than those payable to the Urban District Council shall be entered in the resthouse book by a visitor.

6. The resthouse fees and charges shall be paid in cash on demand. In default of such payment, the resthousekeeper shall be entitled to refuse further supplies. The attention of visitors is invited to the Hotel Keepers' Protection Ordinance, 1908, a copy of which shall be exhibited, together with these rules, in some conspicuous place in the resthouse.

7. (1) No room shall be reserved unless it is engaged at least one day in advance.

(2) When a room is so reserved, it shall be paid for even if the person engaging it does not occupy it.

(3) Until the arrival of the person or persons for whom a room is reserved, the room shall be at the disposal of any other person requiring it.

8. The resthousekeeper shall not be bound to comply with any telegram requesting meals to be prepared unless the name and address of the sender are set out in the telegram.

9. No bed, sofa, or couch in the resthouse shall be used by any visitor for the purpose of sleeping unless a sheet is spread thereon. A breach of this rule shall be punishable with a fine of Rs. 5.

10. The value of all articles damaged or broken by any visitor or his servant shall be paid by that visitor in accordance with the scale of charges appearing on the resthouse notice board.

11. Visitors shall be entitled to call upon the resthousekeeper to attend on them personally. The resthousekeeper and servants shall wear clean white coats and cloths when attending on visitors.

12. (1) Any complaint which a visitor may have to make about the resthouse or the resthousekeeper, shall be noted in the complaint book.

(2) It shall be the duty of the resthousekeeper to produce the complaint book when called upon to do so.

13. No visitor shall bring any dog into the resthouse.

14. A breach of any of the above rules other than rule 9, shall be punishable with a fine not exceeding Rs. 50.

15. The rules published in *Gazette* No. 7,484 of September 11, 1925, and the tariff published in *Gazette* No. 8,201 of February 7, 1936, are hereby revoked.

#### FEES PAYABLE TO THE URBAN DISTRICT COUNCIL.

##### (1) Occupation.

Each person occupying any portion of the resthouse—

A consolidated fee of 10 cents per hour subject to a minimum charge of 25 cents when any meal other than afternoon tea is taken, and a maximum charge of Re. 1.50 in respect of any continuous period of 24 hours.

(This fee includes the use of towels, linen, beds, mosquito curtains, lights, &c.)

##### (2) Garaging and Stabling.

For each vehicle, motor car, or motor cycle garaged, or for any horse stabled, a fee of 25 cents for each continuous period not exceeding 24 hours.

(No fee is charged for any vehicle brought into the resthouse compound.)
