The tenders which must be enclosed in sealed envelopes superscribed "Tender for the Right to take the Produce of Rubber Trees" will be received at the Ratnapura Kachcheri until 11 A.M. on July 28, 1938, when they will be opened and all persons making tenders will be required to be present or satisfy the Government Agent, Province of Sabaragamuwa, by some duly accredited agent or agents that the tender is *bona fide*.

3. The person whose tender is accepted by the Government Agent will be required to deposit the full amount of his tender at once in cash and obtain the necessary lease.

4. Tenders must be made for each land separately.

5. The lessee shall further undertake to keep the land free of jungle growth.

6. The lessee shall wherever necessary take adequate measures to prevent silting of the adjoining land or stream by means of silt traps, contour drains or otherwise.

7. At the expiration or sooner determination of the lease, the lease shall yield quiet possession of the land to any person acting under the orders of the Government Agent.

8. The extent given is only approximate and if the actual total extent of the land should hereafter be found to be less than the extent set forth below, no claim for refund or rebate on account of shortage in extent will be considered unless the variation exceeds 10 per cent. of the stated extent.
