The lessee shall deposit six months' rent in cash as security on the date of sale, and shall pay rent quarterly in advance to the Government Agent, Western Province.

The lessee will be entitled only to the produce of the

trees (matured nuts only).

The lessee or his employees shall not cut down any trees or interfere with any existing fence, boundary, or any buildings.

5. The lessee shall not remove sand, gravel, &c., from the demised land; and further he is not to spoil or damage any portion of the said land.

The lessee shall be bound to fence the land leased to him if called upon to do so by the lessor or his agent or

agents.

7. The lessee shall thoroughly weed and keep the land clean and maintain and care for all trees standing on the land in a husbandlike manner. Further he shall keep the land clean of all weeds and undergrowth, lop off hanging branches, and collect and burn fallen branches, young coconut husks, &c., to the satisfaction of the Director of Medical and Sanitary Services or of a deputy acting under his orders.

8. The lessee shall pay all rates and taxes and fully comply with the Sanitary Board or Village Committee's

regulations.
