The successful bidder shall, within one month of the date of communication to him of Government's approval of the acceptance of his bid, pay the first year's rent and enter into and execute a lease which shall embody, among others as may be agreed upon, the following conditions, and on his failure, neglect or refusal to enter into and execute such lease the amount of the deposit hereinbefore referred to shall be forfeited to His Majesty :-

- (f) the lessee not to assign this lease or create or transfer any interest therein or mortgage his interests in this lease or create any change in or over the said interests without the consent of the lessor first had and obtained in writing; (g) the lease to be terminable ordinarily on six months'
- notice in writing being given by either party to the other. In either event the lessor not to be liable to pay any compensation; (h) buildings to be removed by the lessee on the expiry
