2. The tenders which must be in sealed envelopes must be placed in the tender box at the Kandy Kachcheri before 11 A.M., on Thursday, December 1, 1938.

3. Every tenderer must be present in person or send a duly accredited agent to satisfy the Government Agent that the tender is made *bona fide*.

Conditions.

(1) On the acceptance of his tender the successful tenderer shall pay one-third of the tendered sum forthwith and the balance in two equal instalments on or before January 1, 1940, and January 1, 1941, and sign a lease permit on form Government Agent, C. 144.

(2) The permit shall expire at any time on one calendar month's notice being served on the lessee or left on the premises.

(3) The lessee shall not sublet, transfer or assign, his interest in the said land, except with the consent of the officer issuing the permit previously obtained in writing, and in any such case the new lessee shall obtain a new permit in his own name.

Thorn enclosing all the lands referred to in the schedule mentioned below and according to the boundaries as shown in the plan which will be attached to the lease permit, and shall maintain such fence in good condition to the satisfaction of the Government Agent, Central Province, or his Assistant.

(11) The lessee shall permit the lessor, his agent or agents to inspect the land at any time.

(12) All mining, gemming and quarrying rights are reserved to the Crown.

(13) Any breach of any of the terms and conditions shall render the permit liable to immediate cancellation without compensation, on the orders of the Government Agent or his Assistant.
