FINAL ORDERS.

Order under section 4 sub-section (1) of the Waste Lands Ordinances of 1897, 1899, 1900, 1903, and 1927 declaring land to be the property of the Crown.

In the matter of the land commonly called or known as Bomaluwahinnepatana situate in the village of Telihunna in Ganga Ihala korale of Uda Palata division of the Kandy District of the Central Province, and of the Waste Lands Ordinances of 1897, 1899, 1900, 1903, and 1927.

WHEREAS in pursuance of section 1 of the said Ordinances it was duly notified on July 26, 1929, that if no claim to the land commonly called or known as Bomaluwahinnepatana, situated in the village of Telihunna in Ganga Ihala korale of Uda Palata division of the Kandy District in the Central Province; containing in extent 4 acres 1 rood and 18 perches, and shown as lot 13 in preliminary plan No. 7,829, was made to E. R.
