FINAL ORDERS.

Order under section 4 sub-section (1) of the Waste Lands Ordinances of 1897, 1899, 1900, 1903, and 1927 declaring land to be the property of the Crown.

In the matter of the land commonly called or known as Bomaluwahinnepatana situate in the village of Telihunna in Ganga Ihala korale of Uda Palata division of the Kandy District of the Central Province, and of the Waste Lands Ordinances of 1897, 1899, 1900, 1903, and 1927.
