 - the by-laws, rules and regulations of the Colombo Municipal Council ; and all fees and charges properly payable to the Council in relation to the said works to be paid by the lessee ;

- (e) the lessee to keep the exterior and interior of the buildings to be erected as aforesaid and all other buildings and erections which may at any time during the said term be erected on the land and all additions to such buildings and the fixtures therein and the drains and appurtenances thereof in good and substantial repair and condition ;
- (f) the lessee not to assign this lease or create or transfer any interest therein or mortgage his interests in this lease or create any change in or over the said interests without the consent of the lessor first had and obtained in writing ;
