## THE CEYLON IMPORTATION OF TEXTILES (QUOTAS) ORDERS IN COUNCIL, 1934 AND 1936.

(Textiles (Quotas) Notification No. 38/1.)

REGULATION made by the Governor under Article 10 of the Ceylon Importation of Textiles (Quotas) Orders in Council, 1934 and 1936.

#### REGULATION.

The Textile Quotas Licensing Regulations, 1934, published in *Gazette* No. 8,078 of September 11, 1934, and amended by the Textile Quotas (Amending) Regulations, 1936, published in *Gazette* No. 8,229 of June 26, 1936, are hereby further amended as follows :---

(1) by the substitution, for regulation 3, of the following new regulation :----

"3. No regulated textiles, save only such as are imported in accordance with any direction we by the Governor under the proviso to Article 7 of the Order in Council, shall be imported into this Island, except under a licence in conformity with these regulations, from any such country as may from time to time be specified by the Governor by notification in the *Gazette* as a country to which this regulation shall be applicable. In determining whether or not a country shall be so specified regard shall be had to the extent to which that country has filled its quotas in previous quota periods or in previous portions of the current quota period.";

(2) by the substitution, for regulation 4, of the following new regulation :---

"4. The Collector may, if he considers it necessary, invite applications for licences to import any regulated textiles. Such applications shall be made to him on or before a date to be fixed and notified by him for each quota period and shall be in such form as may be provided by him for the purpose.";

(3) in the Schedule thereto, by the omission of Form E.

REGULATION.

The regulations under section 79 of Ordinance No. 17 of 1869, published in *Gazette* No. 7,801 of September 5, 1930, are hereby amended as follows :----

- (1) in regulation 1 thereof, by the addition immediately after the words and figures " by the deposit with the Collector of the sum of Rs. 1,000 ", of the words " (the interest on which, less the share of such interest which shall be fixed annually by the Principal Collector of Customs and shall accrue to the Crown, shall be payable to the depositor)"; and
- (2) in regulation 7 thereof, by the substitution, for the words "The interest on such deposit will accrue to revenue", of the words "The interest on such deposit, less the share of such interest which shall be fixed annually by the Principal Collector of Customs and shall accrue to the Crown, shall be payable to the depositor".
