MISCELLANEOUS LAND NOTICES.

Sale of Mining Lease for Plumbago-Hambantota.

THE Assistant Government Agent, Hambantota, will put up for sale by public auction the lease for a period of five years of the right to mine for plumbago in the Crown lots described in the schedule, at the Wiraketiya Village Tribunal on April 27, 1939, at 10 A.M., on the following conditions:

- (1) The leases shall be sold to the highest bidders provided that the sum offered shall at the least amount to the upset premium of one hundred rupees (Rs. 100) per acre.
- (2) The officer conducting the sale may, before accepting any bid at the sale, satisfy himself as to the bona fides of the bidder, and in the event of his not being satisfied may refuse to accept such bid and may continue the sale as if no such bid had been made.
- (3) The person declared to be the highest bidder shall immediately on such declaration pay to the Assistant Government Agent, Hambantota, a deposit of 10 per cent. of the purchase amount and also sign these conditions of sale. Should such person fail either to pay the said sum of money or to sign these conditions his bid shall stand cancelled, and the Assistant Government Agent, Hambantota, shall be at liberty to resell the lease in the same manner as in the original instance; provided that no bid shall be accepted from the defaulting purchaser.
