MISCELLANEOUS LAND NOTICES.**Sale of Mining Lease for Plumbago—Hambantota.**

THE Assistant Government Agent, Hambantota, will put up for sale by public auction the lease for a period of five years of the right to mine for plumbago in the Crown lots described in the schedule, at the Wiraketiya Village Tribunal on April 27, 1939, at 10 A.M., on the following conditions:—

- (1) The leases shall be sold to the highest bidders provided that the sum offered shall at the least amount to the upset premium of one hundred rupees (Rs. 100) per acre.
