REGULATION.

The regulations under sections 14, 15, 17 and 61 of the Ordinance, published in Notification No. 7 in *Gazette* No. 8,422 of December 23, 1938, are hereby amended as follows:—

- (1) in regulation 6 thereof by the substitution for the words "cut out, pollarded or lopped", of the words "felled, uprooted, abandoned or destroyed"; ;
- (2) by the substitution, for Form R.C. 10 thereunder, of the following Form:—

REGULATION.

The regulations under sections 18 and 61 of the Ordinance, published in Notification No. 8 in Gazette No. 8,422 of December 23, 1938, are hereby amended as follows :—

(1) in regulation 2—

- (i) by the re-numbering of the regulation as paragraph (1) of regulation 2 ;
- (ii) by the addition at the end of the re-numbered paragraph (1) of the following :—

“ (2) Nothing in paragraph (1) shall be deemed to require any information to be given concerning any matter in respect of which a return is required to be made under regulation 6 of the regulations published in Notification No. 7 ” ;

(2) in regulation 6, by the addition at the end thereof of the following :—

“ Provided, however, that no notice shall be required to be given under this regulation in any case where the amendment is made in consequence of any notification made under regulation 2.” ;

(3) in regulation 12, by the addition at the end thereof of the following :—

“ Provided, however, that no fee shall be payable under this regulation in any case where a person is registered as the proprietor of an estate or small holding upon the death of the previous registered proprietor.” ;

REGULATION under sections 23 and 61 of the Rubber Control Ordinance, No. 63 of 1938, made by the Executive Committee of Agriculture and Lands.

REGULATION.

The regulations under sections 23 and 61 of the Ordinance, published in Notification No. 11 in Gazette No. 8,422 of December 23, 1938, are hereby amended as follows:—

(1) in regulation 7 by the addition at the end thereof of the following new paragraph (3):—

“(3) Nothing in this regulation shall be deemed to require any plant to be serially numbered or to be described in a register kept for the purposes of paragraph (1), if the plant has not completed 5 years of age or if the girth measurement of the plant at a height of 3 feet from the ground is less than 18 inches.”;

(2) in regulation 8 by the addition at the end of paragraph (2) of the following:—

“(c) No fee shall be payable under this regulation in the case of any area, if there is on that area no budded rubber plant or plant grown from approved clonal seeds which has completed 5 years of age and has a girth measurement of 18 inches or over.”;

(3) in regulation 9 by the addition at the end thereof of the following new paragraph:—

“(5) In the case of any area planted with plants grown from approved clonal seeds the Controller shall not under this regulation make a special determination of the yield of that area at any time after the expiry of a period of two years from the date on which the amount of the yield of that area was first determined unless he is satisfied, after such investigation as he may consider necessary, that the actual amount of the yield of that area during a period of twelve consecutive months (including at least one month during which the plants have been rested), is greater than the yield last determined in respect of that area for any year of control.”

(4) in the Table of Fees set out in regulation 20, by the renumbering of items (1) to (10) as items (2) to (11), respectively, and by the insertion of the following new item (1):—

“ Provided that nothing in this regulation shall be deemed to prohibit the re-exportation at any time before July 1, 1939, of any rubber imported into Ceylon before January 1, 1939 ”.
