IT is hereby notified that the Public Service Regulalitions published in the Ceylon Government Gazette No. 7,865 of June 30, 1931, as amended by the Notification of November 9, 1936, appearing in the Ceylon Government Gazette No. 8,256 of November 13, 1936, have been amended by the deletion of Public Service Regulation 130m (v.) and the substitution therefor of the following regulation:—

(v.) A decision by the Head of a Department that an officer is not fit to pass an efficiency bar is final, and no appeal shall lie on the first occasion on which such an order is made. Should an officer whose pensionable emoluments exceed Rs. 1,500 per annum or whose non-pensionable emoluments exceeds Rs. 3,000 per annum be so adjudged for two successive years, the full facts of the case should be submitted to the Chief Secretary for the decision of the Governor. This is however not necessary in the case of officers who are prevented from being promoted over an Efficiency Bar by reason of the fact that they have failed to pass an examination prescribed by departmental or other regulation as a qualification for such promotion.

## GALLE' MUNICIPAL COUNCIL.

## General Meeting.

Thursday, July 13, 1939, at 2.30 p.m.

THE Council met this day at 2,30 P.M., pursuant to notice dated July 3, 1939.

Present.—M. W. Dahanayake, the Mayor, presiding; Messrs. A. I. H. A. Wahab, Deputy Mayor; J. E. Perera; F. Magdon Ismail, R. L. Ephaums, A. H. E. Fernando; E. de S. Wijeratne; D. S. Goonesekera; A. William Wijeratne; W. T. Wijekulaturiya; R. Kagahawatte; P. Dahanayake; A. M. Saheed; and T. W. Roberts.

1. The minutes of the first meeting of Council held on June 9, 1939, and of the General Meeting held on June 12,

- 1939, copies there having been furnished to each Member, were taken as read and confirmed.
- 2. Before proceeding with the business on the Agenda the Mayor announced that he wished, with the permission of Council, to bring up an important matter which he considered should not be further delayed. The two Audit Examiners, who were carrying on the usual inspection of the Municipal Office had brought to his notice, he said, that the accounts of the Health Department had been incorrect since January, 1938, and that investigations made by them showed that there were differences in figures in the ledger and in the registers. The Mayor added that in response to a request made by him Mr. P. W. Kaule, Chief Audit Examiner, had come to the Municipal Office and he (the Mayor) would like the Members to hear what Mr. Kaule had to say on the matter.

Mr. Kaule thereupon addressed the Council in Committee and pointed out that the present accounting system in the office was bad, that there had been no internal check on the Revenue Accounts, and that the position, therefore, was that the Council did not know whether all moneys due to it had been recovered. Mr. Kaule suggested that the Council should employ an experienced Accountant who would exercise a proper internal check on the accounts.

The Mayor then, with the permission of Council, took up item 12 on the Agenda which was as follows:—"To consider what steps should be taken to fill the vacant post of Accountant," and moved the Council into Committee to consider the matter. Mr. A. I. H. A. Wahab seconded.—Carried.

Council in Committee recommended, after discussion, (1) that applications for the post of Accountant be called for at once on a salary of Rs. 2400 per annum rising to Rs. 3,600 per annum by annual increments of Rs. 120; (2) that the selected candidate should be required to furnish security as follows:—Rs. 2,000 in cash, or Rs. 4,000 by hypothecation of property or through a Guarantee Association approved by the Council; (3) that the closing date for applications be July 25; (4) that the application be considered at an adjourned meeting of the Council on July 29; and (5) that the notice do specify that the selected candilate should be prepared to assume duties on August 1.

Council then resumed and the Mayor moved that the above recommendations of the Council in Committee be adopted. Mr. Wahab seconded.— "rried unanimously.

- 3. Pursuant to notice Mr. T. W. and the following questions which the Mayor answered:
- (1) Q.—(u) Have analyses been made of the water from private wells now used for drinking purposes in those wards where there is no pipe supply? (b) Is such water fit fcr human consumption? A.—(a) No. (b) In the absence of analyses I am unable to answer this question. But from observations made by me personally, I may say that such water is fit for human consumption.

-Have analyses been made of the water now sold in barrels about the town?

Are there records of similar analyses of the water from the old wells which were closed when pipe supply was introduced? and what was the verdict of those analyses on the fitness for use of the water from those wells?

No such records are available, nor do there appear to be any papers at all on the matter.

(4) Q.—Is there reason to keep meters in action further? or do the readings taken in the past year supply sufficient information about the quantities consumed? A.—A statement is tabled showing the consumption of water at six premises where the Council decided that meters should be fixed under Waterworks By-law No. 20 on the ground of excess consumption. This statement will show that in the case of three premises at least (marked X) the consumption per head per day is considerably more than what should reasonably be allowed. The question of retaining meters at these premises, and also at premises which have the water carriage system, will be considered by the Works Committee in due course.

(5) Q.—Do the present  $\frac{3}{2}$  inch meters clog the flow into I inch pipes and cause grave inconvenience to consumers? Will the Mayor, if the meters are not removed, substitute meters of calibre equal to the pipes in each house? A.— $\frac{3}{2}$  inch meters are considered to be quite capable of giving the required quantity of water provided no solids or floating matter obstruct the screen which is fixed on the upstream side of the meters. House service meters are usually of  $\frac{3}{2}$  inch or  $\frac{1}{2}$  inch size, and it is not considered necessary to have any larger size than  $\frac{1}{2}$  inch.

(6) Q.—Will the Mayor be so good as to increase the pressure at issue of water from Hiyare reservoir, since it is now nearly full, and relieve the suffering of those ratepayers who now get water upstairs only for  $\frac{1}{2}$  an hour per day. A.—The present level of the water in the Hiyare reservoir is 4 ft.  $\frac{1}{2}$  inch below spill. In view of this I do not consider that any increase of pressure would be justified just yet pending completion of the Madola Augmentation Scheme. Special any increase of pressure would be justified just yet pending completion of the Madola Augmentation Scheme. Special supplies are given for one and a half hours daily at different times of the day in order to meet the needs of the residents of the high level areas in the Fort, Kaluwella, and Magalle where the water does not rise sufficiently during the normal hours of supply owing to the excessive draw-off in other parts of the town.

(7) Q.—In regard to complaints of internal stenches from the drains (a) in Middle street west of the Bakery;

(b) in Lighthouse street between the premises at the corner and the premises of Surveyor Goonewardene, what steps, if any, have been taken to suppress these nuisances?

(8) Q.—In view of the discovery that there is no substance in the first theory that the latter stench arose from private drains, will the Mayor take effective steps to end the blockade at the junction of the drains between those premises with the street drain and to establish adequate daily flushing sufficient to prevent recurrence of these nuisances? A.—All the silt traps of the Fort drains are cleaned, disinfected and oiled at least once a week, and some of them are also treated daily with chloride of lime in view of the repeated complaints made by residents about foul odours. The cause of the trouble, I understand, is due to the bad state of the sewers from which foul odours emanate along the drains opening into them and thence on to private premises. The nuisance cannot be eliminated entirely until the sewers are put into order and syphon traps provided at the junction of every surface drain with the sewers. A scheme for rebuilding the Fort sewers is now being prepared by the Municipal Engineer and will be submitted to Council in due course.

(9) Q.—Where are the surplus funds of this Council deposited or invested? and at what rate of interest? A.—The surplus funds of the Council are placed in fixed deposit with the National Bank, Colombo, and the Mercantile Bank, Galle. The interest earned at present on these deposits is  $1\frac{3}{4}$  per cent. per annum.

(10) Q.—Will the Mayor sacretain whether this Council has power to reinvest them with a view to a higher rate of interest?  $\frac{1}{4}$  Section 74 of the Mayorian Council has power to reinvest them with a view to a higher rate A .- Section 74A of the Municipal Councils Ordinance authorises the Council to invest its funds in any one or more of the following securities and in no others:—(a) stock or other securities of the Government of Ceylon; (b) debentures issued by the Ceylon State Mortgage Bank; (c) any other securities guaranteed by the Covernment of Ceylon.

(11) Q.—Will the Mayor please investigate the possibility of a conversion loan or some other action designed to A.—This is provided for in reduce the rate of interest now paid by this Council on money borrowed by the Council?

section 218 of the Municipal Councils Ordinance, No. 6 of 1910.

(12) Q.—Would it not be practicable to convert the street sweepings into compost manure? and would that not be profitable to the Council than its present use? A.—This question was previously considered by the Council and be more profitable to the Council than its present use? the papers on the subject are tabled.

Mr. T. W. Roberts: With regard to the reply to question 6, will the Mayor state when he expects the Madola Augmentation Scheme to be completed? Mayor: At the end of August.

Mr. T. W. Roberts: With regard to the replies to questions 7 and 8, will the Mayor consider the question of providing syphon traps? Mayor: The matter will be submitted to the Sanitation Committee for consideration.

Mr. T. W. Roberts: With regard to the reply to question 9, will the Mayor see that the surplus funds of the Council are better invested? Mayor: Yes, I will place the matter before the Finance Committee.

Pursuant to notice Mr. D. S. Goonesekera asked the following questions which the Mayor answered:-

(1) Q.—(a) What is the annual expenditure on the conservancy service? (b) What is the annual income on it? (1) Q.—(a) What is the annual expenditure on the conservancy service? (b) What is the annual income of it? (c) What is the present scale of conservancy charged? (d) Will the Mayor please consider the possibility of doing away entirely with the conservancy fee as it causes untold hardship to the poor? A.—(a) The total expenditure for 1938 was Rs. 36,144.97. (b) The total income for 1938 was Rs. 37,662.13. (c) Premises assessed at Rs. 51 and under, 50 cents per bucket; Rs. 52 to Rs. 102, Re. 1 per bucket; Rs. 103 to Rs. 202, Re. 1.50 per bucket; Rs. 203 and over, Rs. 2 per bucket. (d) I agree with the member that the conservancy fees cause untold hardship to the poor. I have asked the M. O. H. to submit to me a scheme whereby relief may be granted to the poor. When that report is ready, I shall submit

M. O. H. to submit to me a scheme whereby relief may be granted to the poor. When that report is ready, I shall submit to the Finance Committee for consideration.

(2) Q.—(a) What parts of the town are now served by Municipal midwives and what parts are not? What parts are inadequately served? (b) To what parts should the service be extended in the opinion of the Medical Officer of Health? A.—The Council has sanctioned the appointment of six midwives for the town, but one of these posts has not yet been filled, and applications for it are now being considered. All parts of the town, with the exception of an area in Wards 6 and 7 comprising Hirimbure, Batagalwila, Madawalamulla, and Maitipe, are now served by the Municipal midwives. This area also will be served when the 6th midwife is appointed. For the present the midwives closest to the area have been instructed to answer calls. The M. O. H. is of opinion that the service already provided for is adequate for the present.

Arising out of the above replies the following supplementary question was asked by Mr. D. S. Goonesekera and replied to by the Mayor:—Is there any possibility of including the Conservancy fee in the assessment rate? Mayor: The Finance Committee will consider this matter.

- 5. Pursuant to notice Mr. P. Dahanayake presented two petitions protesting against the adoption of the eastern trace for the proposed new road through Bope.
- 6. Pursuant to notice Mr. W. William Wijeratne moved:—(1) That with a view to getting an increased number of electricity consumers, the S. E. D. be requested to submit a report on the lanes that are suitable for electricity extension. (As the mover began to speak on the motion in Sinhalese Mr. E. de S. Wijeratne asked for a ruling from the Chair as to whether it was in order for a Member to address the Council in Sinhalese when there was a by-law to the effect that all businsss shall be conducted in the English language. The Mayor ruled that in terms of section 15 (2) (b) of Ordinance No. 60 of 1935 any Member could address the Council in English, Sinhalese or Tamil.) Mr. T. W. Roberts seconded.— Carried unanimously.

(2) That an extent of five chains on the side outside Municipal limits from the edge of each limitary road be included within Municipal limits. Mr. D. S. Goonesekera seconded. Messrs. F. Magdon Ismail and E. de S. Wijeratne opposed the motion, the latter pointing out that the motion in its present form was obnoxious to the provisions of section 4 of Ordinance No. 60 of 1935. The Mayor explained that at present the Council did not appear to have the power to enlarge its limits. The Attorney-General had been consulted on the matter but his reply had not yet been received. The mover thereupon, with the permission of Council, withdrew the motion for the time being, on the understanding that he would bring it up again at a later date, if necessary.

(3) That public latrines be constructed at Pedurugewala Junction, Joolgaha Junction, and near the Minuwangoda level crossing. Mr. W. T. Wijekulasuriya seconded. On the suggestion of the Mayor it was resolved that the matter

be referred to the Sanitation Committee for consideration and report.

7. Pursuant to notice Mr. D. S. Goonesekera moved :-(1) That a scheme of model tenements be drawn up as early as possible, and submitted to Government with an appeal for a reasonable subsidy. Mr. A. I. H. A. Wahab seconded. Resolved that the matter be referred to the Works Committee for consideration.

(2) That the Works Committee be asked to report on the feasibility of converting the land in Bazaar Ward (3) now vested in the Council into a playground, or, in the alternative, of earmarking it for model tenements. Mr. W. T. Wijekulasuriya seconded. Mr. A. M. Saheed suggested that the Works and Finance Committee together should report on the matter. The mover and seconder agreed to the suggestion and the motion as amended was then put to the Meeting and carried.

(3) That the Works Committee be asked to report on the subject of the Council maintaining a number of wells in different parts of the town. Mr. A. I. H. A. Wahab seconded.—Carried by 11 votes to 3.

- (4) That steps be taken to expedite the putting up of a suitable Town Hall. Mr. A. I. H. A. Wahab seconded. Messrs. T. W. Roberts; F. Magdon Ismail; W. T. Wijekulasuriya; and E. de S. Wijeratne opposed the motion. Mr. P. Dahanayake supported it. The motion was then put to the Meeting and carried by 9 votes to 4.
- Pursuant to notice Mr. A. H. E. Fernando moved :--(1) That ten Revenue Inspectors be appointed to the ten Wards to replace the present system of tax collection with effect from October 1, 1939, and that in the selection of these Revenue Inspectors, preference be given to such assistants of the tax collector as have served over five years and are found competent. Mr. W. T. Wijekulasuriya seconded. The Mayor spoke in favour of the motion and appealed to the House to support it. Mr. D. S. Goonesekera opposed the motion. Mr. P. Dahanayake supported it. Mr. J. E. Perera moved as an amendment that the matter be referred to the Finance Committee for consideration. Mr. A. M. Saheed seconded. Messrs. F. Magdon Ismail, T. W. Roberts, and E. de S. Wijeratne supported the amendment. The amendment

was then put to the Meeting and carried by 8 votes to 6.

Mr. A. M. Saheed called for a division which resulted as follows:—For.—Messrs. J. E. Perera; F. Magdon Ismail; R. L. Ephraums; A. M. Saheed; T. W. Roberts; D. S. Goonesekera; E. D. Nagahawatte; and E. de S. Wijeratne.

and P. Dahanayake.

- (2) That the Works Committee do report on the feasibility of converting into roads (a) the lane from Dangedera School through Meddawatta and falling near Mahinda College playground to Elliott road; (b) the lane from Elliott road near the Attapattan Vihare passing through Madapatala and falling to Steele road near the Mosque. Mr. D. S. Goonesekera seconded.—Carried.
- (3) That public latrines be erected at the following important junctions:—Dangedera Junction; Beligaha Junction; Kahaduwewatta Junction; Kalegane Junction and Julgaha Junction. Mr. E. D. Nagahawatte seconded. Resolved that the matter be referred to the Sanitation Committee for consideration and report.
- 9. Pursuant to notice Mr. W. T. Wijekulasuriya moved :-(1) That, with a view to consider what steps should be taken to give relief to the unemployed, this Council do take immediate steps to prepare a register of unemployed persons residing within the Municipal limits of Galle. Mr. A. William Wijeratne seconded. (1) Carried; (2) Resolved that a supplemental vote of Rs. 50 be sanctioned for the purpose.

(2) That a public latrine be erected at Padawtota in Magalle on the southern side of the Moragoda-ela, which is an area thickly populated by the poor and is over half a mile from the nearest public latrine. Mr. J. E. Perera seconded.

Resolved that the matter be referred to the Sanitation Committee for consideration and report.

Considered tenders for the supply of Liquid Fuel for a period of one year commencing from August 1, 1939:-10. Mr. A. I. H. A. Wahab moved that the tender of Caltex Ceylon, Ltd., at 22 cents per gallon be accepted. Mr. F. Magdon Ismail seconded.

Mr. A. H. E. Fernando moved that the tender of the Standard Vacuum Oil Co., also at 22 cents per gallon, be accepted. Mr. D. S. Goonesekera seconded.

Mr. Wahab's motion was first put to the Meeting and declared lost, 5 voting for and 6 against. Three Members declined to vote.

A.—No. To the best of my recollection the only words I spoke in Sinhalese at the last meeting were by way of repeating a question asked in Sinhalese by Mr. R. L. Ephraums.
- 12. To consider the report of the Special Committee regarding the delegation of powers, duties, and functions under section 9 (1) of Ordinance No. 60 of 1935:—The Mayor moved that the report of the Special Committee be adopted. Mr. W. T. Wijekulasuriya seconded.—Carried.
- 13. With the permission of Council item 6 (3) on the supplemental Agenda was next taken up for consideration and Mr. D. S. Goonesekera moved: -That the resolution of Council dated May 26, 1939, whereby the confirmation of the appointment of Mr. A. V. Chinniah as Superintendent of the Electricity Department was deferred be rescinded and that he be confirmed in the post with effect from May 1, 1938, in view of the fact that he has performed his duties very satisfactorily throughout. Mr. A. H. E. Fernando seconded. With the permission of Council the mover deleted the words "with effect from May 1, 1938." The motion, as amended, was then put to the Meeting and carried unanimously.

Mr. J. E. Perera seconded. Resolved that the matter be referred to the Finance Committee for consideration and report.
- (2) It is the opinion of this Council that a Special Committee consisting of the Mayor, the Deputy Mayor, and the representatives of Wards 5, 6, and 7 in the Council be appointed to inquire at the spot and recommend what steps should be taken to prevent sea water rushing up the "Moragoda" ela and causing damage to the vegetable and paddy plantations in the low lying area of Wards 5, 6, and 7. The Mayor seconded, and Messrs. T. W. Roberts and A. I. H. A. Wahab supported the motion which was then put to the Meeting and carried by 13 votes to 1, Mr. P. Dahanayake being against as he was of opinion that the matter was not one for the Council but for the Government Irrigation Department.
- (3) This Council requests the Standing Committee on Works to report to Council on a scheme whereby the Granaries may be erected, on terms and conditions to be agreed upon, by a private party, at his expense, in accordance with all specifications and instructions given to him by the Council. Mr. A. I. H. A. Wahab seconded.—Carried.
- (4) This Council requests the Standing Committee on Works to report on the road between Maligaspe and Siyam-balagahawatta across Moragoda with a view to taking it over for maintenance by the Municipality. The Mayor seconded.—Carried.
- (5) In the opinion of this Council public latrines are very necessary at the following junctions:—Karapitiya Junction, Beligaha Junction: The Mayor seconded.—Resolved that the matter be referred to the Sanitation Committee for consideration and report.
- (6) This Council requests the Four Standing Committees to consider the question of the large expenditure incurred on the Conservancy service, and recommend a scheme of Contract or other means to reduce the expenditure. Mr. T. W. Roberts seconded. On the suggestion of Mr. Wahab it was agreed to substitute the words "Finance Committee" for the words "Four Standing Committees." The motion, as amended, was then put to the Meeting and carried.
- 16. Pursuant to notice Mr. P. Dahanayake moved:—(1) That this Council is of opinion that immediate steps should be taken to erect 3 latrines one opposite the Civil Hospital, Mahamodera, another at Pedurugewala Junction, and another at Kalegane Junction. Mr. W. T. Wijekulasuriya seconded.—Resolved that the matter be referred to the Sanitation Committee for consideration and report.
- (2) This Council is of opinion that as a first measure of relief to the poorer classes who are being forced to abandon their houses on closing orders being served, a scheme to build 50 model cottages in a ten acre block of land in Heenpendola area be drawn up and submitted to Government with an appeal for a suitable subsidy. The cottages finally to be the property of the occupants on their making regular payment of rent for a continuous period of 20 to 25 years, which amount should cover up the full value of the cottages and lands with  $2\frac{1}{2}$  per cent. added as interest. Mr. A. H. E. Fernando seconded. Mr. E. D. Nagahawatte suggested the substitution of the words "in a suitable area" for the words "in Heenpendola area." The mover and seconder agreed to the suggestion and the motion, as amended, was then put to the Meeting and carried.
- (3) This Council is of opinion that a scheme be drawn up to train six young men between the ages of 16 and 24 from the unemployed of the town of Galle in the Electricity Department with a view to employing them, if possible when suitable vacancies occur in the subordinate service of that Department. Mr. A. H. E. Fernando seconded. Messis. T. W. Roberts, A. M. Saheed, and F. Magdon Ismail opposed the motion. The motion was then put to the Meeting and declared lost, 6 voting for and 7 against.
- 17. The following motion which also stood in the name of Mr. P. Dahanayake was, with the permission of Council, deferred for the next Meeting:—"This Council is of opinion that the Galle Friend-in-Need Society be requested to include 4 members of this Council in their executive Committee—to be nominated at a later date—to look after Municipal interests, so long as this Council makes contributions for poor relief."
- 18. Pursuant to notice Mr. T. W. Roberts moved:—That the hours of lighting be reduced by one hour, i.e.,  $\frac{1}{2}$  hour in the morning and  $\frac{1}{2}$  hour in the evening. Mr. F. Magdon Ismail seconded.—Resolved that the matter be referred to the Finance Committee for consideration and report.
- 19. Pursuant to notice Mr. E. de S. Wijeratne moved:—(1) That a plan drawer be appointed on a monthly salary of Rs. 15 plus Rs. 2 per plan drawn, whose duty shall be to draw plans free of charge for needy ratepayers on the recommendation of the Ward Member. The Mayor seconded, and strongly supported the motion. Mr. F. Magdon Ismail opposed the motion. Messrs. T. W. Roberts, J. E. Perera, and P. Dahanayake also spoke. The mover replied. It was then resolved that the matter be referred to the Finance Committee for consideration and report.
- . (2) That public latrines be established in Dadalla Ward at or near the following six places:—(1) the Mahamodera Bridge; (2) the Segregation Camp; (3) the Dadalla Cemetery; (4) Colombo road-Bope Cross road Junction; (5) Piyadigama Bazaar; (6) Uduwata Beach. Mr. P. Dahanayake seconded.—Resolved that the matter be referred to the Sani-Otation Committee for consideration and report.
- (3) That the present road leading to the Maha Mudalinda Ramaya at Dadalla and the village beyond be taken over by the Galle Municipality and extended up to join the Bope Cross road at Piyadigama near the overhead bridge. Mr. T. W. Roberts seconded.—Resolved that the matter be referred to the Works Committee for consideration and report.
- (4) That immediate steps be taken to provide a playground for children in Dadalla Ward. The Mayor seconded.—Resolved that the matter be referred to the Works Committee for consideration and report.
- (5) That immediate steps be taken to remove the Infectious Diseases Hospital and the Segregation Camp at Dadalla to some area outside the town. The Mayor seconded.—Resolved that the matter be referred to the Works Committee for consideration and report.
- (6) That with the object of providing better houses for the poorer classes in this Ward and some other parts of the town a scheme to put up model tenements be forthwith devised. The Mayor seconded.—Resolved that the matter be referred to the Works Committee for consideration and report.
- (7) That six public bathing wells be established in Dadalla Ward for the convenience of the poor ratepayers of the Ward. Mr. A. I. H. A. Wahab seconded.—Resolved that the matter be referred to the Works Committee for consideration and report.
- and report.

  The Mayor stated that Mr. E. de S. Wijeratne would be invited to attend the meetings of the Standing Committees at which his motions would be discussed.
  - 20. The following extracts from the minutes of the Standing Committees were laid before the Council:—
    - (a) Extracts from the Minutes of the Standing Committee on Finance held on July 3, 1939.
  - (2) Lists of demolished buildings in Wards 2, 4, 6, 7, 8, and 9.—Recommended that the rates be struck off.
- (3) Considered the question of waiving the rates due on the following properties for 1938 and 1939 on the ground of poverty of the owners:—577a/70/2, Bope road; 48/2, Wekunagoda road; 13, Wekunagoda road; 206/1, Richmond Hill road; 8/399, Wackwella road; and 497, Hirimbure road.—Recommended that the rates due on the above properties for 1938 and 1939, amounting to Rs. 18·10, be waived on the ground of poverty of the owners.
- (4) To sanction a supplemental vote of Rs. 400 under Vote 48—Maintenance of bridges.—Recommended that for the present a supplemental vote of Rs. 200 only be sanctioned.
- (5) Considered an application for 20 days' leave from Midwife M. L. Rosa.—Recommended that she be granted 20 days' sick leave on full pay with effect from June 26, 1939.

- (6) Considered the question of fixing an age limit at which all daily paid employees of the Council should be required to retire from service.—Recommended by 4 votes to 2, Messrs. A. M. Saheed and D. S. Goonesekera dissenting, that no age limit be fixed in the case of daily paid employees and that the present practice do continue.
- (7) Considered whether any action should be taken as regards the non-Ceylonese labourers employed by the Council.—Recommended that no action be taken in the case of the 15 non-Ceylonese labourers already in service, but that in future no non-Ceylonese be employed by the Council either as permanent or substitute labourers.
- Mr. W. T. Wijekulasuriya dissented from the first part of this recommendation as he was of opinion that all non-Ceylonese labourers now in service should be discontinued.
- (9) Considered the question of appointing a delivery peon for the Electricity Department.—Recommended that, in order to save expenditure on postage, an office labourer, who shall also be the delivery peon of the Electricity Department, be appointed on the scale of salary attached to the post of office labourer, viz., Rs. 180—Rs. 6—Rs. 240, and on condition that he works throughout the year.
- (14) Considered the question of payment to Contractor A. R. A. Hassen for supplying 30 dozen Conservancy buckets of inferior quality.—(1) Resolved that the Contractor be paid at the rate of Re. 1·10 per bucket instead of at the accepted rate of Re. 1·20 in view of the fact that the buckets supplied by him are inferior in quality to the sample bucket sent by him when submitting his tender.—(2) Recommended to Council that his contract be cancelled as he has not complied with the terms thereof, and that fresh tenders be obtained for the supply of buckets for the rest of the year.
- (15) To sanction a supplemental vote of Rs. 275 for the provision of office rooms for the Mayor and Commissioner.—Recommended.

## Resolution.

With regard to item (7) it was resolved that consideration be deferred till the next Meeting.

The recommendations of the Standing Committee with regard to all the remaining items were adopted.

- (b) Extracts from the Minutes of the Standing Committee on Municipal Works held on July 4, 1939.
- (3) To approve the extra expenditure of a sum of Rs. 100 on item (8) of the Bill of Quantities in connection with the construction of a retaining wall along the Keppu-ela.—Recommended that the extra expenditure of Rs. 100 be approved.
- (6) Considered an estimate of Rs. 375 for improvements to the compound of the office of the Superintendent, Electricity Department.—Recommended that quotations be obtained for clearing and levelling the site only (items 1 and 2 of the estimate) and that a sum of Rs. 100 be voted for the purpose.
- (7) Considered whether, in the case of the contracts entered into for maintenance works during 1939, the necessary percentage deduction should be made even in the case of items which were not included in the Schedule of Rates on which tenders were called for.—Recommended that for all future maintenance works the necessary percentage deduction be made in the case of all items whether included in the Schedule or not.
- (9) Considered papers with regard to the proposed widening and duplication of the main Colombo-Matara road.—
  Recommended that the Honourable the Minister for Communications and Works be informed that the Council is prepared to contribute one-tenth of the total cost of constructing the proposed Marine Drive, provided that the contribution is spread over a period of 10 years in view of the present depleted state of the Council's finances.
- (10) Considered the question of keeping a register of approved Contractors.—Recommended that a register of approved Contractors be not maintained.
- (12) Considered what concession should be allowed in the case of new service connections to consumers of electricity.—Recommended that, with effect from August 1, 1939, a sum of Rs. 25 be deducted from the estimated cost of the service main in the case of overhead services and a sum of Rs. 85 in the case of underground services.—Recommended, further, that the connection fee of Rs. 5 charged hitherto in such cases be not recovered from August 1, 1939.
- (13) Considered the question of providing a rickshaw stand at the junction of Pedlar street and Rampart street.—Recommended that a stand for six rickshaws be provided at a cost of Rs. 35 and that the expenditure be charged to Vote 55—Works Contingencies.

## Resolution.

With regard to item (9) it was resolved that the recommendation of the Standing Committee be adopted with effect from July 14, 1939.

The recommendations of the Standing Committee with regard to all the remaining items were adopted.

21. To consider applications for the post of Accountant:—Mr. F. Magdon Ismail moved the Council into Committee to consider this item. The Mayor seconded.—Carried.

## Council in Committee-

Mr. Wahab moved that a Special Committee be appointed to consider the applications and to select certain names of for submission to the Council. Mr. R. L. Ephraums seconded.—Carried by 6 votes to 4.

(Mr. T. W. Roberts left the Meeting at this stage.)

Council in Committee then recommended—(1) that the Special Committee do consist of the Deputy Mayor (as Chairman) and Messrs. T. W. Roberts, A. M. Saheed, E. D. Nagahawatte, A. H. E. Fernando, W. T. Wijekulasuriya, E. de S. Wijeratne, and P. Dahanayake, and (2) that a Special General Meeting of the Council be held on August 10, 1939, to consider the recommendations of the Special Committee and to select a few candidates for interview at the next General Meeting on August 17, 1939.

Council then resumed and the Mayor moved that the above resolution and recommendations of the Council in Committee be adopted. Mr. Wahab seconded.—Carried.

- 22. To submit the reply received from the Commissioner of Local Government with regard to the application made to Government for a contribution of a moiety of the cost of carrying out the Madola Augmentation Scheme:—Submitted.
- 23. To submit the report of the Auditor-General for the year ending December 31, 1938.—Resolved that submission be deferred till the next meeting.
- 24. Pursuant to notice Mr. F. Magdon Ismail moved:—That a Committee of this Council be appointed to suggest as to what improvements should be effected to the Fort Ramparts and the outlying grounds thereof and a suitable spot therein for the construction of a playground. Mr. A. I. H. A. Wahab seconded. Messrs. P. Dahanayake and E. de S. Wijeratne opposed the motion. The Mayor and Messrs. J. E. Perera and D. S. Goonesekera supported the motion. The mover replied. The motion was then put to the Meeting and carried by 11 votes to 2.—Resolved that the Committee do consist of the Mayor and Messrs. T. W. Roberts, F. Magdon Ismail, D. S. Goonesekera, E. de S. Wijeratne and R. L. Ephraums.
- 25. Pursusant to notice Mr. A. William Wijeratne moved:—That all sign boards, notice boards, notices calling for tenders, quotations, applications, notices issued on questions of health and sanitation, &c., be in Sinhalese and also in Tamil whenever necessary, rather than in English. Mr. E. de S. Wijeratne seconded. Mr. W. T. Wijekulasuriya moved as an amendment that the following words be added to the motion:—"and that replies sent to communications be in the language in which the communications are written," but subsequently withdrew it on the Mayor pointing out that this would mean the appointment of additional staff. The motion was then put to the Meeting and carried, the voting being as follows:—For.—The Mayor and Messrs. J. E. Perera, F. Magdon Ismail, R. L. Ephraums, A. H. E. Fernando, E. de S. Wijeratne, D. S. Goonesekera, A. William Wijeratne, W. T. Wijekulasuriya, E. D. Nagahawatte, A. M. Saheed and A. I. H. A. Wahab.

Against.—None.

Declined to vote :- Mr. P. Dahanayake.

- 26. Pursuant to notice Mr. P. Dahanayake moved:—This Council is of opinion that immediate steps be taken to construct the Galketiya-Bope road, and the western tracing be adopted as it would open out the place and would be of greater advantage to people than the eastern tracing, which would serve the requirements of 5 families and, further, as there is every possibility of getting all the land necessary along the western tracing free of any cost to the Council. Mr. E. de S. Wijeratne seconded.—Resolved that the matter be referred to the Works Committee for consideration and report.
- 27. Pursuant to notice Mr. D. S. Goonesekera moved :—(1) That the commission paid for the collection of taxes be reduced by one per cent. with effect from August 1, 1939. Mr. F. Magdon Ismail seconded.—Resolved that the matter be referred to the Finance Committee for consideration and report.

(2) That the Council be pleased to allow a discount of one per cent. on all taxes paid to the office by rate-payers. Mr. F. Magdon Ismail seconded.—Resolved that the matter be referred to the Law Committee for consideration and

report.

Dahanayake, Mayor of Galle, hereby notify that, in virtue of the powers vested in me under section 203 of the Municipal Councils Ordinance (Chapter 193) and with the sanction of the Council conveyed by resolution dated August 17, 1935.
