The rules published by notification dated July 24, 1891, in Gazette No. 5,075 of July 31, 1891, as last amended by rule published by notification dated December 6, 1933, in Gazette No. 8,023 of December 15, 1933, are hereby further amended as follows:—

(1) in rule VII. thereof, by the substitution, for the words "annexed to these rules" of the words "annexed to these rules and signed by the Directing Manager on behalf of the Managers";

(2) in rule IX. thereof, by the substitution, for the words "period of five years", of the words "period not exceeding five years";

exceeding five years ";
(3) in rule XVII., by the substitution, for all the words from "The resignation" to "enforced withdrawal", of the following:—

"The resignation or dismissal of an Associate from his Public Office or the death of any Associate, or his voluntary or enforced withdrawal";

(4) by the substitution for rule XVIII., of the following new rule:—

"XVIII. Upon the voluntary or enforced withdrawal of an Associate from the Association he shall be entitled, on the production of a written certificate from the Deputy Financial Secretary that there is no claim against such Associate in respect of any breach of his bond, to be repaid the full amount of his loans with bonus additions if no losses have attached, or such portions of his loans and bonus additions as shall result to his credit after providing for all claims incurred during the connection of the past Associate with the Association, and towards which the share of such past Associate is liable to contribute; and the Managers in their discretion may withhold such repayments as long as may be necessary, to ascertain and determine the extent of the contributory obligation of the past Associate in respect of any such claims.

Where the guarantee of the Association has been given under rule VIII. with regard to an additional amount of security which an Associate is required to give and the Associate ceases to fill the office for which he was required to give the

additional amount of security the Managers may on the production by him of a written certificate from the Deputy Financial Secretary that there is no claim against such Associate on his bond providing for such additional security, refund to such Associate the amount then paid by him by way of loan for such additional security with bonus additions, if any, after deducting any sums due by way of contributory obligations from the share of the Associate as aforesaid.

In the event of the death of an Associate the Managers shall pay the amount standing to his credit after providing for all claims as aforesaid to the duly appointed executor or the administrator of his estate upon the production of a written certificate from the Deputy Financial Secretary that there is no claim in respect of any breach of the bond of the said deceased Associate. Where the Managers are satisfied that an Associate has died intestate and that no letters of administration are by any law for the time being in force required to be taken out for the due administration of his estate they may on the production of the said written certificate from the Deputy Financial Secretary pay the amount standing to the credit of the deceased as aforesaid to any person proved to their satisfaction to be an heir-at-law of the deceased Associate. Any payment made in accordance with this rule shall be and shall operate for all purposes as a complete discharge of the obligations of the Managers in respect of the repayment of loans paid by Associates under IX., but without prejudice to the right of any other heir of a deceased Associate to recover his share from the heir who has been paid any sum in accordance with the provisions of this rule "; and

(5) in the Form of Guarantee—(a) by the substitution for the words "Our Sovereign Lord" wherever those words occur in that form, of the words "His Majesty", and (b) by the substitution, for the word "Managers" occurring at the end of that form, of the following:—

## REGULATIONS FOR ADMISSION.

1. No student shall be admitted to the Intermediate Courses (including the Pre-Medical Course) of the Ceylon University College unless, either:—

(a) he passes an Entrance Examination to be held by the authorities of the University College, or

(b) produces a certificate from the Headmaster of an approved Secondary School in Ceylon that, after passing the London Matriculation Examination (or securing exemption from it) in January, 1939, or at an earlier date, he has successfully completed at least one year's post-Matriculation course at such School, and has satisfied the Headmaster that he is intellectually fitted to proceed to a full course at an institution of University status.

(For the purpose of this regulation, an approved Secondary School means any Secondary School which conducts post-Matriculation courses approved by the Director of Education.)

- 2. A student who is awarded a University College Entrance Scholarship or Exhibition or any free tuition Scholarship awarded on the results of the London Matriculation or the Cambridge Senior School Certificate Examinations may be deemed to have passed the Entrance Examination.
- 3. The Principal shall have the power to admit not more than 10 candidates over and above those selected on the results of the Entrance Examination and on production of a post-Matriculation certificate from a Head-master, provided that such candidates have reached a suitable standard in the Entrance Examination.
- A student who has passed the Intermediate Examination of the London University may be admitted to a Final Class without Examination. A student who has been "referred" in one subject in the Intermediate Examination and is due to take the Examination in the "referred" subject in July, 1940, may be admitted provisionally to a Final Class.
- The above regulations are in addition to, and not in substitution of, the existing regulations relating to admission to the University College.

## The Entrance Examination.

- 6. Date of Examination.—The Entrance Examination will begin on May 20, 1940, or on such other date as may be notified by the Principal.
- 7. Qualifications for Admission.—To be admitted to the Examination, every candidate must have :
  - (a) completed his 16th year on the 1st day of July, 1939, and
  - (b) passed the London Matriculation Examination or secured exemption from it.

A candidate for the Matriculation Examination in January, 1940, or the Cambridge Senior Examination in December, 1939, may be admitted to the Examination provisionally, but his application will be disallowed if he fails to pass the Matriculation Examination or to secure exemption therefrom.

- 8. Entry.—Application for entry to the Examination must be made in such form as the Principal may prescribe, and must reach the Registrar, University College, not later than April 13, 1940.
- 9. Examination Fee. Every candidate entering for the Examination must pay a fee of ten rupees into the Bank of Ceylon or at a Kachcheri to the credit of the Ceylon Government, and attach the receipt to his application. The fee is not returnable except in cases where candidates withdraw their application before May 15, 1940.
- 10. The Scheme of Examination.—Candidates will be examined in three subjects one to be selected from each of the following groups:—
  - (a) Candidates for the Intermediate Science Course:—
  - Group I.: Elementary Mathematics, Botany, Zoology.

Group II.: Physics, Chemistry.

- Group III. : Either Advanced Mathematics or Mechanics, Geography, and any subject in Groups I. and II. not already selected.
- (b) Candidates for the Intermediate Arts Course :—

Group I.: Latin, Pali, Sanskrit, Sinhalese, Tamil.

Groups II. and III.: English, Greek, Elementary Mathematics, either Advanced Mathematics or Mechanics, History, Geography, Elements of Economics, Logic, and any subject in Group I. not already selected.

Note.—Candidates who wish to read Latin or Mathematics must offer the subjects, candidates who wish to read Sanskrit, or Pali, must offer one of these subjects or Sinhalese or Tamil.

(c) Candidates for the Intermediate Science (Economics)

Group I.: Elementary Mathematics, Logic.

Group II. : Principles of Economics, Geography.

Group III.: History, English, Latin, Sinhalese, Tamil, and any subject in Groups I. and II. not already (d) Candidates for the Pre-Medical Course:-

Groups I. and II.: Physics, Chemistry, Botany, Zoology.
Group III.: English, Latin, Sinhalese, Tamil, History,
Geography, Elementary Mathematics, and any
subject in Groups I. and II. not already selected.

The Principal may for sufficient reason relax any of the requirements laid down in this regulation.

11. The syllabus in each subject will be published in due course in the Government Gazette. The standard of the question papers will be slightly higher than that of the papers set for the London Matriculation Examination.

- 7. (i.) A deposit of Rs. 50 will be required to be made either at the Office of the Conservator of Forests, Colombo, or at a Kachcheri, and a receipt produced for same before any form of tender is issued.
- (ii.) If a person to whom a tender form has been issued fails for no satisfactory reasons to submit his tender within the time fixed in condition 4 above his tender form deposit of Rs. 50 will be liable to be forfeited at the discretion of the Conservator of Forests.
- (iii.) The successful tenderer shall within ten days of receipt of notice in writing that his tender has been accepted, enter into necessary contract after depositing Rs. 1,000 as security for the due and punctual performance of the contract. He shall also supply at his own cost a stamp of the value of Rs. 10 to be affixed to the original of the contract. Should he fail to comply with these requirements his tender form deposit may be forfeited to the Crown; he may render himself liable to be included in the list of defaulting contractors precluded from having any concern in a Government contract in future and to make good any resultant loss; further the service may be offered to another tenderer in which case no claim for any profit that may accrue to Government by such offer will be entertained.

Notice of acceptance will be deemed to have been received by the tenderer if it has been sent by post addressed to, or left at, the address given by the tenderer. All other tender form deposits will be returned upon signature of a contract.

- 8. A tenderer shall, before making his tender, preferably at the time of obtaining a tender form, examine in the office, at which he obtains his tender form, a copy of the agreement he will be required to execute in the event of his tender being accepted and shall sign and deliver a statement to the effect that he has fully acquainted himself with the terms of such agreement and that in the event of his tender being accepted he will, within the time fixed in condition 7 above execute an agreement in terms of the specimen agreement. As evidence of his having examined the specimen agreement the tenderer shall sign his name on it in the space provided for the purpose.
- 9. A tenderer who has not previously held a Government contract, when applying for tender forms, should furnish the officer issuing the forms with a written statement giving his full name and permanent address, stating in which district or districts he owns landed property or other interests. The extent of the landed property, and the nature and extent of other interests should also be given.

A tenderer who has carried out contracts with the Department, but not in the Dry Zone Division of this Department should state in which Division or District or Divisions or Districts he has held contracts. A tenderer who has carried out Government contracts with any other Department should state the name of such Department and the District in which the service was rendered.

No tender form will be issued to any person or on behalf of any person whose name appears on the list of defaulting contractors.

- 10. A rate per cubic yard of firewood delivered to the Railway in accordance with the conditions of the annexed schedule must be quoted written both in words and figures.
- 11. Tenderers before tendering should inspect the area of operations. A sketch of which can be seen in the Office of the Conservator of Forests or in any of the Divisional Forest Offices at Kurunegala, Jaffna, and Nuwara Eliya and no representation as to yield, &c., will be entertained after a tender has been accepted.
- 12. No tender will be considered unless the conditions laid down above have been stictly complied with.
- 13. The Government reserves to itself the right, without question, of rejecting any or all tenders, and the right of accepting any portion of a tender. No offers will be entertained from persons whose names appear on the list of defaulting contractors.
- 14. The contract shall be entered into by the successful tenderer with the Divisional Forest Officer, Dry Zone Division, Jaffna, acting for and on behalf of His Majesty the King, and the designation of such officer shall mean and include the officer for the time being holding such office and his successors in office for the time being under the Government of Ceylon.

- 15. The contract may not be assigned or sublet without the authority of the Tender Board. The Government reserves to itself the right to refuse to recognise a power of attorney issued by a contractor to any person authorising him to carry on the contract on the contractor's behalf.
- 16. The successful tenderer will except as stated below be required to employ only Ceylonese labour in carrying out the work tendered for and shall not employ any person whose name is on the list of defaulting contractors. If for any reason the tenderer is unable to employ only Ceylonese labour for the work, he shall state in his tender the maximum percentage of non-Ceylonese labour which he proposes to employ on the work. The Tender Board will give preference other things being equal, to the tenderer who undertakes to employ only Ceylonese labour and failing that to the tenderer who specifies the lowest percentage of non-Ceylonese labour which he proposes to employ for the work which appears to the Tender Board to be unnecessarily high.

The employment of Ceylonese labour only to carry out the work tendered for or the employment of a definite percentage only of non-Ceylonese labour for such work will be made a condition of the contract, and the failure on the part of the successful tenderer to fulfil this condition will be treated as a breach of the terms of the contract and will render the contractor liable to have the contract cancelled, and in addition to pay a penalty of Re. 1 50 a day for each non-Ceylonese labourer employed by him on work or for each non-Ceylonese labourer employed by him over and above the percentage of non-Ceylonese labour which he is permitted to employ on the work in terms of his contract. The word "Ceylonese" shall mean and include all persons born in Ceylon and no others.

The Divisional Forest Officer may, for reasons which appear to him sufficient, give notice in writing of his objection to the employment by the contractor of any person specified in the notice, and no such person shall be employed by the contractor.

- 17. The contractor shall indemnify the Crown against any claim by or in respect of any employee of the contractor under the Workmen's Compensation Ordinance, No. 19 of 1934.
- 18. The payments to which the contractor may render himself liable under this contract may be deducted by the Divisional Forest Officer concerned from all moneys then due or that may become due to the contractor under this or any other contract he may hold under Government and/or from the security deposited by the contractor and hypothecated to the Crown under condition 7 (iii.) above or be recovered from him by action at law.
- 19. The Conservator of Forests reserves to himself the right, without question, of ejecting the contractor's employees and of rescinding the contract if the above conditions are not adhered to.
- 20. In case of any disagreement arising between parties to the contract it shall be referred to the Tender Board whose decision in every case shall be final and binding on the parties to the contract.

## Schedule.

- 1. To fell, transport, and deliver neatly stacked not further than 30 ft. from the nearest rail at the Polonnariwal Railway Station Yard or at approved points on the railway line close by to the area of exploitation suitable to the Railway Department at an average of 5,000 cubic yards more or less per month from the bed of the proposed Sea of Parakrama. A sketch of the area of exploitation can be seen at the Office of the Conservator of Forests or at any of the Divisional Offices at Jaffna, Kurunegala and Nuwara Eliya. The following conditions shall be complied with in carrying out the work:—
- (a) The first delivery of 5,000 cubic yards shall be made not later than November 30, 1939. Final delivery shall be made on or before March 15, 1941. No felling operations shall be carried out after February 28, 1941. The distance of transport is from about 4 (minimum) to 7 (maximum) miles by gravelled road from Angamedilla to Topawewa and thence by metalled road to Polonnaruwa Railway Station.

- (b) All trees shall be felled except trees which emit milky exudation such as ficus species, Kaduru, Lunumidella, Rukkattana, Kapu, Kottan, Erabadu, Dadap, Ethdemata, Kekuna, Amba, Gedumba, Walkaduru, Imbul, Del, and Pulun.
- (c) The contractor shall not exploit any area selected by the Construction Engineer in charge, as not to be felled. The contractor shall consult the Construction Engineer, Irrigation Department, in regard to such areas before he starts felling.
- (d) All felled trees or other fallen trees shall be cut and split into firewood of billets of 3 ft. in length and not less than 2 in. or more than 9 in. in diameter.
- (e) Firewood shall be stacked in the railway yard or on the approved railway line side in rows convenient for loading the firewood into railway trucks. To economize ground space and to allow space between the stacks for inspection, stacks shall be either 3 ft.,  $4\frac{1}{2}$  ft. or 6 ft. in height as the Forest Officer in charge may direct from time to time. Walking space should be left between any two stacks.
- (f) The contractor shall be responsible for the safety of the firewood either in the forests or in transit or on the railway line side until taken over by the Railway Department.
- (g) The contractor may be required to increase or decrease the output of firewood at the instance of the Railway Department.
- (h) A penalty of a sum not exceeding 25 cents for every cubic yard of firewood not stacked or delivered at the monthly rate stipulated will be exacted from the contractor at the discretion of the Divisional Forest Officer, Jaffna.
- (i) The contractor is to be paid monthly at the convenience of the Railway Department for firewood, supplied as above and accepted, at the tendered rate per cubic yard on production of formal receipts signed by a responsible officer of the Railway Department, deductions being made for any fine or penalty imposed under this contract. Rejected material will not be paid for but will lapse to Government. In the event of a dispute arising owing to deduction for bad stacking, &c., the wood is liable to be restacked by the contractor and the measurement made after such restacks shall be considered as final for purposes of payment. "Method and device for mechanically removing the stalks or stems from dry factory tea during the sorting thereof."

Abstract.—The inventor states that the stems in manufactured tea have to be removed by hand, before the product is screened and separated into grades for the market. The picking of stems by hand is an expensive process, and the present invention is designed to overcome this defect by removing the stems mechanically.

According to the invention, instead of cutting manufactured tea (which causes cutting of stems also), the tea is cautiously crushed between a roller and a supported canvas belt. The linear velocity of belt must be equal to the circumferential velocity of the roller, so that only crushing takes place. This operation breaks down the tea but leaves the stems intact. By repeated crushings and screenings finally a product which is mostly composed of stems is left.


