Rule 17 of the rules prescribed under Article 39 (2) of the Ceylon (State Council) Order in Council, 1931, and published in *Gazette* No. 7,858 of June 5, 1931, is hereby amended in Columns II. and III. thereof, by the addition, to the respective items relating to the Chief Secretary, of the item set out hereunder:—

IT is hereby notified that the Public Service Regulations published in the *Ceylon Government Gazette* No. 7,865 of June 30, 1931, as amended by Notifications dated April 26, 1932, May 6, 1932, and February 25, 1936, are further amended by the deletion of Public Service Regulations 145 to 154 and the substitution thereof of the following regulations:—

145. No Public Officer is allowed to take part directly or indirectly, in the management of any commercial undertaking, notwithstanding that he may have invested money in such undertaking.

ACQUISITION OF LAND.

146. Non-Ceylonese Officers.—(i.) A non-Ceylonese Public Officer may not acquire or be a part owner of any land in the Island other than a garden or ground attached to his dwelling house, and not cultivated with a view to the sale of produce. He may not acquire or be a part owner in any concession in the Island, nor be the owner of house property other than a house for his own occupation. This regulation applies to every acquisition of land by way of purchase by or gift to a non-Ceylonese Public Officer whether in his own name or in that of any other person, including the members of his family, and also to every such acquisition made by his wife as her own separate property.

(ii.) This regulation does not apply to acquisitions by inheritance, dowry or devise; but such acquisitions must be reported to the Chief Secretary, who will make such order as may in his opinion be necessary.

147. Ceylonese Officers.—Ceylonese officers are permitted to acquire and to hold land and leases of land, in accordance with the following procedure* :—

(i.) Acquisitions by gift or purchase require the sanction of the Chief Secretary which must be obtained before the acquisition takes place. Applications to acquire land or leases of land should be made in duplicate on Form General 134 and forwarded to the Chief Secretary without a covering letter through the Government Agent of the Province or the Assistant Government Agent of the District in which the land is situated.

(ii.) Acquisitions by inheritance, dowry or devise do not require the prior sanction of the Chief Secretary, but they must be reported to the Chief Secretary, who will make such order as may seem to him necessary. Acquisitions must be completed before marriage or within such period as the Chief Secretary may prescribe if they are to be accepted as acquisitions by dowry.

(iii.) The preceding sub-sections of this regulation apply to acquisitions by a Ceylonese Public Officer whether in his own name or that of any other person,

*This procedure does not apply to daily-paid employees and unpaid or minor headmen.

including the members of his family; and also to acquisitions made by or on behalf of his wife as her own separate property.

(iv.) Sub-sections (i.) and (ii.) apply to acquisitions made by or on behalf of a female Public Officer. They do not apply to acquisitions made by the husband of a female Public Officer (who is not himself a Public Officer).

148. (i.) If in the opinion of the Governor any acquisition or holding by or on behalf of any Public Officer is improper, he may order that the Officer shall divest himself of interest to such extent as the Governor thinks fit.

(ii.) An acquisition or holding is improper if it might bring an officer's private interests into real or apparent conflict with his public duties, or in any way influence him in the discharge of his duties.

INVESTMENTS.

149. A Public Officer shall not directly or indirectly acquire investments or interests which might bring his private affairs into real or apparent conflict with his public duties or in any way influence him in the discharge of those duties. If in the opinion of the Governor or any investment or interest acquired by or on behalf of a public officer is improper he may order that the officer shall divest himself of such investment or interest in whole or in part.

150. A Public Officer should consult the Chief Secretary confidentially as regards any investment or interest the propriety of acquiring which may be reasonably open to doubt.

151. (i.) Public Officers are permitted to purchase shares in local companies subject to the provision of Public Service Regulation 149.

(ii.) All investments made by or on behalf of Public Officers or their wives must be reported to the Chief Secretary.

(iii.) This regulation applies to investments made by or on behalf of a female Public Officer. It does not apply to investments made by the husband of a female Public Officer (who is not himself a Public Officer).

152. Public Officers are not debarred from becoming members of Co-operative Societies registered under The Co-operative Societies Ordinance (Chapter 107, Volume III., page 288).

MORTGAGES.

153. (i.) Public Officers may make local investments in mortgages but the previous sanction of the Chief Secretary should be sought in each case before such investments are made by a Public Officer or by his wife.

(ii.) This regulation applies to investments in mortgages made by or on behalf of a female Public Officer. It does not apply to investments in mortgages made by the husband of a female Public Officer (who is not himself a Public Officer).

Scheme for the Improvement of Village Irrigation Works.

SCHEME in accordance with the provisions of Chapter VI. of the Irrigation Ordinance (Cap. 312), approved under section 8 (1) (b) at a meeting duly held on May 30, 1939, by the prescribed majority of the proprietors within the irrigable area of the Mavilpitiya amuna irrigation work in the Kandy District, and sanctioned by the Governor by virtue of the powers vested in him by section 41 of the aforesaid Ordinance, and by Article 93 of the Ceylon (State Council) Order in Council, 1931.

1. Name and description of work: Improvements to Mavilpitiya amuna, Gampaha korale west, Udadumbara, Kandy District, Central Province.

2. Extent and nature of lands irrigable under the scheme:—

3. Terms agreed upon—

(1) The construction of the following items of the necessary work, namely, (a) a permanent amuna with silt scour reach, retaining wall, and head sluice, (b) a spillway at the kandura crossing at chainage 4.25 on the ela, (c) general improvements to the ela up to the estimated cost of Rs. 1,700 is undertaken by the Government.

(2) In consideration of the aforesaid undertaking on the part of the Government, the proprietors on their part undertake to complete the following items of work free of all charges, namely, 50 cubes of earthwork in strengthening bund of channel.

(3) The proprietors further agree to repay to the Government a sum of Rs. 222 in full settlement of the cost, incurred by the Government in the construction of the items of work aforesaid, by a construction rate of Re. 1.20 per acre per annum for a period of five years from the date of completion of the irrigation work or until the said sum has been fully repaid.

(4) The proprietors further agree to contribute, after the completion of the work, all labour required for its maintenance and repair, free of all charges.

(5) The proprietors further agree that in the event of any default on the part of any of them in contributing any uncommutable labour due under this scheme, the Government Agent may cause such labour to be performed by any other person and recover the cost thereof in the manner prescribed in Chapter VIII. of the Ordinance.

REGULATION made by the Executive Committee of Agriculture and Lands under Section 9 of the Contagious Diseases (Animals) Ordinance (Chapter 327).

REGULATION.

The Contagious Diseases (Animals) Regulations 1937, published in *Gazette* No. 8,338 of December 17, 1937, are hereby amended in part III. thereof—(1) by the substitution for regulation 28, set out under the heading "C—Sheep, Goats and Swine," of the following new regulation:—

"28. Application for a licence to land any sheep or goats imported for the purpose of slaughter shall be made in Colombo to the Veterinary Surgeon of the Colombo

Municipal Council and in any other place to the Government Agent or the Assistant Government Agent; and every licence which the Minister may decide to issue will be forwarded to the applicant through the officer to whom the application was made."

(2) by the substitution for regulations 31, 32, 33 and 34 under the aforesaid heading of the following new regulations:—

"31. The Minister may upon application in that behalf made through the Government Veterinary Surgeon issue a special licence authorizing the landing of any number of sheep or goats imported from Asiatic or African ports for the purpose of breeding stock, and such number may in his discretion be in addition to the number of sheep and goats permitted to be landed for the purpose of slaughter.

32. (1) Every person desiring to land at the Port of Colombo any sheep, goats or swine imported for breeding purposes from any port or place outside Asia or Africa shall immediately inform the Collector of Customs of the arrival of the animals and shall furnish to him a certificate issued by a qualified Veterinary Surgeon at the port of shipment describing the animals and certifying that they have been examined and found free from any infectious or contagious disease before shipment.

(2) The provision of regulation 25 (1) to (3) shall apply *mutatis mutandis* to the inspection, the landing at the Port of Colombo, and the removal therefrom, of sheep, goats or swine imported from any port or place outside Asia or Africa.

(3) The importer of any sheep, goats or swine shall pay to the Government Veterinary Officer a fee calculated at the rates set out hereunder for the inspection of such animals under the provisions of paragraph (2):

Provided that the fee payable by any one importer in respect of any one shipment of sheep, goats, or swine shall not exceed twenty rupees.

(4) No swine imported from any port or place in Asia or Africa shall be permitted to be landed at the Port of Colombo.

33. (1) All sheep and goats imported from any port or place in Asia or Africa for the purpose of slaughter and landed at the Port of Colombo shall within twelve hours of being landed be removed to the Municipal Quarantine Station. Provided, however, that any such animal which is intended for slaughter within the Municipal limits of Colombo may be removed direct to the Municipal Slaughter house at Colombo.

(2) All sheep and goats imported from any port or place in Asia or Africa for the purpose of slaughter and landed at the Port of Colombo, shall be removed from the Municipal Quarantine Station to the Municipal Slaughter-house at Colombo and shall be slaughtered forthwith at that Slaughter-house.

(3) No person shall at the Port of Colombo land or cause or permit the landing of any sheep, goats or swine imported for the purpose of slaughter from any port or place outside Asia or Africa unless written permission for such landing has been granted by the Municipal Veterinary Surgeon, Colombo.

(4) In any case where the Municipal Veterinary Surgeon after the inspection of any sheep, goat, or swine referred to in paragraph (3), is of opinion that it should be placed under observation, he may, in granting the permission required by that paragraph, prescribe conditions as to the place at which and the manner in which it shall be kept; and the person to whom such permission is granted shall keep the sheep, goat or swine in accordance with such conditions until such time as the Municipal Veterinary Surgeon authorizes its removal from such place.

(5) No person shall remove or cause the removal, from the Customs premises, of any sheep, goat or swine landed under paragraph (3) except under the authority of a pass issued by the Collector of Customs. The Collector shall issue such pass upon the production of the Municipal Veterinary Surgeon's written permission referred to in paragraph (3).

34. The provisions of regulation 23 shall apply *mutatis mutandis* to the landing of sheep and goats imported at the Port of Colombo from any port or place in Asia or Africa, for any purpose other than that of slaughter."

REGULATION.

The Ceylon Quarantine Regulations made under sections 4 and 5 (now sections 2 and 3), of the Quarantine and Prevention of Diseases Ordinance (Chapter 173), and published in *Gazette* No. 8,029 of January 26, 1934, as last amended by regulation published in *Gazette* No. 8,445 of April 13, 1939, are hereby further amended in regulation 53 as follows:—

- (1) by the substitution in paragraph (1) for the words "every quarter" of the words "every quarter, and at intervals not exceeding three months";
- (2) by the substitution in paragraph (5) for the word "hoses" of the words "hoses, their covers, pumping machines, the boats on which they are mounted";
- (3) by the addition to that regulation of the following new paragraphs:—

"(7) (a) shall take all such steps as may be necessary to ensure that no person is employed, or re-employed after an absence from work for any period exceeding fourteen days, in any capacity in a water boat until he has been examined by a medical officer and certified in writing not to be a carrier of typhoid, paratyphoid or dysentery germs; and shall cause all person so employed in a water boat to be so examined and certified in the month of March in each year; and

(b) shall furnish the Port Health Officer in the month of February in each year with a list of all persons then employed by him in the water boat;

(8) (a) shall cause every canvas hose to be disinfected with steam once at least in every fortnight, and shall obtain from the Supervisor,

Disinfecting Station, a certificate (which shall be given free of charge) that this has been properly done;

(b) shall provide every hose (except a hose of which the opening is closed by folding and lashing when it is not in use, and which is used for delivery of water to ships) with a well fitting metal screw-cap of approved pattern, and shall take all such measures as may be necessary to ensure that the cap is securely screwed on whenever the hose is not actually in use;

(c) shall take all such steps as may be necessary to ensure that any hose fitted to the hydrant at the water meter is not disconnected except for repairs; and when such hose is not in use, shall cause its screw-cap to be fitted on and the hose to be draped round the rail on the hydrant;

(d) shall take all such steps as may be necessary to ensure that the unprotected ends of a hose do not come into contact with the decks of water-boats, or the pontoon on which the pumping machine is carried, or with any other possible source of pollution; and

(9) shall maintain in a clean and good condition the pontoons in which pumping machines are carried; and shall take all such steps as may be necessary to prevent persons from washing, cooking or sleeping on such pontoons; and

- (4) by the omission of the word "and" appearing at the end of paragraph (5) thereof.

AIR NAVIGATION

THE CARRIAGE BY AIR (PARTIES TO CONVENTION) ORDER, 1939.

At the Court at Buckingham Palace, the 3rd day of July, 1939.

PRESENT,

The King's Most Excellent Majesty in Council.

Whereas a Convention for the unification of certain rules relating to international carriage by air was on the twelfth day of October, nineteen hundred and twenty-nine, signed at Warsaw on behalf of His Majesty:

And whereas provision is made by the Carriage by Air Act, 1932 (a), for giving effect to the said Convention:

And whereas by subsection (2) of section one of the said Act His Majesty may by Order in Council from time to time certify who are the High Contracting Parties to the said Convention, in respect of what territories they are respectively parties and to what extent they have availed themselves of the provisions of the Additional Protocol to the said Convention:

And whereas since the date of the Carriage by Air (Parties to Convention) (No. 3) Order, 1938 (b), the accession to the said Convention by His Majesty in respect of Newfoundland has been duly notified, and it is therefore, expedient that the said Order should be superseded by a more comprehensive Order:

Now, therefore, His Majesty is pleased, by and with the advice of His Privy Council to order, and it is hereby ordered, as follows :—

1. It is hereby certified that the High Contracting Parties to the said Convention and the territories in respect of which they are respectively parties are as specified in Part I of the Schedule to this Order, and that the only High Contracting Party who has availed himself of the provisions of the Additional Protocol to the said Convention is the High Contracting Party specified in Part II of the said Schedule, who has availed himself of those provisions to the extent specified in the said Part.

2. The Carriage by Air (Parties to Convention) (No. 3) Order, 1938, is hereby revoked.

3. This Order may be cited as the Carriage by Air (Parties to Convention) Order, 1939.

5. Tenders are to be made upon forms which will be supplied upon application at the Office of the Conservator of Forests, Colombo, or at any of the Divisional Forest Offices in Jaffna, Kurunegala, and Nuwara Eliya. No tender will be considered unless it is on the recognized form.

6. All alterations and erasures in tenders must be initialled by the tenderers.

7. (i.) A deposit of Rs. 20 will be required to be made either at the Office of the Conservator of Forests, Colombo, or at a Kacheheri, and a receipt produced for same before any form of tender is issued.

(ii.) If a person to whom a tender form has been issued fails for no satisfactory reasons to submit his tender within

the time fixed in condition 4 above his tender form deposit of Rs. 20 will be liable to be forfeited at the discretion of the Conservator of Forests.

(iii.) The successful tenderer shall within ten days of receipt of notice in writing that his tender has been accepted, enter into necessary contract after depositing Rs. 500 as security for the due and punctual performance of the contract. He shall also supply at his own cost a stamp of the value of Rs. 10 to be fixed to the original of the contract. Should he fail to comply with these requirements his tender form deposit may be forfeited to the Crown; he may render himself liable to be included in the list of defaulting contractors precluded from having any concern in a Government contract in future and to make good any resultant loss; further the service may be offered to another tenderer in which case no claim for any profit that may accrue to Government by such offer will be entertained.

Notice of acceptance will be deemed to have been received by the tenderer if it has been sent by post addressed to, or left at, the address given by the tenderer. All other tender form deposits will be returned upon signature of a contract.

8. A tenderer shall, before making his tender, preferably at the time of obtaining a tender form, examine in the office, at which he obtains his tender form, a copy of the agreement he will be required to execute in the event of his tender being accepted and shall sign and deliver a statement to the effect that he has fully acquainted himself with the terms of such agreement and that in the event of his tender being accepted he will, within the time fixed in condition 7 above execute an agreement in terms of the specimen agreement. As evidence of his having examined the specimen agreement the tenderer shall sign his name on it in the space provided for the purpose.

9. A tenderer who has not previously held a Government contract, when applying for tender forms, should furnish the officer issuing the forms with a written statement giving his full name and permanent address, stating in which district or districts he owns landed property or other interests. The extent of the landed property, and the nature and extent of other interests should also be given.

A tenderer who has carried out contracts with the Department, but not in the Dry Zone or North-Western Division of this Department should state in which Division or District or Divisions or Districts he has held contracts. A tenderer who has carried out Government contracts with any other Department should state the name of such Department and the District in which the service was rendered.

No tender form will be issued to any person or on behalf of any person whose name appears on the list of defaulting contractors.

10. Rates per cubic yard of firewood delivered to the Railway in accordance with condition (a) of the special conditions must be quoted written both in words and figures.

11. Tenderers before tendering should inspect the areas of operations for which they tender. Sketches of the areas can be seen in the Office of the Conservator of Forest or in any of the Divisional Forest Offices at Kurunegala, Jaffna and Nuwara Eliya. No representation as to yield, &c., will be entertained after a tender has been accepted.

12. No tender will be considered unless the conditions laid down above have been strictly complied with.

13. The Government reserves to itself the right, without question, of rejecting any or all tenders, and the right of accepting any portion of a tender. No offers will be entertained from persons whose names appear on the list of defaulting contractors.

14. The contract shall be entered into by the successful tenderer with the Divisional Forest Officer, Dry Zone Division, Jaffna, or the Divisional Forest Officer, North-Western Division, Kurunegala, as the case may be, acting for and on behalf of His Majesty the King, and the designation of such officer shall mean and include the officer for the time being holding such office and his successors in office for the time being under the Government of Ceylon.

15. The contract may not be assigned or sublet without the authority of the Tender Board. The Government reserves to itself the right to refuse to recognize a power of attorney issued by a contractor to any person authorizing him to carry on the contract on the contractor's behalf.

16. The contractor shall not employ any person whose name appears on the list of defaulting contractors.

17. The successful tenderer will except as stated below be required to employ only Ceylonese labour in carrying out the work tendered for. If for any reason the tenderer is unable to employ only Ceylonese labour for the work, he shall state in his tender the maximum percentage of non-Ceylonese labour which he proposes to employ on the work. The Tender Board will give preference other things being equal, to the tenderer who undertakes to employ only Ceylonese labour and failing that to the tenderer who specifies the lowest percentage of non-Ceylonese labour which he proposes to employ for the work which appears to the Tender Board to be unnecessarily high.

The employment of Ceylonese labour only to carry out the work tendered for or the employment of a definite percentage only of non-Ceylonese labour for such work will be made a condition of the contract, and the failure on the part of the successful tenderer to fulfil this condition will be treated as a breach of the terms of the contract and will render the contractor liable to have the contract cancelled, and in addition to pay a penalty of Re. 1-50 a day for each non-Ceylonese labourer employed by him on work or for each non-Ceylonese labourer employed by him over and above the percentage of non-Ceylonese labour which he is permitted to employ on the work in terms of his contract. The word "Ceylonese" shall mean and include all persons born in Ceylon and no others.

The Divisional Forest Officer may, for reasons which appear to him sufficient, give notice in writing of his objection to the employment by the contractor of any person specified in the notice, and no such persons shall be employed by the contractor.

18. The contractor shall indemnify the Crown against any claim by or in respect of any employee of the contractor under the Workmen's Compensation Ordinance, No. 19 of 1934.

19. The payments to which the contractor may render himself liable under this contract may be deducted by the Divisional Forest Officer concerned from all moneys then due or that may become due to the contractor under this or any other contract he may hold under Government and/or from the security deposited by the contractor and hypothecated to the Crown under condition 7 (iii.) above or be recovered from him by action at law.

20. The Conservator of Forests reserves to himself the right, without question, of ejecting the contractor's employees and of rescinding the contract if the above conditions are not adhered to.

21. In case of any disagreement arising between parties to the contract it shall be referred to the Conservator of Forests whose decision in every case shall be final and binding on the parties to the contract.

22. For any further information, application should be made to the officer issuing the Tender form.

Special Conditions.

(a) Tenderers should quote two separate rates (1) on the basis of a supply for one year and (2) on the basis of a supply for three years.

(b) The distance of each area from the nearest Railway line is given in the schedule below.

(c) Only trees marked for felling by the Forest Department shall be felled. Under no circumstances shall trees of any of the following species be felled: Satin, Palu, Ranai, Milla, Halmilla, Hulanhik, Ebony, Kolon, Tamarind, Kirikon, Gammalu, Margosa and Mi.

(d) The contractor shall in accordance with the directions of the Divisional Forest Officer or any officer deputed by him cut all timbers in the area of operation.

(e) Should the contractor or any of his agents or workmen be responsible for the felling or damaging of any trees of whatever girth of the above reserved species or for causing any damage to trees not marked for felling which in the opinion of the Divisional Forest Officer is avoidable, the contractor shall be liable to a fine not exceeding double royalty for each tree so felled or damaged.

(f) All felled trees or other fallen trees shall be cut and split into firewood of billets of 3 ft. in length and not less than 2 in. or more than 9 in. in diameter.

(g) Firewood shall be stacked in the railway yard or on the approved railway line side in rows convenient for loading the firewood into railway trucks. To economize ground space and to allow space between the stacks for inspection,

stacks shall be either 3 ft., 4½ ft. or 6 ft. in height as the Forest Officer in charge may direct from time to time. Walking space should be left between any two stacks.

(h) The contractor shall be responsible for the safety of the firewood either in the forest or in transit or on the railway line side until taken over by the Railway Department.

(i) The contractor may be required at the instance of the Railway Department to increase or decrease the rate of supply of firewood prescribed in the schedule.

(m) The contractor shall at his own cost and charges furnish labour, transport, implements, tools, wire-shoots, and material necessary for carrying on the work under this contract.

(n) The contractor will be allowed by the Divisional Forest Officer to open extraction roads at distances not less than ten chains apart and at right angles or parallel to the Railway line or P. W. D. road to which extraction is to be made and haulage by cart shall be restricted to such roads. The construction of such roads shall be strictly in accordance with the directions of the Divisional Forest Officer.

(o) The contractor will be permitted to convert the material in the forest but transport from the forest to the extraction road must be by headload only.

Forest Officer, in charge of the work, in writing at the commencement of work under the contract and who shall hold a written authority from the contractor, shall at all times and without fail be at the working centres to supervise and control workmen and to take orders from inspecting Forest Officers. Should this condition not be complied with the inspecting officer shall have the power to eject such workmen. Further the Divisional Forest Officer shall have the power to reject without question, any of the contractor's agents or employees. The contractor will be at liberty to change his agents, provided the changes are duly communicated to the Divisional Forest Officer and the Range Forest Officer in writing and provided that each new agent holds a written authority from the contractor to act on his behalf.

(t) The Divisional Forest Officer shall have power to impose fines not exceeding Rs. 100 for any breach of the conditions or for any delinquencies on the part of the contractor in carrying out this contract. Syllabuses.

English.—The paper shall contain:—

(a) a subject for an essay, to be chosen by the candidate from several subjects set, the main object being to test power of expression, thought, and arrangement.

(b) Precis writing (the subject set may be either a selection of diplomatic or other correspondence, or one or more passages of a prose author).

Note.—The contents of the passage set may be classified under three heads:—(a) What is important, (b) What is less important, (c) What is unimportant. The merit of the candidate's work will be judged by his ability to distinguish between these. A good candidate will retain (a), omit (c), and keep (b) in due subordination.

The style should be clear and consistent, e.g., in an oratorical passage the candidate should not insert here and there rhetorical phrases which are out of harmony with the style of the rest. In dealing with correspondence the candidate should not write separate abstracts of each letter, but a summary of the whole correspondence in continuous English.

(c) A question testing knowledge and command of English Idiom, and the construction of sentences.

Candidates are expected to devote about one hour to the Essay.

Latin.—The paper shall contain:—

(a) Passages from Latin authors for translation into English.

(b) English sentences for translation into Latin.

(c) Questions on Latin grammar.

Greek.—The paper shall contain:—

(a) Passages from Greek authors for translation into English.

(b) English sentences for translation into Greek.

(c) Questions on Greek grammar.

Sanskrit.—The paper shall contain:—

(a) Translation into English of easy passages.

(b) An easy English passage for translation into Sanskrit.

(c) Questions on grammar and easy idioms.

Pali.—The paper shall contain:—

(a) Translation into English of easy passages.

(b) An easy English passage for translation into Pali.

(c) Questions on grammar and easy idioms.

Sinhalese.—The paper shall contain:—

(a) Translation into English of easy passages.

(b) An easy English passage for translation into Sinhalese.

(c) Questions on grammar and on well-known authors and books.

(d) An essay in Sinhalese on one of four subjects set at the examination.

Tamil.—The paper shall contain:—

(a) Translation from Tamil into English.

(b) Translation from English into Tamil.

(c) Questions on Tamil grammar and on well-known authors and books.

(d) An essay in Tamil containing not more than 500 words.

History.—One of the following branches (one paper will be set in each branch):—

(a) *English History.* The general outlines of English History, with some reference to social and economic History, to the contemporary history of Europe, and to the History of the British Empire.

(b) Medieval European History.

(c) Modern European History.

A wide choice of questions will be allowed. Credit will be given for a knowledge of historical Geography, and sketch maps to illustrate it.

(d) A paper may be set on the History of the British Empire, if any candidates apply for it.

Economics.—The paper shall contain questions on the Scope of economics, the economic problem as the problem of satisfaction of unlimited wants with limited means, nature of wants, marginal utility, the principle of equi-marginal utility, the motive of exchange, the determination

of value, supply and demand, exchange in monopoly and competition, production, the price system, as the regulator of production, costs, the allocation and the pricing of the factors of production, marginal productivity, companies and other forms of business organization in modern communities, problems of the firm, specific incomes, rent, interest, wages and profits.

One or two questions may be set with a view to test the candidate's general knowledge of current economic problems.

Geography.—A broad study of the outlines of World Geography including the division of the world into Geographical Regions.

The following Regions in decreasing detail:—

(a) Ceylon and India.

(b) The rest of Asia.

(c) The rest of the World.

The study should be based upon the principles of Physical Geography, of which the candidate will be expected to have an elementary knowledge.

In addition to questions requiring descriptive answers, practical exercises may be set on such subjects as maps, and map-reading, meteorological and other geographical statistics.

Logic.—The syllabus will be the same as the syllabus for the London Matriculation Examination, 1940.

Mathematics.—The syllabuses in (a) Elementary Mathematics, (b) Mathematics (more Advanced), (c) Mechanics, will be identical with the syllabuses for the London Matriculation Examination, 1940.

Physics.—The syllabus will be identical with the syllabus for the London Matriculation Examination, 1940.

Chemistry.—The distinction between elements, compounds, and mixtures. Physical and Chemical changes. The laws of Boyle, Charles, and Gay-Lussac. Avogadro's Hypothesis. Volume relations in gaseous reactions. The relationship between densities of gases and their molecular weights.

The laws of definite and multiple proportions. Equivalent weights and methods for their determination. Atomic weights and their determination by the aid of Dulong and Petit's law. Valency.

Atoms, molecules, formulae, chemical equations, and simple calculations based on them.

Characteristics of acids, bases, and salts; metals and non-metals.

Diffusion; simple cases of reversible reaction; catalysis; an elementary study of electrolysis; chemical applications of Faraday's laws of Electrolysis.

Elementary experimental study of air and water; natural waters; solution, crystallization and distillation.

The preparation and properties of the elements hydrogen, oxygen, nitrogen, phosphorus, chlorine, and sulphur; the chemistry of their more important compounds with hydrogen and oxygen including ozone and hydrogen peroxide. Formation of nitrates in the soil. Carbon; allotropic forms of carbon; carbon monoxide and dioxide; carbonates. Silica and the making of glass.

The properties of sodium, potassium, calcium, iron, copper, lead, and zinc; and the preparation and properties of their oxides, hydroxide, and more important compounds. The principles involved in the large scale preparation of sodium hydroxide, sodium carbonate, sulphuric acid, and nitric acid.

Botany.—One paper will be set on the revised syllabus in Botany for the Cambridge Senior Certificate Examination, 1939. (see page 7 of the regulations for the Cambridge Senior Certificate Examination, December, 1939, i.e., Sections on General Morphology, Plant Physiology, Units of Vegetation, and Classification of Plants).

Zoology.—The syllabus will be identical, with the syllabus for the London Matriculation Examination, 1940.

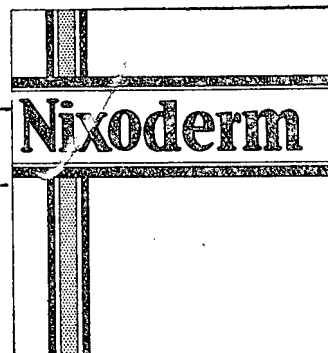

THE POST OFFICE ORDINANCE.

IN the exercise of the powers vested in the Governor by section 9 (3) of the Post Office Ordinance (Chapter 146) and delegated to the Postmaster-General by Notification under section 91 of the Ordinance published in *Gazette* No. 8,099 of January 11, 1935, I, John Radley Walters, Postmaster-General, do hereby notify that, in lieu of the terms, conditions, and requirements relating to Air Mails set out in the Schedule to the Notification published in *Gazette* No. 8,369 of May 20, 1938, the terms, conditions, and requirements set out in the Schedule hereto shall have effect.

SCHEDULE.

Air Mails.

1. *Definition.*—"Air service" means the service whereby postal articles may be forwarded by air to the country of destination, or for part of the journey by air, on payment of a combined postage and air fee.

2. Every article for transmission by the air service must bear on the top left hand corner of the cover an air mail label or the words "By Air Mail" clearly written or printed. (It is recommended that the air route be written below thus:
"Via.....".)

3. Every article for transmission by the air service must be fully prepaid by means of postage stamps affixed to the article, according to rates notified from time to time in the

Post Office Daily List or the Air Mail leaflet published by authority of the Postmaster-General. Unpaid or insufficiently prepaid air mail articles will not be forwarded by the air service.

4. *Registration.*—Air Mail letters and postcards may be registered on payment, in addition to the usual air mail rates, of the registration fee of 15 cents in the case of an article addressed to India, or 20 cents in the case of an article addressed to any other country.

5. *Insurance.*—Insurance is not available for air mail articles except on those addressed to India.

6. *Air Mail Money Orders.*—Advices of money orders payable in India or the United Kingdom shall be forwarded by the air service on payment of an air fee of 10 cents and 30 cents respectively on each order, irrespective of value, in addition to the usual money order commission. The words "Air Mail" shall be clearly written across the application form in ink where no special form of application is provided for the purpose.

7. *Services not available.*—The air mail service is not available for parcels and insured boxes.

8. *General Conditions.*—(i.) Articles for conveyance by the air service must comply with the rules relating to weight, make-up and size published in the Foreign Letter Post Regulations, 1935.

(ii.) The general conditions relating to registration of articles published in the Foreign Letter Post Regulations, 1935, shall apply to registered articles forwarded by the air service.

(iii.) The general conditions relating to insurance, published in the Foreign Letter Post Regulations, 1935, shall apply to insured articles forwarded by the air service to India.

9. These terms, conditions, and requirements relating to Air Mails may be cited as the Air Mail Regulations, 1939.

The terms, conditions, and requirements relating to the Foreign Letter post, published as the Foreign Letter Post Regulations, 1935, in *Gazette* No. 8,100 of January 18, 1935, as amended by the notifications published in *Gazette* No. 8,369 of May 20, 1938, are hereby further amended as follows:—

(1) in regulation 2 (1)—

(a) in paragraph (a), by the omission of the words "or air", and

(b) by the omission of paragraph (c);

(2) by the substitution for regulation 13 of the following new regulation:—

"13. The postage on letters to all countries served by the Foreign post except India shall be 20 cents for the first ounce or part of that weight, and 10 cents for every additional ounce."; and

(3) by the substitution for regulation 17 of the following new regulation:—

"17. (1) The postage on postcards to all countries served by the Foreign post, except India, shall be 12 cents on each card.

(2) The postage stamps on postcards shall be affixed to the address side of a postcard and as far as possible to the right hand half of the card."
