An Ordinance to amend the Medical Ordinance and other written law in consequence of the suppression of the post of Deputy Director of Medical and Sanitary Services.

A. CALDECOTT.

BE it enacted by the Governor of Ceylon, with the advice and consent of the State Council thereof, as follows :-

This Ordinance may be cited as the Medical Amendment Ordinance, No. 35 of 1939.

2 Section 4 of the Medical Ordinance, (hereinafter re-ferred to as "the principal Ordinance") is hereby repealed.

Section 5 of the principal Ordinance is hereby amended-

(a) by the omission of the words and figure "or by section 4 of this Ordinance, ";

(b) by the omission of the word "Deputy" where that

word occurs in that section for the first time; and (c) by the omission of the words "or by the Deputy Director of Medical and Sanitary Services "

Section 8 of the principal Ordinance is hereby amended 4 in sub-section (1) thereof by the substitution in paragraph (b) for the words "Deputy Director of Medical and Sanitary Services", of the words "Assistant Director of Medical Services".

5 Section 9 of the principal Ordinance is hereby amended in sub-section (1) thereof by the substitution, for the words "Deputy Director of Medical and Sanitary Services" of the words "Assistant Director of Medical Services ".

Where in any written law made before the commencement of this Ordinance there occurs the expression "the Deputy Director of Medical and Sanitary Services " or any form of words intended to designate that officer, there shall be substituted therefor the expression "an officer of the Department of Medical and Sanitary Services authorised in that behalf by the Director "
