THE DEFENCE (MISCELLANEOUS) REGULATIONS.

THE EMERGENCY POWERS (DEFENCE) ACT, 1939.

DEFENCE regulation made by the Officer Administering the Government of Ceylon by virtue of the powers vested in the Governor by section 1 of the Emergency Powers (Defence) Act, 1939, of the Imperial Parliament, as adapted, modified, and extended to Ceylon by the Emergency Powers (Colonial Defence) Order in Council, 1939.

### THE FOOD CONTROL ORDINANCE.

IT is hereby notified in terms of section 4 (4) of the Food Control Ordinance (Chapter 132), that the Board of Ministers has refused to confirm the Order made under section 4 (1) (a) of the Ordinance and published in Gazette Extraordinary No. 8,540 of October 31, 1939, prohibiting the transport or removal from the Nuwarakalawiya division of the North-Central Province, of paddy grown in the said division, or of rice made from such paddy, except under the authority of a permit issued by the Deputy Food Controller of the said Province.
