

DEFENCE regulation made by the Governor by virtue of the powers vested in him by the Emergency Powers (Defence) Acts, 1939 and 1940, of the Imperial Parliament, as adapted, modified and extended to Ceylon by the Emergency Powers (Colonial Defence) Order in Council, 1939, and the Emergency Powers (Colonial Defence) (Amendment) Order in Council, 1940.

REGULATION.

The Defence (Miscellaneous) Regulations published in the Supplement to Gazette No. 8,533 of October 20, 1939, are hereby amended by the insertion, immediately after regulation 32B, of the following new regulations, which shall have effect respectively as regulations 32c, 32d, and 32E:—

Restrictions on departure of ships and aircraft.

32c. (1) The Governor, if it appears to him to be necessary or expedient so to do in the interests of public safety, the defence of the Island or the efficient prosecution of the war, or for maintaining supplies and services essential to the life of the community, may give directions—

- (a) as respects any class of ships or aircraft in the Island, that no ship or aircraft of that class shall leave any port or place in the Island at which it may be;
 (b) as respects any particular ship or aircraft at any port or place in the Island, that the ship or aircraft shall not leave that port or place by the permission granted by the present of the ship or aircraft shall not leave that port or place by the permission granted by the
- place, except with permission granted by the Governor or such person as may be specified in the directions.

(2) If any ship of aircraft leaves or attempts to leave any port or place in contravention of any directions given under this regulation, the master of the ship or the pilot of the aircraft, as the case may be, shall be guilty of an offence against this regula-tion tion

tion. (3) Any servant of His Majesty may, in relation to any ship or aircraft, take such steps, and use such force, as may appear to him to be reasonably necessary for securing compliance with such direc-tions given under this regulation as are applicable to the ship or aircraft, for, where an offence against this regulation has occurred in the case of the ship or aircraft, for enabling proceedings in respect of the offence to be effectually taken.

 32_{D} . (1) No person lawfully engaged to serve on board any ship to which this regulation applies shall-

- (a) neglect or refuse without reasonable cause to join his ship or to proceed to sea in his
- ship; or (b) desert or be absent without leave from his ship; or (c) be absent without leave from his duty at any
- time.

(2) Nothing in the foregoing provisions of this regulation shall be taken to prejudice the provisions of section 221 of the Merchant Shipping Act, 1894, or sub-sections (1) and (2) of section 73 of the Merchant Shipping Ordinance, relating to forfeiture of effects or wages for desertion or absence without leave

leave.
(3) Where an authorized officer has reason to believe that any person has, in Ceylon, contravened the provisions of paragraph (1) of this regulation, that person may be conveyed on board his ship by or under the direction of that officer.
(4) For the purpose of the last foregoing paragraph, the following persons shall be authorized officers, that is to say, the master of the ship, any mate of the ship, the person having the management of the ship, any police officer, any commissioned officer in His Majesty's forces and any shipping officer appointed under the Merchant Shipping Ordinance.
(5) Fn relation to ships to which this regulation applies, the last two foregoing paragraphs shall have applies, the last two foregoing paragraphs shall have effect—

(a) in the case of a British ship, in substitution for the provisions of section 222 of the Merchant Shipping Act, 1894, section 76 of the

Merchant Shipping Ordinance and section 2 of the Merchant Shipping (War Service) Ordinance ;

(b) in the case of a ship belonging to a subject of a foreign country to which section 238 of the Merchant Shipping Act, 1894, for the time being applies, in substitution for the provisions of sub-sections (2) and (3) of that section.

(6) No person lawfully engaged to serve on board any ship to which this regulation applies, shall join his ship, or be whilst on board his ship, in a state of drunkenness so that the performance of his duties or the navigation of the ship is thereby impeded.

(7) The ships to which this regulation applies are

- (a) every ship belonging to His Majesty and every ship, whether British or foreign, chartered or requisitioned by or on behalf of His Majesty; and
 (b) every ship in respect of which there is for the time being in force a licence granted in pursuance of an order made-under regulations of the United Kingdom or under any corresponding regulation made under the Emergency Powers (Defence) Acts, 1939 and 1940, of the Imperial Parliament by the Governor of any territory to which those Acts have been extended by the Emergency Powers (Colonial Defence) Order in Council, 1939, and the Emergency Powers (Colonial Defence) Order in Council, 1940.
 32E. (1) Upon the entry of any ship into the

Safe custody 32E. (1) Upon the entry of any ship into the territorial waters of Ceylon—

- (a) the master of the ship shall, by exhibiting e master of the ship shall, by exhibiting notices in conspicuous places in the ship and by taking all such other measures as may be reasonably necessary, cause every camera on board the ship to be deposited, within such time as may be specified in the notice, with him or with any other officer of the ship designated by him in that behalf; and evy person on board the ship who is in
- (b) every person on board the ship who is in possession or has control of any camera or cameras shall deposit such camera or each such camera, within the time specified in the notice, either with the master of the ship or with the officer designated by the master in that behalf.
- (2) Subject as hereinafter provided, every camera deposited under the preceding paragraph with the master of a ship or other officer designated by him in that behalf shall, throughout the period during which the ship remains within the territorial waters of Ceylon, be kept in safe custody under lock and key by such master or other officer : Provided that any camera or cameras so deposited by a person whose destination is a port in Ceylon shall be taken out of the aforesaid safe custody and returned to such person at the time of his disembarka-

returned to such person at the time of his disembarkation at such port.

(3) Where any camera on board any ship within the territorial waters of Ceylon (other than a camera in the possession of any person at the time of his embarkation on or disembarkation from such ship) is not at any time kept in safe custody under lock and key by the master of the ship or other officer designated by him in that behalf, the master and the person in whose possession the camera is found shall severally be guilty of an offence against this regulation

(4) Nothing in the preceding provisions of this regulation shall apply to any camera which—

- (a) is the property of His Majesty or of the Government of any part of His Majesty's dominions; and `
 (b) is entrusted to and is in the possession of any officer of His Majesty's forces for use in connection with his official duties; and
- (c) is required for such official use at any port or place in Ceylon.

The Defence (Finance) Regulations published in *Gazette Extra-*ordinary No. 8,509 of September 19, 1939, as last amended by regulations published in *Gazette Extraordinary* No. 8,693 of December 11, 1940, are hereby further amended as follows :--

Restrictions on dealings in scheduled currency or gold.

4. Except with permission granted by or on behalf of the Governor, no person other than an authorized dealer shall buy or borrow any scheduled currency or any gold from, or lend or sell any scheduled currency or any gold to, any person who is not an authorized dealer not an authorized dealer.

Power of Governor to prohibit action on certain orders as to gold, &c.

Where the Governor is satisfied upon information received from the Secretary of State that any State is exposed to pressure from another State and in consequence action is being, or is likely to be, taken to the detriment of the economic position of the British Empire, the Governor may give general or special directions prohibiting, either absolutely or to such extent as may be specified in the directions, the carrying out, except with permission granted by or on behalf of the Governor, of any order given by or on behalf of-

 (b) any body corporate which is incorporated under the laws of that State or is under the control of that State or the Sovereign thereof or any person resident therein,

- (ii.) requires any change to be made in the persons to whose credit any sum is to stand or to whose order any gold or securities are to be hold. held;

REGULATION.

The Defence (Finance No. 2) Regulations published in *Gazette* Extraordinary No. 8,525 of October 11, 1939, as last amended by the regulation published in *Gazette* No. 8,666 of October 4, 1940, are hereby further amended by the substitution, for regulation I thereof, of the following new regulation :-

Acquisition by the Crown of certain specified currencies.

1. (1) Every person in whose case the following conditions are fulfilled, that is to say--

- (a) that he is, or has, at any time since the eleventh day of October, 1939, been, in Ceylon or, being a corporation, he is, or has, at any time since the eleventh day of October, 1939, been, resident in Carlon and Ceylon, and
- (b) that he is entitled to sell, or to procure the sale of, any currency to which this regulation applies,

shall offer it, or cause it to be offered, for sale to the Controller of Exchange or to a person desig-nated by him for the purposes of this regulation, at such price as may be determined by or on behalf of the Controller. (1A) Where a person has become bound under paragraph (1) of this regulation to offer, or cause to be offered, for sale, any currency to which this regulation applies, and has not done so, the Governor may direct that that currency shall vest in the Crown, and it shall vest in the Crown accordingly free from any mortgage, pledge or charge, and the Crown may deal with that currency as it thinks fit, but the Deputy Financial Secretary. as it thinks fit, but the Deputy Financial Secretary. shall, on behalf of the Crown, pay to the person, who would but for the direction be entitled to possession of the currency, such price in respect thereof as may be determined by or on behalf of the Controller.

(2) Every person in whose case the following conditions are fulfilled, that is to say—

(a) that he is, or has, at any time since the eleventh day of October, 1939, been, in Ceylon or, being a corporation, he is, or has, at any time since the eleventh day of October, 1939, been, resident in Ceylon, and and

(b) that he is entitled to assign, or procure the assignment of, any right to receive, in respect of any credit or balance at a bank, payment of any amount in a currency to which this regulation applies,
shall, unless the Controller or a person designated by him for the purposes of this regulation, gives him notice to the contrary, do all things necessary for the purpose of assigning that right to the Controller or to a person so designated. The sum payable as consideration for any assignment made in accordance with this paragraph shall be such as may be determined by or on behalf of the Controller.
(2A) Where a person has become bound under paragraph (2) of this regulation to take steps for the purpose of assigning any right to the Controller or to a person designated by him for the purposes of this regulation, but that right has not effectively been assigned, the Governor may direct that the right regulation, but that right has not enectively been assigned, the Governor may direct that the right shall vest in the Crown, and the right shall vest in the Crown accordingly free from any mortgage or charge, and the Crown may deal with the right as it thinks fit, but the Deputy Financial Secretary shall, on behalf of the Crown, pay to the person, who would but for the direction be entitled to precise the amount in any currency to which this receive the amount in any currency to which this regulation applies, such sum as consideration as may be determined by or on behalf of the Controller. (3) The preceding provisions of this regulation

shall not impose upon any person an obligation in respect of any currency or any right to receive payment of any amount if and so long as he is, in respect of that currency or right, exempted from this regulation by the Controller or a person designated by him for the purposes of this regula-tion tion

(4) The currency to which this regulation applies is such currency as may from time to time be designated by the Governor for the purposes of this regulation by notice published in the *Gazette*.

(2) Subject to such exemptions as may be granted by order of the Governor, it shall not be lawful to issue any prospectus or other document offering for subscription, or publicly offering for sale, any securities which does not include a statement that the consent of the Governor has been obtained to the issue or offer of the securities.

(3) For the purposes of this regulation a person shall be deemed to make an issue of capital who—

- (a) issues any securities (whether for cash or otherwise), or
- (b) receives any money onaloan on the terms, or in the expectation, that the loan will or may be repaid wholly or partly by the issue of any securities, or by the transfer of any securities issued after the making of the loan.

(4) A security shall not be invalid by reasons that the consent of the Governor has not been given to the the consent of the Governor has not been given to the issue thereof, or that any conditions imposed by the Governor in relation to the issue thereof have not been complied with, but nothing in this paragraph shall be construed as modifying the liability of any person to any penalty in respect of any failure to obtain such consent or to comply with such conditions. (5) In this regulation, references to securities and to the issue of securities respectively include as

The Defence (Gold Coin and Bullion) Regulation published in Gazette Extraordinary No. 8,516 of September 28, 1939, is hereby amended as follows :-

(1) Every person in whose case the following conditions are fulfilled, that is to say—

(a) that he is, or has, at any time since the twenty-eighth day of September, 1939, been, in Ceylon or, being a corporation, he is, or has, at any time since the twenty-eighth day of September, 1939, been, resident in Ceylon; and

(b) that he is entitled to sell, or to procure the sale of, any gold ; shall offer that gold, or cause it to be offered, for sale to the Controller or to a person designated by him for the purposes of this regulation, at such price as may be determined by or on behalf of the Controller:

Provided that the preceding provisions of this paragraph shall not impose upon any person an obligation to offer any gold for sale, or to cause any gold to be offerd for sale, if and so long as he is, in respect of that gold, exempted from this regulation by the Controller or a person designated by him.

(1A) Where a person has become bound under paragraph (1) of this regulation to offer, or cause to be offered, any gold for sale, and has not done so, the Governor may direct that that gold sale, and has not done so, the Governor may direct that that goin shall vest in the Crown, and it shall vest in the Crown accordingly free from any mortgage, pledge or charge, and the Crown may deal with that gold as it thinks fit, but the Deputy Financial Secretary shall, on behalf of the Crown, pay to the person who would but for the direction be entitled to possession of the gold such price in respect thereof as may be determined by or on behalf of the Controller.

BY-LAW.

The by-laws relating to pensions, gratuities, and retiring allowances, published in *Gazette* No. 7,999 of August 18, 1933, as last amended by by-law published in *Gazette* No. 8,553 of December 1, 1939, are hereby further amended by the addition, immediately after by-law 6, of the following new by-law 6A :=

"6A. The Council may call upon any officer who is below the limit of age for retirement on pension to retire from the service on the ground of his inability to discharge efficiently the duties of his office. In such a case, if the Council considers that the special circumstances of the case justify the grant of a retiring allowance, the officer so called upon to retire may, with the approval of the Governor, be given such retiring allowance as the Council thinks just and proper, but in no case exceeding the amount for which his length of service would qualify him."

BY-LAW.

The by-laws published in *Gazette* No. 7,798 of August 15, 1930, as last amended by by-law published in *Gazette* No. 8,476 of August 25, 1939, are hereby further amended by the addition, immediately after by-law 16, of the following new by-law 17 :-

"17. (1) The Council may, with the approval of the Governor, pay a gratuity in accordance with the provisions of this by-law to the widow or to the children or to the dependants of any officer or servant who dies in the service of the Council after he has completed five years' public service as defined in by-law 13 (2) and while he is in receipt of a salary of not less than Rs. 360 per approximately constrained in the service of the council service is the service of the council service is the service of the council after he has completed five years' public service as defined in by-law 13 (2) and while he is in receipt of a salary of not less than Rs. 360 per annum.

(2) (a) In the case of any officer or servant referred to in paragraph (1) who was holding a post on the fixed establishment of the Council at the time of his death, the gratuity payable under this by-law shall be a sum equal to twelve times the monthly-salary drawn by him in respect of that post at that time.

(b) In the case of any officer or servant referred to in paragraph (b) In the case of any officer or servant referred to in paragraph (1) who was not on the fixed establishment of the Council at the time of his death, the gratuity payable under this by-law shall be a sum equal to three times the monthly salary of the post held by him at that time, and an additional sum equal to such monthly salary for each minor child surviving him : Provided however that such additional sum shall not be payable in respect of more than nine such minor children in any one case.

(c) In the case of any officer or servant referred to in paragraph (1) who was holding a post on the fixed establishment of the Council at the time of his death but was in receipt of a salary of less than Rs. 360 per annum, the gratuity payable under this by-law shall be a sum equal to three times the monthly salary drawn by him in respect of that post at that time, and an addi-tional sum equal to such monthly salary for each minor child surviving him: Provided however that such additional sum shall not be payable in respect of more than nine such minor children in any one case.

- (3) The gratuity shall be pavable-
- (a) where the widow of the deceased officer or servant survives him, to such widow, whether or not there is any child of such widow surviving him; or
- (b) where the widow, whether with or without children, and also children by a previous marriage of the deceased officer or servant, survive him, to the widow and to the children of such previous marriage in such manner and in such proportion as the Council may determine; or
- (c) where there in no widow surviving, to the children of the deceased officer or servant in such manner and in such proportion as the Council may determine; or
- (d) where there is no widow or child of the deceased officer or servant surviving him, to the dependants who were living with and maintained by him at the time of his death.

(4) Where any child, to whom the amount of any gratuity or share of a gratuity is payable under this by-law, is a minor, such amount may be paid to some person approved by the Council, for the use and benefit of such child."




