PRELIMINARY NOTICES.

LAND SETTLEMENT ORDINANCE.

Settlement Notice No. 2,230 (Kurunegala).

2. FIRST SCHEDULE.

SECOND SCHEDULE.

2. The Assistant Government Agent may, on the date on which the tenders are opened, call upon the successful tenderer to deposit a sum not exceeding fifty rupees. In the event of such tenderer failing to comply with the request the tender will be rejected.

3. The Assistant Government Agent reserves the right to reject any or all the tenders.

4. The person whose tender is accepted shall, within one month of the date of communication of such acceptance, pay to the Assistant Government Agent the premium and the first year's rent and execute a lease. In the event of the lessee's failure to pay the premium and rent or to execute the lease within 10 days of it being sent to him, the Assistant Government Agent may cancel the sale and forfeit any deposit paid by the tenderer.

5. The proposed lease will include the following conditions:—

(a) The annual rental is Rs. 300. The lessee shall pay this amount at the Kegalla Kachcheri on February 1, in every year.

(b) The term of the lease shall be five years from February 1, 1941: Provided that either party may terminate the lease on three months' notice to the other party.

(c) The lessee shall pay all existing and future rates and assessments.

(d) The lessee shall maintain all buildings and plantations standing on the land to the satisfaction of the Assistant Government Agent.

(e) The lessee shall make no alterations or additions or demolition of the buildings standing on the land, without the written consent of the lessor.

(f) The lessee shall not cause damage to or fell or remove any plantation or trees standing on the land without the written consent of the lessor.

(g) The lessee shall fence the land if called upon by the Assistant Government Agent to do so.

(h) The lessee shall keep the exterior and the interior of the buildings standing on the land in good and substantial repair and condition.

(i) The lessee shall keep the premises clean and in good condition.

(j) The lessee shall not in any way whatsoever dispose of or otherwise deal with his interests under this lease, except with the consent of the Land Commissioner previously obtained in writing.

(k) The lessee shall permit the Assistant Government Agent, or anyone acting under his orders at all reasonable hours during the term of the lease to enter upon the land and inspect the condition thereof.

(l) If the whole or any portion of the premises is required by the Government before the expiry of the lease such whole or portion thereof shall be surrendered on one month's notice being given. In that event a proportionate reduction in the rent will be made for the unexpired portion of the term.

(m) In the event of any breach of the foregoing conditions, the Assistant Government Agent may cancel the lease forthwith and resume possession of the land and the buildings thereon.
