THE DEFENCE (CONTROL OF IMPORTS) REGULATIONS.

Order.

BY virtue of the powers vested in me by regulation 4 of the Defence (Control of Imports) Regulations, I, Andrew Caldecott, Governor of Ceylon, do by this Order—

- (1) rescind the Order under that regulation published at pages 10 and 11 of the Supplement to Gazette No. 8,712 of February 14, 1941;
- (2) direct, without prejudice to the Orders under regulation 3 and under regulation 4 of the aforesaid regulations published respectively at pages 2 and 7 of the Supplement to Gazette No. 8,712 of February 14, 1941, that except under the authority of a licence granted by or on behalf of the Controller of Imports, no person shall import into Ceylon any goods of the classes and description set out in the Schedule hereto; and
- (3) exempt from the restriction imposed by paragraph (2)-
 - (a) such of those goods as may be consigned to or imported by or for the use of consular officers named in any Order of the Governor issued under section 21 of the Customs Ordinance :
 - (b) such of those goods as may be exempted from payment of import duty under section 22 of the Customs Ordinance;
 - (c) such of those goods as may be required by section 47 of the Customs Ordinauce to be passed duty free in the circumstances and on the terms and conditions prescribed in that section;
 - (d) such of those goods as are exempted as passengers' baggage within the meaning of the Customs Regulations;
 - (e) such of those goods as may be imported for any purpose approved by the Principal Collector of Customs, other than the purposes of sale or barter, in such quantities as the Principal Collector of Customs may consider reasonable in the circumstances of each case;

- (f) such of those goods as may be imported by visitors, or residents returning to the Island, in such quantities as the Principal Collector of Customs may consider reasonable in the circumstances of each case;
- (g) such of those goods as may be imported by the agents or the members of the staff of the agents of any shipping company, in vessels belonging to that company, for the use of such agents or staff, and in such quantities as the Principal Collector of Customs may consider reasonable in the circumstances of each case; and
- (h) such of those goods as may be imported as samples by commercial travellers or indenting agents.

SCHEDULE. Such of the following classes of goods as are shipped direct to Ceylon from any place in the United Kingdom:—

- All articles of food and drink falling within Groups A, B, C, D, and E in Class I. of the Customs Classification, with the exception of sparkling wines other than champagne,
 All vegetable oils other than those included in item 1,
 Saccharin.
- Saccharin, Starch of all kinds.
