THE DEFENCE (FINANCE) REGULATIONS

43/2/61 (FSO)

Directions under Regulation 4A

- I, Andrew Caldecott, Governor of Ceylon, by virtue of the powers vested in me by Regulation 4A of the Defence (Finance) Regulations, 1939, do hereby prohibit except with permission granted by the Controller on my behalf, the carrying out of an order given by or on behalf

  - (a) the State named in paragraph 2 hereof or any person resident therein, or
     (b) any body corporate which is incorporated under the laws of the State or which is under the control of that State, or of any person resident therein in so far as that order—

    - (1) requires the person to whom the order is given to make any payment or to part with any gold or securities, or (11.) requires any change to be made in the persons to whose credit any sum is to stand or to whose order any gold or countries are to be held. securities are to be held.
  - 2. The State referred to in paragraph 1 is China, including the International Settlement in Shanghai.
  - 3. I do hereby grant permission to bankers-

    - (a) to honour their obligations under confirmed credits opened prior to August 2, 1941, on account of the State or any person or body corporate referred to in paragraph I (a) or paragraph I (b) hereof.
      (b) to accept bills or drafts and to pay cheques bills or drafts drawn by or for the State, or any person or body corporate referred to in paragraph I (a) or paragraph I (b) hereof and presented by or on behalf of any person who being in possession thereof became a holder for value thereof before August 2, 1941.
      (c) to carry out orders received before August 2, 1941, for making of any payment or transfer of gold or securities in or within Ceylon.

Provided that nothing in the foregoing directions shall authorise or be deemed or construed to authorise any transactions prohibited by er under the Defence (Trading with the Enemy) Regulations, 1939, or any Order made thereunder, or by or under any other written law.

Note —All unconfirmed credits opened on account of the State abovementioned or for account of any persons resident therein or any body corporate referred to in paragraph 1 (b) therein (including branches or subsidiaries wherever carrying on business) should be cancelled forthwith But, provided no other Regulation of the Defence (Finance) Regulations, 1939, is infringed, there is no objection to sums which may be received for the credit of accounts blocked under these directions being credited to such
