THE DEFENCE (CONTROL OF EXPORTS) REGULATIONS.

Order.

BY virtue of the powers vested in me by regulation 3 of the Defence (Control of Exports) Regulations, 1, Andrew Caldecott Governor of Ceylon, do by this Order amend the Schedule to those Regulations (as last amended by the Order published in Gazette No. 8,787 of August 29, 1941), by the addition of the following new item to that Schedule

"12. Sugar, refined and unrefined, including candy and jaggery ".

THE DEFENCE (CONTROL OF EXPORTS) REGULATIONS.

Order.

BY virtue of the powers vested in me by regulation 3 (1) of the Defence (Control of Exports) Regulations, I, Andrew Caldecott, Governor of Ceylon, do by this Order amend the Order of exemptions under that regulation published in Gázette No. 8,787 of August 29, 1941, as follows:

(I) in paragraph (c) of that Order, by the substitution for the words "Principal Collector of Customs:" of the words "Principal Collector of Customs:"

(2) by the addition, immediately after paragraph (e) of that Order, of the following new paragraphs:

- "(f) the sending or taking out of Ceylon of any quantity of any commodity specified in item 12 of the Schedule to the principal Regulations, by or on behalf of the Government of Ceylon or by or for the use of any of His Majesty's Naval, Military or Air Forces;

 (g) the taking out of Ceylon on board any ship for use as ships stores by that ship, or for the personal use of any passenger travelling on that ship, or of any member of his family, of any such quantity of any commodity specified in the aforesaid item 12 as the Principal Collector of Customs may consider reasonable for the purpose;

 (h) the sending out of Ceylon by post to the United Kingdom of any parcel containing not more than two pounds in weight of any commodity specified in the aforesaid item 12,

 (i) the sending out of Ceylon by post to any territory other than the United Kingdom of any parcel containing not more than five pounds in weight of any commodity specified in the aforesaid item 12."

BY virtue of the powers vested in me by regulations 3 and 4 of the Defence (Control of Imports) Regulations, I, Andrew Caldecott, Governor of Ceylon, do by this Order amend the First Schedule to the Order under those regulations published at page 5 of the Supplement to Gazette No. 8,776 of August 1, 1941, as follows:

(1) by the omission of item 112; and
(2) by the insertion of the following new items immediately after item 111:

"112. Vegetable oils, fats and greases: Coconut oil II. G
112a. Vegetable oils, fats and greases (other than essential oils, olive oil, substitutes for ghee, coconut oil and gingelly oil)
