Defence (Finance No 2) Regulations

43/2/62 (FSO)

IN pursuance of the provisions of regulation 2(4) of the Defence (Funance No 2) Regulations, I, Veluppilla Coomaraswamy, Controller of Exchange, do by this notification amend the Schedule to the notification under the aforesaid regulation published in *Gazette* No 8,668 of October 11, 1940, as amended by any subsequent notification, as follows —

(1) by the addition, at the end of the list of territories mentioned in that Schedule, of the following item — "China-Sterling or rupees by method N or method O",

(2) by the insertion, immediately after the definition of "method M", of the following new definitions -

"" method N" means payment by a sterling or rupee bill drawn under a credit which is opened by the buyer of the goods with a bank approved by the Controller and which is registered with the Bank of England or the Ceylon Exchange Control respectively on Form E 2
"method O" means payment in sterling or rupees made in the United Kingdom or Ceylon (against documents or otherwise) by or through a bank approved by the Controller."
