NOTICE is hereby given, in terms of sub-section 2 of section 14 of Ordinance No. 26 of 1890, that bathing or washing animals or clothes in the lake at Vauxhall street, facing Dawson street, is hereby prohibited. Any person found bathing, washing, or doing any act contrary to this notice will be guilty of an offence, and be liable on conviction to a fine not exceeding Rs. 50 in terms of sub-section 3.

Minutes of Proceedings of a General Meeting of the Municipal Council of Colombo held in the Town Hall on Friday, September 13, 1895.

The Council met this day at 3 P.M., pursuant to notice dated September 7, 1895.

Present :—Mr. F. H. Price, Acting Mayor and Chairman; Capt. F. Bayley; Mr. M. Finlay; Dr. J. L. Vanderstraeten; Hon. A. de A. Seneviratne; Mr. M. I. M. Haniffa; Mr. C. Perera; Mr. C. P. Dias; Mr. Walter Pereira; Mr. R. H. Morgan; Mr. C. M. Fernando; and Mr. A. Alvia.

The Minutes of August 9, 1895, having been printed, and a copy thereof having been sent to each Member of the Council, were taken as read.

Resolved,—That the Minutes of August 9, 1895, be confirmed.

Hon. A. de A. Seneviratne, by leave of Council, presented a petition dated August 30, 1895, from Louis Fernando and other residents of St. Joseph's lane, and moved that it be read.

The petition was read.

1. Pursuant to notice Mr. C. M. Fernando moved "that a Sub-Committee of the Council be appointed to consider and report on the question of the housing of the poor within the Municipality of Colombo, referred to in the report of the Sanitary Officer for the second quarter of the present year."

Dr. Vanderstraeten seconded.

By leave of Council the above motion was amended as follows:—"That a Sub-Committee be appointed to consider and report upon the gradual improvement of the sanitary condition of the overcrowded localities of the town."

The motion so amended was seconded by Mr. Dias and carried.

Resolved,—That a Special Committee be appointed, consisting of the Chairman, Captain F. Bayley, Dr. J. L. Vanderstraeten, Hon. A. de A. Seneviratne, Mr. Chas. Perera, Mr. C. P. Dias, and Mr. C. M. Fernando—three members to form a quorum.

2. The following motion standing in Mr. C. P. Dias' name was, by leave of Council, withdrawn:—"To move that the Sanitary Officer be requested to formulate a scheme, which, in his opinion, will gradually improve the most insanitary and worst overcrowded parts of the town, and provide housing for the poor in the city."

3. The consideration of the following question and motion standing in Hon. A. de A. Seneviratne's name was deferred, in the absence of the Inspector-General of Police:—"To ask if the attention of the Government has been called to the absence of police protection at the Victoria Bridge and its approach road, and to move for papers."

4. The following recommendations from the Standing Committee of August 5 and September 6 and 7, 1895, were laid before the Council:—

August 5.

3. Estimate for drain, 2nd Division, Maradana (Rs. 485).

Resolved that the estimate of Rs. 485 be passed, and that the transfer of this amount for the purpose, from vote 27 in the Supplemental Budget, be recommended to the Council.

7. Opinion of Attorney-General on question of assessment of Havelock racecourse.

Resolved that the Council be recommended to ask the Government to make the occupier of Crown property, which has been leased, liable to assessment rate.

September 6.

4. Tenders for Floral Hall.

Resolved that Mr. Campbell's tender of Rs. 1,500 be accepted, subject to the conditions of the lease for 1894-95.

5. Tenders for lease of river frontage, bridge-of-boats.

Resolved that the tender of J. G. G. Abeyasinghe of Rs. 600 per annum be accepted.

9. Estimate for footpath from Colombo abutments of Victoria Bridge to Ferguson's road (Rs. 470).

Resolved that the estimate of Rs. 470 be passed, and that the transfer of this amount for the purpose, from vote 27 of Supplemental Budget, be recommended to the Council.

10. Estimate for repairing Madampitiya slaughter-house (Rs. 250).

Resolved that the estimate of Rs. 250 be passed, and that the transfer of this amount for the purpose, from vote 27 of Supplemental Budget, be recommended to the Council.

13. Estimate for repair of Floral Hall (Rs. 600).

Resolved, that the estimate of Rs. 600 be sanctioned, and that the transfer of this amount for the purpose, from vote 27 of Supplemental Budget, be recommended to the Council.

21. Question of interest paid to Gas Company for lamps erected at Council's expense.

Resolved, that the Gas Company be required to refund the amounts paid as interest on lamps which have been erected at the Council's expense.

Resolved, further, that such payments in respect of such lamps be discontinued in future.

37. Letter from Superintendent of Works submitting estimate of Rs. 96 for repair of buffalo shed, Dematagoda slaughter-house.

Resolved, that the estimate of Rs. 96, as amended by Superintendent of Works in letter 619 of September 2, 1895, be sanctioned, and that the transfer of this amount for the purpose, from vote 27 of Supplemental Budget, be recommended to the Council.

September, 7.

12. Estimate for building cesspit at Dean's road latrine (Rs. 285).

Resolved, that the estimate of Rs. 285 be sanctioned, and that the transfer of this amount for the purpose, from vote 27 of Supplemental Budget, be recommended to the Council.

24. Report and estimate of Superintendent of Works regarding recreation ground, Kachcheri garden.

Resolved,—That the estimates A and B of Rs. 2,000 and Rs. 4,500 respectively, attached to Superintendent of Works' letter 615 of August 29, 1895, be approved.

Captain Bayley moved, "that the recommendation contained in paragraph 4 of the Minutes of the Standing Committee of September 6, 1895, be adopted."

Mr. Alvia seconded.

Mr. C. Perera moved as an amendment "that fresh tenders be called for."

Hon. A. de A. Seneviratne seconded.

6. The report dated August 19, 1895, of the Special Committee, with reference to the proposal to form a street along the approach road to the Victoria Bridge, was laid before the Council, having been previously printed and circulated.

Mr. Morgan moved the adoption of the report. Captain Bayley seconded.—Carried.

7. A letter No. 127 dated August 31, 1895, from the Colonial Secretary, was laid before the Council, intimating that the Government is willing to hand over to the Municipality the whole of the land known as the "Kachcheri, Grass Garden," exclusive of the kachcheri compound.

Mr. Dias moved "that the Government be thanked for the generous manner in which they have accepted the Council's proposal, and that the land offered be accepted on the same conditions."

Mr. C. Perera seconded.—Carried.

8. A letter No. 128 dated August 31, 1895, from the Colonial Secretary, with reference to the prohibition of bathing in the lake opposite the Echelon Barracks, was laid before the Council.

Mr. Alvis moved "that the Council will be glad to comply with the request made to prohibit bathing in the lake opposite the Echelon Barracks, after a suitable bathing-place is provided for the public at the expense of this Council, and on Government undertaking to supply such bathing-place with water gratis."

Dr. Vanderstraaten seconded.

Captain Bayley moved as an amendment "that bathing be prohibited at the place referred to opposite the Echelon Barracks."

Mr. C. Perera moved "that the application be declined." Mr. Dias seconded.—Carried.

10. A letter dated September 5, 1895, from Messrs. Boustead Brothers, inquiring if the Council is in a position to consider an application from them for a concession to construct tramways, was laid before the Council.

Resolved,—That Messrs. Boustead Brothers be informed that the Council is prepared to receive an application.

11. A letter No. 130 of September 5, 1895, from the Colonial Secretary, furnishing information relating to the water supply of 1894, asked for by resolutions of the Municipal Council of June 14 last, was read.

12. An application dated August 25, 1895, from the Sanitary Officer, for an extension of leave from September 12 to 30, was laid before the Council.

Resolved,—That the extension of leave applied for be granted.

13. The Auditor-General's remarks on the accounts for March, 1895, received with letter No. 50 of July 31, 1895, were laid on the table.

14. The City Analyst's report dated August 31, 1895, on the town water for August, 1895, was laid on the table, having been previously printed and circulated.

15. Reports of Inspectors on licensed carriages, and kerosine, poison, and gunpowder shops for September 1895, were laid on the table.
