## LAND SETTLEMENT ORDINANCE.

## Settlement Order.

WHEREAS a settlement notice under section 4 of the Land Settlement Ordinance, was duly published in the *Gazette* No. 8,448 of April 28, 1939, and as otherwise required by the said section, in respect of the lands situated in the village of Kekulehya, in Udugaha pattuwa, Rayigam korale of the Kalutara District, in the Western Province, and described as lots 1 and 3 in forest survey preliminary plan No. 117 (*vide* Settlement Notice No. 1,961):

And whereas all claims received in pursuance of the said notice have been duly dealt with in accordance with the provisions of the said Ordinance:

I, the undersigned, in pursuance of the powers conferred on me by section 5 (5) of the said Ordinance, do hereby make order that the said lands be settled as specified in the schedule to this order.
