# MISCELLANEOUS LAND NOTICES.

L. J. 737 Lease of Crown Land.

NOTICE is hereby given that the Government Agent of the Western Province will receive tenders for the purchase of the lease of the under-mentioned Crown land for a period of five years from January 1, 1942.

2. The tenders which must be in sealed envelopes will be received at the Colombo Kachcheri until 11 A.M. on Thursday, February 19, 1942, when they will be opened. All persons making the tenders will be required to be present or to a large of Government Agent by some duly accredited agent that the tender is made bona fide.

CONDIT ONS.

- 1. The highest tenderer shall be declared the purchaser.
- 2. Six months' rent shall be paid in cash as security on the day of sale, and the rent shall be paid by the lessee, in equal quarterly instalments in advance. The six months' rent paid as herein will be credited to revenue and accounted for at the termination
- The purchaser is only entitled to cultivate (not permanent cultivation) and take the produce of the land.
- The purchaser or his workmen shall not cut down any trees or interfere with any existing fence or boundary.
- The purchaser shall be bound to fence the land leased to him, if called on by the Government Agent to do so.
- The purchaser shall keep the land clean and m good or pay all rates and taxes, and comply with Municipal regulations.

- The Government Agent or any one acting under his authority
- will be entitled to re-enter into occupation at any time on giving three months notice to the lessee without compensation.

  8. The purchaser shall not assign, transfer, or sublet the land without the written permission from the Government Agent, Western Province, to do so.
- 9. If the whole or any portion of the and is required by Government before the expiry of the lease, such land or portion shall be surrendered on a month's notice being given, a proportionate reduction in the rental will be made for the unexpired period of the lease respecting the land or portion thereof resumed by the Crown for which rent has previously been paid.
- 10. Putting up of structures of any sort or the running of tea booths on the land without the permission of the Government Agent previously barned in writing is strictly prohibited.
- the event of any breach of the foregoing anditions, the Government Agent shall have the power to resume possession of the land and eject the purchaser and his workmen from the land without compensation.
- 12. The Government Agent eserves the right to reject any tender or all tenders.
