Regulation 12 of the Defence (Trading with the Enemy) Regulations, published in *Gazette Extraordinary* No. 8,501 of September 11, 1939, is hereby amended, in paragraph (2) of that Regulation, by the omission of the words "and the Minister for Labour, Industry and Commerce".

1. Regulation 5 of the Defence (Finance) Regulations published in Gazette Extraordinary No. 8,509 of September 19, 1939, is hereby amended in paragraph (5) of that Regulation by the substitution, for the words "the Financial Secretary who shall, before disposing of any appeal against the refusal of a certificate for any purpose mentioned in paragraph (3) (a) or paragraph 3 (b), consult the Minister for Labour, Industry and Commerce.", of the words "the Financial Secretary."

Regulation 2 of the Defence (Finance No. 2) Regulations published in Gazette Extraordinary No. 8,525 of October 11, 1939, is hereby amended in paragraph (6) of that Regulation, by the substitution, for the words "the Financial Secretary who shall, before disposing of any such appeal, consult the Minister for Labour, Industry and Commerce.", of the words "the Financial Secretary.".

REGULATIONS.

- 1. The Defence (Control of Exports) Regulations published in Gazette Extraordinary No. 8,541 of October 31, 1939, are hereby amended as follows:—
 - (1) in paragraph (2) of Regulation 2, by the substitution, for the words "the Minister for Labour, Industry and Commerce.", of the words "the Financial Secretary.";

(2) in Regulation 8-

(a) by the omission of paragraph (3) of that Regulation;

(b) by the renumbering of paragraph (4) of that Regulation as paragraph (3); and

- (c) by the substitution, in paragraph (2) and in renumbered paragraph (3) of that Regulation, for the words "the Minister", of the words "the Financial Secretary".
- 2. For the purpose of giving effect to the preceding Regulation, any appeal duly preferred to the Minister for Labour, Industry and Commerce prior to the twenty-eighth day of February, 1940, under the Defence (Control of Exports) Regulations, shall be deemed to be an appeal preferred to the Financial Secretary.

REGULATIONS.

- 1. The Defence (Control of Imports) Regulations published in Gazette Extraordinary No. 8,541 of October 31, 1939, are hereby amended as follows:—
 - (1) in paragraph (2) of Regulation 2, by the substitution, for the words "the Minister for Labour, Industry and Commerce.", of the words "the Financial Secretary.";

(2) in Regulation 5-

(a) by the omission of paragraph (5) of that Regulation;

(b) by the renumbering of paragraph (6) of that Regulation as paragraph (5); and

- (c) by the substitution, in paragraph (4) and in renumbered paragraph (5) of that Regulation, for the words "the Minister", of the words "the Financial Secretary".
- 2. For the purpose of giving effect to the preceding Regulation, any appeal duly preferred to the Minister for Labour, Industry and Commerce prior to the twenty-eighth day of February, 1940, under the Defence (Control of Imports) Regulations, shall be deemed to be an appeal preferred to the Financial Secretary under those Regulations and may be disposed of accordingly.
