# Notification of Land Kachcheri to select Persons to receive Permits—(Middle-class Ceylonese).

NOTICE is hereby given that the Government Agent, Northern Province, will hold a Land Kachcheri under the Land Development Ordinance (Cap. 320), at 2.30 v m. on Saturday, May 22, 1943, at the Kilinochchi Circuit Bungalow to consider applications for lands particulars of which are given below, and to select persons to receive permits for portions thereof according to their ability to cultivate.

- 2. The allotment will be confined to Middle-class Ceylones
- 3. All applications must reach the Government Agent, Northern Province, at the Jaffna Kachcheri on or before May 18, 1943.
- 4. Every applicant should attend the Land Kachcheri in person or depute someone to represent him. If neither the applicant nor any person deputed to represent him. If neither the applicant nor any person deputed to represent him attends the Land Kachcheri, the Government Agent, Northern Province, may presume that the applicant does not wish to pursue the application further.
- 5. Every applicant selected will be exempted from annual payment for a period of three years.
- 6. Inquiries with regard to the Land Kachcheri should be addressed to the Government Agent, Northern Province.
- 7. Every selected applicant should pay at the Land Kachcheri a sum of rupees three per acre or part of an acre. This amount will be kept in deposit and annual payment will be defrayed from it as they fall due. If a permit is cancelled for any fault on the part of the permit-holder, the balance of the deposit will be confiscated.
- 8. Applications must be made on the prescribed form, copies of which can be obtained at the Jaffna Kachcheri.
