(3) The purchaser of the lease will not be entitled to take the produce of the coconut, jak, rubber and any other trees standing on lot 5, the lease of which is separately sold by public auction annually.

(4) The tenderer whose tender is accepted (hereinafter referred to as "the lessee") will be required to deposit immediately after his tender has been accepted, a sum equal to three months' rent as cash security.
