#### SPECIAL COMMODITY LEVY ACT, No. 48 OF 2007

#### Order under Section 2

BY virtue of the powers vested in me under Section 2 of the Special Commodity Levy Act, No. 48 of 2007, I, Ravi Karunanayake, Minister of Finance, the Democratic Socialist Republic of Sri Lanka, do by this order impose in respect of list of commodities specified in Column I of the Schedule hereto a Special Commodity Levy, at the rates specified in the corresponding entries in Column II of that Schedule. This Order shall be valid for a period as described in Column III of that Schedule, commencing from 29th January 2016, subject to provisions of Sub section (3) of Section 2 of the Special Commodity Levy Act, No. 48 of 2007.
