THE DEFENCE FORCE ORDINANCE AND THE DEFENCE (CEYLON ELECTRICAL AND MECHANICAL CORPS) REGULATIONS.

ORDER made by the Governor by virtue of the powers vested in him by section 14 of the Defence Force Ordinance (Chapter 258) and by Regulation 4 of the Defence (Ceylon Electrical and Mechanical Corps) Regulations.

Order.

Rates of Pay for Members of the Ceylon Electrical and Mechanical Corps.

- 1. Officers and other ranks of Category A will be entitled to the scales of pay laid down for officers and other ranks of the other Corps of the Ceylon Defence Force, and under the same
- 2. (a) Officers and other ranks of Category B will continue to receive their civil salary together with service pay referred to in sub-paragraph (b).
- (b) Service pay shall be computed on the basis of the civil salary according to the following scale of percentages:—

In the case of the 1st unit of 25 per cent. of that unit or

 In the case of the 2nd unit of

 In the case of the 3rd unit of
 150 rupees or any part thereof

- (c) Officers and other ranks shall not be entitled to earn overtime under the Public Service Regulations while they are on full-time military duty.

(d) Overtime or civil or military allowances shall not be

taken into account in computing service pay.

(e) "Ordinary pay", for purposes of the Army Act, King's Regulations and other Regulations, is defined as civil salary (exclusive of overtime, bonus, or civil or military allowances)

plus service pay.

(f) "Day's pay", in the case of members in receipt of ordinary pay on a monthly basis, is defined as one-thirtieth of

the ordinary pay for one month.

3. Followers will be entitled to the scales of pay laid down for followers of the Ceylon Efigmeers, and under the same conditions.

THE DEFENCE FORCE ORDINANCE AND THE DEFENCE (CEYLON ELECTRICAL AND MECHANICAL CORPS) REGULATIONS.

REGULATIONS for the Ceylon Electrical and Mechanical Corps, made by the Officer Commanding the Troops, Ceylon, after consultation with the Commandant, Ceylon Defence Force, and approved by the Governor, under sections 9 and 12 of the Defence Force Ordinance (Chapter 258) and the Defence (Ceylon Electrical and Mechanical Corps) Regulations.

Regulations.

MEMBERS OF CATEGORY 'A'.

1. Members of Category 'A' will be governed by the Regulations for the Ceylon Defence Force, except where otherwise hereinafter provided.

MEMBERS OF CATEGORY 'B' ON FULL-TIME MILITARY DUTY.

2. Members of Category 'B' on full-time military duty will be governed by the Regulations for the Ceylon Defence Force, except where otherwise hereinafter provided.

MEMBERS OF CATEGORY 'B' ON COMPULSORY LEAVE.

- 3. Members of Category ' B' on compulsory leave will be governed by the provisions of the next following paragraphs :—

Leave concessions will be governed by the Public Service Regulations.

- (b) Medical and Dental.
- (1) Free medical treatment by a Military Medical Officer will be provided.
- (ii) No member will be entitled to free dental ${f t}$ reatment.
- (c) R ttrons.

Members will be entitled to Dry Rations, according to the scale authorised for the time being by Headquarters, Ceylon Army Command.

(d) Accommodation.

Members will not be entitled to accommodation.

- (c) Travelling and Subsistence.
 - (i) Travelling allowances on civilian duties will be governed by the Public Service Regulations.
 (ii) Travelling and subsistence allowances on military
 - duties will be governed by the Regulations for the Ceylon Defence Force.

FOLLOWERS.

4. Followers will be enrolled under, and be governed by, the Regulations relating to the followers of the Ceylon Engineers.

CLOTHING AND EQUIPMENT.

5. Clothing and equipment for members and followers will be in accordance with the scales and subject to the provisions set out in the Schedule.

Uniform Allowance.

Officers will be allowed an initial grant at the same rate and under the same conditions as are prescribed for officers of other Corps by the Regulations for the Ceylon Defence Force.

AUTHORISED SCALES OF OFFICE FURNITURE.

- 7. (a) For Unit Headquarters.
- (b) For a District (Company) Headquarters.

Offices will be equipped at scales laid down from time to time by Headquarters, Ceylon Army Command.

BOOKS, STATIONERY AND FORMS.

8. These will be arranged for according to the normal practice of the Ceylon Defence Force.

TYPEWRITERS.

9. Unit Headquarters and District (Company) Headquarters will each be entitled to one typewriter.

PAY ACCOUNTING.

 (a) Officers and other ranks of Category 'A' and Followers.

On the normal system followed in the case of the Ceylon Defence Force.

(b) Officers and other ranks of Category 'B'.

Through the Accountant, Electrical Department, Colombo.

TELEPHONES.

11. These will be arranged by the Chief Signal Officer through normal channels as and where necessary.

Schedule.

CLOTHING, EQUIPMENT, &C.

Clothing and Equipment-Officers.

1. Officers must purchase clothing and equipment on the scale laid down in Part 1 of Appendix A to this Schedule. They will be provided free with clothing and equipment on the scale laid down in Part II of Appendix A to this Schedule.

Clothing and Equipment-Other Ranks and Followers.

2. Other ranks of both categories and followers will be provided free with clothing, necessaries and equipment on the scale laid down in Appendix B to this Schedule. Replacements due to fair wear and tear, or loss occasioned by enemy action will be free.

Cold Weather Clothing and Equipment.

3. Members (other than officers) of both categories and followers may, at the discretion of the Officer Commanding the Troops, Ceylon, be provided free, and in addition to the appropriate scale authorised in paragraph 2, with cold weather clothing and equipment when stationed at any place of an altitude of 4000 feet or above.

Equipment-Additional.

4. Equipment additional to that sanctioned in Appendices 'A' and 'B' may be issued free to officers and other ranks of both categories and followers, at the discretion of the Officer Commanding the Troops, Ceylon.

Return of Equipment and Clothing.

5. All members and followers, on leaving the Corps for any reason, must return all equipment and clothing issued free as aforesaid.

Wearing of Uniform.

6. Uniform must be worn by officers, other ranks and followers at all times except during games and recreations and except on occasions specified from time to time by the Commanding Officer at his discretion.
