Schedule A to the principal Ordinance is hereby amended in paragraph 3 of the Rules and Orders set out therein, by the substitution, for all the words from "take into account" to the words "such advances and deductions", of the following -

"take into account any deductions authorised to be made by or under the provisions of any other written law from the wages of the plaintiff or each of the plaintiffs and shall apply the amount of such deductions "

### **Objects** and Reasons
