THE DEFENCE (CONTROL OF EXPORTS) REGULATIONS.

Order.

BY virtue of the powers vested in me by regulation 3 (1) of the Defence (Control of Exports) Regulations, I, Andrew Caldecott, Governor of Ceylon, do by this Order amend the order of exemptions under that regulation published in Gazette No. 8,787 of August 29, 1941 (as last amended by the Order published in Gazette No. 8,822 of December 5, 1941), by the addition immediately after paragraph (b) (viii.) of that Order, of the following new sub-paragraph:—

THE FOOD CONTROL ORDINANCE.

Order No. 1.

BY virtue of the powers vested in me by section 4 (1) (a) of the Food Control Ordinance (Chapter 132), I, George Claude Stanley Corea, Minister for Labour, Industry and Commerce, do by this Order prohibit the transport or removal of paddy and rice from the areas specified in the first column of the Schedule hereto, except under the authority of a permit issued by the person mentioned in the corresponding entry in the second column of that Schedule.
