THE RICE RESERVES ORDINANCE, No. 52 of 1941.

Notification.

BY virtue of the powers vested in me by section 7 of the Rice Reserves Ordinance, No. 52 of 1941, read with section 15 of the Interpretation Ordinance (Chapter 2), I, Andrew Caldecott, Governor of Ceylon, do hereby rescind the notification under the aforesaid section 7 of the Rice Reserves Ordinance, No. 52 of 1941, published in Gazette Extraordmary No. 8,835 of December 22, 1941.

THE CUSTOMS ORDINANCE.

BY virtue of the powers vested in me by section 24 (5) of the Customs Ordinance (Chapter 185), I, Andrew Caldecott, Governor of Ceylon, do by this notification amend Schedule A to the notification under that section published in *Gazette* No. 8,751 of June 6, 1941, by the substitution, for all the words from "Cigarettes" to "store.", of the following:—

"Cigarettes manufactured in Ceylon and containing as an ingredient thereof tobacco or paper upon which import duty has been paid. Containers manufactured in Ceylon which are used for packing such eigarettes and upon any ingredient of which import duty has been paid."

Rule.

The rules made under section 24 (4) of the Customs Ordinance and published in Gazette No. 8,751 of June 6, 1941, are hereby amended by the addition, immediately after rule 6, of the following new

- "6A. Notwithstanding anything to the contrary in the preceding rules, rebate of the whole of the import duty paid on the following articles shall be allowed:—
- (a) tobacco and paper contained in cigarettes manufactured in
 - Ceylon;
 (b) ingredients of containers manufactured in Ceylon and used for packing such cigarettes.

Such rebate shall be allowed notwithstanding that the import duty paid is less than five runees."

THE DEFENCE (MISCELLANEOUS) REGULATIONS.

ORDER made by the Governor by virtue of the powers vested in him by regulation 14B of the Defence (Miscellaneous) Regulations.

Part I. General.

1. Subject to the provisions of paragraph 3, no person shall acquire any map of any part of the British Empire, drawn to a scale of, or exceeding, four miles to one inch except under the authority

of, or exceeding, four miles to one inch except under the authority of a licence granted by the Surveyor-General.

2. (1) Subject to the provisions of paragraph 3, no person shall sell any such map as aforesaid to any other person except upon production by such other person of a licence so granted authorising him to acquire the map.

(2) Where any person sells any such map as aforesaid upon production of a licence, he shall endorse the fact of sale upon the licence and transmit the licence to the Surveyor-General:

Provided that where the licence authorises the acquisition of more than one map, it shall not be necessary to transmit the licence to the Surveyor-General until all the maps authorised by the licence to be acquired have been acquired by the holder of the licence.

3. Nothing in this Part of this Order shall apply with respect to the acquisition of a map by a servant of His Majesty, or the Chairman of a local authority, or the Chairman of the Colombo Port Commission, acting in the course of his duty as such.

Part II.

Special Provisions relating to Aliens.

4. Subject to the provisions of paragraph 6, an alien shall not after the 27th day of January, 1942, have in his possession any map of any part of the British Empire drawn to a scale exceeding twelve

miles to one inch or any guide-book to any such part, except under the authority of a licence granted by the Deputy Inspector-General of Police, Criminal Investigation Department:

Provided, however, that where application for permission to have in his possession any map or guide-book is made—

- (a) in the case of an alien who is at the date of this Order in Ceylon, before the 27th day of January, 1942; or
 (b) in the case of an alien who enters Ceylon after the date of this Order, within seven days of the date of his entry,

the alien may retain the map or guide-book in his possession pending the determination of his application.

5. Subject to the provisions of paragraph 6, an alien who has in his possession any such map or guide-book as is mentioned in the last foregoing paragraph shall, not later than the 27th day of January, 1942, or, in the case of an alien who has made an application under the last foregoing paragraph, not later than three days after the date on which his application is refused, deliver the map or guide-book to the officer in charge of a police station; and the said officer is hereby authorised to destroy any map or guide-book so delivered to him.

6. This Part of this Order shall not apply to any agency deliver.

6. This Part of this Order shall not apply to any person duly recognized as being a consul-general, consul, vice-consul or consular

Part III.

Interpretation and Short Title.

7. In this Order-

"British Empire" includes a British Protectorate or Protected State and any territory in respect of which a mandate on behalf of the League of Nations has been

- mandate on behalf of the League of Nations has been accepted by His Majesty;
 "guide-book" includes road-book;
 "sell" includes distribute, dispose of, and part with possession of; and "sale" shall be construed accordingly.
- This Order may be cited as the Defence (Control of Maps) Order, 1942.
