1 The right the lease of which is to be sold is the right to tap for rubber 1,049 rubber trees and to take the produce of 770 bearing coconut trees, 518 non bearing coconut trees, 6 breadfruit trees, 143 arecanut trees, 70 bearing jak trees, 46 non-bearing jak trees and 45 mango trees in the garden of the Infectious Diseases Hospital at Angoda, and the tenderer whose tender is accepted will be entitled, in addition, to receive the coupons if such coupons are issued by the Rubber Controller in respect of the said rubber trees.
