THE QUARANTINE AND PREVENTION OF DISEASES ORDINANCE.

Notification.

BY virtue of the powers vested in me by regulation 1 of the regulations under sections 2 and 3 of the Quarantine and Prevention of Diseases Ordinance (Chapter 173), published in the *Supplement to Gazette* No. 7,481 of August 28, 1925, I, Andrew Caldecott, Governor of Ceylon, do by this Notification confirm the declaration of the "diseased locality" specified in the Schedule hereto, made by the Acting Government Agent, North-Central Province, the proper authority in that behalf, on May 22, 1942.

Schedule.

1. The Village of Perimiyankulama within Nuwaragam korale of Nuwaragam palata in the North-Central Province, bounded as follows:—

- North : Village boundaries of Parasangahawewa, Palugaswewa and Elapatwewa.
- East : Village boundary of Pankuliya
- South : Administrative limits of the Anuradhapura Urban Council.
- West : Village boundaries of Ihala Kudawewa, Pahala Hammillewa and Katukeliyawa.

2. The area of land within the village limits of Kombichchikulama in the Peace Officer's Division of Ponnarankulama of Kanadara korale in Nuwaragam palata in the North-Central Province, bounded as follows:—

- North : Footpath from Kombichchikulama tank bund to Malwatu-oya, originally marked as lot 1k in F. V. P. 258.
- West : Malwatu-oya.
- East and South : Railway line.

POTATOES, BOMBAY ONIONS, RED ONIONS AND ATTA FLOUR.
THE CONTROL OF PRICES ORDINANCE, No. 39 OF 1939.

Revoking Order.

BY virtue of the powers vested in the Deputy Controller of Prices by section 3, sub-section (13) (a) of the Control of Prices Ordinance, as amended by Order No. 43 of 1939, I, Charles Joseph Dane Lanktree, Deputy Controller of Prices, Nuwara Eliya District, do hereby revoke my order dated March 25, 1942, in so far as it relates to the maximum prices above which Potatoes, Bombay Onions, Red Onions and Atta Flour shall not be sold within the Nuwara Eliya District, published in *Government Gazette* No. 3,900 of April 2, 1942.
