THE CEYLON (STATE COUNCIL ELECTIONS) ORDER IN COUNCIL, 1931.

Notice under Article 36 (4).

Election of a member of the State Council for the Electoral District No. 2, Colombo Central, in pursuance of a notice under Article 23 (3) published in Gazette Extraordinary No. 8,913 of April 15, 1942.

BY virtue of the powers vested in me by Article 36 (4) of the Ceylon (State Council Elections) Order in Council, 1931, I, Andrew Caldecott, Governor of Ceylon, do by this notice order that no male polling agents shall, during the hours of polling, be admitted to the polling stations which are specified in the Schedule hereto and which have been reserved, by notice published in Gazette No. 8,937 of May 29, 1942, exclusively for the use of female voters at the election of a member of the State Council for the Electoral District No. 2, Colombo Central.

THE EMERGENCE POWERS (DEFENCE) ACTS, 1939 AND 1940.

DEFENCE Regulations made by the Governor by virtue of the powers vested in him by the Emergency Powers (Defence) Acts, 1939 and 1940, of the Imperial Parliament, as adapted, modified and extended to Ceylon by the Emergency Powers (Colonial Defence) Order in Council, 1939, and the Emergency Powers (Colonial Defence) (Amendment) Order in Council, 1940.

Regulations.

Regulations.

1. These regulations may be cited as the Defence (Invalidation of certain Petrol Permits) Regulations, 1942, and shall be read and construed as one with the Petrol (Control of Supplies) Ordinance, No. 52 of 1939, hereinafter referred to as "the Ordinance".

2. Every permit, issued or purporting to have been issued under the Ordinance in respect of the month of June, 1942, which bears the figure and word "20 GALLONS" imprinted on the face thereof is hereby cancelled; and no vendor shall sell or deliver any petrol to any person upon surrender of any coupon removed from any such permit.

3. Where any permit which is cancelled by the provisions of regulation 2 is surrendered to the Controller by the holder of the permit. the Controller may in his discretion, if he is satisfied that such holder is the person to whom the permit was issued under the Ordinance, issue to that person one or more new permits which will enable that person to obtain a quantity of petrol not exceeding the quantity, represented by the unused coupons attached to the permit so surrendered.
