Ruleq

- These rules may be cited as the Trincomalee Special Area Rules, 1943
- 2 That part of the Truncomalee District which is described in the Schedule hereto is hereby declared to be "the special area" for the purposes of these rules
- No enemy alien shall enter or remain in the special 3 area
- The Fortress Commander of Trincomalee shall have power-
 - (1) to require the attendance before him of any person who is within the special area,
 - (2) to question him as to the reasons for his being in that area, and
 - (3) where he is of opinion that the presence of such person in that area is prejudicial to the public safety, the defence of the Island, the maintenance of public order or the efficient prosecution of the war, to make a removal order in respect of such person, unless it is shown to his satisfaction that such person—
 - (a) is a member of His Majesty's forces or of any Department of the Government of Ceylon, or

- (b) was, at the date of the publication of these rules in the Gazette, the owner of any land or premises situated in that area, or
- (c) was, at the aforesaid date-
 - (1) the occupier of any such land or premises, or (11) a member of the family of any such occupier dependent on and living with

such occupier


In this rule, "occupier", in relation to any land or premises not actually occupied by the owner thereof, means the person who, by virtue of any contract or agreement entered into with such owner, is entitled to have the exclusive pos session of the land or premises

- 5 A removal order made under rule 4 may require the person in respect of whom it is made to quit the special area within such time or along such route and in such manner as may be specified therein
- 6 Every person in respect of whom a removal order is made, under rule 4 shall quit the special area in accordance with the order, and shall thereafter, as long as the order is in force, remain out of the special area
- Any person in respect of whom a removal order is made under rule 4 may, if he contravenes or fails to comply with the provisions of rule 6, be arrested without a warrant by any police officer and may be removed from the special area in such manner as the Foitress Commander may direct, and shall, when so arrested, be deemed to be in lawful custody until he is so removed

Schedule

All the area which is depicted as a hatched area in the sketch set out hereunder and which is bounded by a line drawn from the sea coast along the SOUTH bank of the CREEK at ms 12\frac{3}{4} on road Trincomalee Kuchchaveli in a SW direction and thence SOUTH to the POINT where the TRACK from SOUTH of ms 12 on road Trincomalee Kuchchaveli joins the shore of the LAGOON Thence along a line drawn SW, to the BRIDGE atms 9\frac{1}{4} road Trincomalee Anuradhapura and thence along a line drawn SOUTH to ms 103 on road Trincomalee Kandy Thence along the EAST bank of the PALAMPOTTA ARU to TAMBALAGAM BAY Thence along the SOUTH shore of TAMBALAGAM BAY to the EAST bank of the KATTA ARU Along this EAST bank to its junction with the UPPAR ARU Thence along a line drawn \{ mile inland from the BEACH of KODDIYAR BAY to the EAST bank to the bifurcation of this river From Along this EAST bank to the bifurcation of this river From this bifurcation along a line to m s 63 on road Trincomalee-Batticaloa Thence in a N E direction along a line drawn to the S W corner of ILAKKANTAI KULAM Along the WEST bank of this KULAM to its junction with the BUND at the NORTH corner Thence N E along the TRACK to at the NORTH corner Thence NE along the TRACK to ILAKKANTAI VILLAGE to the point where it leaves the PADDY LAND Thence along a line drawn to the junction PADDY LAND Thence along a line drawn to the junction of the NORTH bank of the CREEK, SOUTH to ROCKY HEADLAND, and the COAST Thence due EAST to a point at sea 3 miles from shore and thence NW along a line parallel to the COAST to a POINT 3 miles NORTH of FOUL POINT Thence NW to a POINT 3 miles due EAST of SWAMI ROCK and thence NORTH along a line parallel to the COAST to a POINT 3 miles due EAST of the junction of the COAST and the SOUTH bank of the CREEK at m s 123 road Trincomalee Kuchchaveli
