### A PROCLAMATION

A CALDECOTT

KNOW Ye that by virtue of the powers vested in me by sections 3 and 6 of the Village Communities Ordinance (Chapter 198), I, Andrew Caldecott, Governor of Ceylon, do by this Proclamation—

(1) declare that with effect from the first day of January, 1944, the area now known as the town of Huluganga, which forms part of the Divisional Revenue Officer's Division of Pata Dumbara in the Kandy District of the Central Province, and is more fully described in the Schedule hereto, shall be brought within the operation of the said Ordinance, and

(2) alter and redefine, with effect from the aforesaid date the limits of the Pallispattu West village area defined in Schedule II to the Order published in Gazette No 8,102 of February 1, 1935, by the addition to that village area of the area now known as the town of Huluganga and more fully described in the Schedule hereto

Limits of the Town of Huluganga

North From the centre of the culvert on the Estate Road leading from Alakolella Estate Factory to Bungalow and near the boundary between Alakolella Estate and Tharanagala Estate eastwards along the centre line of the said Estate Road to a point Northwest of the Public Works Department landmark at the Northeastern corner of lot 2 in P P A 335

East From the last mentioned point South Eastwards across the Estate Road to the Public Works Department landmark at the North Eastern corner of lot 2 in P P A 335, thence South Eastwards and Southwards along the eastern boundaries of lots 2 and 3 in P P. A 335 crossing on its way the main road leading from Kandy to Bambarella at culvert No 21/4 to the northern boundary of Huluganga, thence South Westwards in a straight line across Huluganga and Huluganga Estate to a distance of 6 chains (which point is 2 chains and 60 links south of the northern end of the Sunday Market)

South From the last mentioned point South Westwards in a straight line to the 20th Mile Stone on the Main Road leading from Kandy to Bambaiella, thence South Westwards across the said Road to a distance of 1½ chains

West From the last mentioned point North-Westwards in a straight line to the South Western corner of lot 1 (Reservoir) in P P A 756, thence North Eastwards along the Western boundary of the said lot to its North Western corner, thence Northwards in a straight line to the large rock below the Mosque on the Southern Boundary of Huluganga, thence Northwards across Huluganga to its Northern boundary, thence North Westwards along the said boundary to a point South West of the stump of the old jak tree, thence North-Eastwards in a straight line to the culvert on the road leading to Alakolella Estate Factory, thence Northwards along the drain and along the row of arecanut trees and the row of trees which forms the boundary between Alakolella Estate and Tharanagala Estate to the starting point of the Northern limit of the area

THE VILLAGE COMMUNITIES ORDINANCE

Order

WHEREAS by Proclamations the area now known as the town of 'Huluganga in the Divisional Revenue Officer's Division of Pata Dumbara, in the Kandy District of the Central Province has, with effect from the first day of January, 1944, been excluded from the operation of the Small Towns Sanitary Ordmance (Chapter 197), and brought within the operation of the Village Communities Ordmance (Chapter 198), 'fand added to the Pallispattu West village area of the aforesaid Divisional Revenue Officer's Division

Now, therefore, by virtue of the powers vested in me by section 41 of the Village Communities Ordinance (Chapter 198), I, Andrew Caldecott, Governor of Ceylon, do by this Order, with effect from the first day of January, 1944—

- (a) transfer to the Village Committee of the aforesaid, village area the whole of the property and the funds acquired or received by or vested in the Sanitary Board of the Kandy District for the use and benefit of the town of Huluganga and specified in the Schedule hereto,
- (b) declare that such funds and the revenue derived from that part of the village area which is now known as the town of Huluganga shall be employed by the Village Committee for the use and benefit of the aforesaid part of that area,
- (c) direct the Village Committee to keep separate books of accounts in respect of the aforesaid part of that area,

(d) apportion and assign to the Village Committee the whole of the rights, liabilities, debts or obligations of the Santary Board of the Kandy District under any contract entered into by the said Board for the benefit of the town of Huluganga

The Lighting Restriction (Motor Cars) Order, 1942, published in *Gazette* No 8,877 of March 9, 1942, as amended by any subsequent Order, is hereby further amended by the substitu tion, for paragraph 6 of that Order, of the following new paragraph

"6 Subject as hereinafter provided, no spot light, fog lamp, reversing light, stop light, or interior light, and no other light or lamp of any description whatsoever (other than a head light, side light, or tail light) shall be used in or upon, or displayed from, any motor car, and no such light or lamp shall be equipped with a bulb

no such light or lamp shall be equipped with a bulb
Provided that nothing in the preceding provisions of
this paragraph shall be deemed or construed to prohibit
the use of a screened light, of a type approved by the
Minister, for the purpose of illuminating any sign or board
so approved and fitted to, or carried by, any motor car

- l The Defence (Miscellaneous) Regulations published in the Supplement to Gazette No. 8,533 of October 20, 1939, (as amended by any subsequent regulation) are hereby further amended in Regulation 31 thereof, as follows
  - (1) by the re-numbering of that regulation as paragraph (1) of Regulation 31,
  - (2) by the insertion, immediately after the re-numbered paragraph (1), of the following new paragraphs "(2) Any place provided by the Government for
    - the storage of any goods removed from any port under the preceding provisions of this regulation shall be deemed for all purposes to be a King's warehouse within the meaning of the Customs Ordinance, and in the application of the provisions of that Ordinance to such goods-
      - (a) section 104(4) of that Ordinance shall have effect as though there were substituted, for the words "ninety days", the words "fourteen days,"

- (b) section 108 of that Ordinance shall have effect as though there were substituted, for the words "three months", the words "fourteen days"
- (3) In any cases where any goods have been so removed and kept at any place, an authorised officer may refuse to give delivery thereof to the consignee or to any other person on his behalf, except upon payment to such officer of the costs incurred in the removal of such goods to such place All moneys paid to an authorised officer under this paragraph shall be credited to general revenue "

The Ceylon Air Navigation (Restriction in Time of War) Order, 1939, published in Gazette No 8,549 of November 17, 1939, (as amended by any subsequent Order) is hereby further amended as follows—

- (1) in paragraph 4 (1) of that Order, by the substitution, for sub-paragraph (a), of the following
  - "(a) between Talaimannar and Negombo, a route following the coastline within a corridor of two miles seaward of the coastline,"
- (2) by the substitution, for paragraph 5 of that Order, of the following new paragraph -
  - '5 (1) Every civilian aircraft approaching the coast of Ceylon shall fly at a height of 1,500 feet or below cloud base, whichever is the lower

    (2) Every civilian aircraft which flies over Ceylon—
  - (a) shall fly at all times at such a height as to be
  - clearly visible from the ground, and
    (b) shall not fly at a height lower than 1,000 feet
    except so far as may be necessary for the
    purpose of taking off or landing or except where weather conditions are such that the aircraft would not be clearly visible from the ground, unless flown at such lower height
  - (3) For the purposes of this paragraph, "height" means height above the surface of the ground or the water over which the aircraft is flying,, and
- (3) by the insertion, immediately after paragraph 6 of that Order, of the following new paragraph
  - "6A Every aircraft which approaches the area contained within a radius of two miles from the contained within a radius of two miles from the centre of any aerodrome shall conform to the Rules in Section V of Schedule IV to the Air Navigation (Colonies, Protectorates and Mandated Territories) Order, 1927, and shall make a circuit clear of the landing area in accordance with rule 43 of those Rules at a height below cloud base or below 1500 foot from ground level whichever height is 1,500 feet from ground level, whichever height is the lower"
