PROCLAMATION

By His Excellency SIR ANDREW CALDECOTT, Knight Grand Cross of the Most Distinguished Order of Saint Michael and Saint George, Commander of the Most Excellent Order of the British Empire, Governor in and over the Island of Ceylon with the Territories and Dependencies thereof

A CALDECOTT

KNOW Ye that in pursuance of the provisions of Article 74 of the Ceylon (State Council) Order in Council, 1931, I, Andrew Caldecott, Governor of Ceylon, do by this Proclamation signify the assent given by His Majesty the King, through one of His Principal Secretaries of State, to the Bill intituled "An Ordinance to amend the Bank of Ceylon Ordinance, No 53 of 1938", which was passed by the State Council on the Eighteenth day of November, One thousand Nine hundred and Forty three, and was reserved by me under Article 77 of the aforesaid Order in Council for the signification of His Majesty's pleasure

Given at Colombo, in the Island of Ceylon this Fourth day of December, One thousand Nine hundred and Forty three

THE URBAN COUNCILS ORDINANCE, No 61 of 1939

Order under sections 21 and 30

BY virtue of the powers vested in me by sections 21 and 30 of the Urban Councils Ordinance, No 61 of 1939, I, Andrew Caldecott, Governor of Ceylon, do by this Order—

- (1) revoke, subject to the provisions of paragraph (4), the order relating to the number of members of the Bandarawela Urban Council and to the number and limits of the electoral divisions of the town of Bandarawela, published in *Gazette* No 8 630 of July 5, 1940,
- (2) order under section 30 that, subject to the provisions of paragraph (4), the Bandarawela Urban Council shall consist of seven members and the town of Bandarawela shall be divided into seven electoral divisions with the limits defined in the Schedule hereto,
- (3) order under section 21 that, for the purposes of the general election of the members of the Bandarawela Urban Council to be held next after the date hereof and for the purposes of the application of the provisions of the aforesaid Ordinance in any matter relating or

incidental to or connected with that election, the Order set out in paragraph (2) shall be deemed to be operative on any day, prior to the day specified in paragraph (4), on which it may be necessary that that order should be so operative, and

- (4) declare that the provisions of paragraphs (1) and (2) shall come into effect on the day immediately following the date of expiration of the term of office of the members of the Bandarawela Urban Council who are in office at the date hereof

Electoral Divisions of the Town of Bandarawela.

Electoral Division No 1 *Tantiriya*

North From the centre of Culvert No 18/7 on Badulla Road eastwards and northwards along the centre line of the said road to the northern extremity of the eastern limit of the Urban Council area

East From the last mentioned point southwards along the eastern limit of the Urban Council area to its southern extremity

South From the last mentioned point westwards along the southern limit of the Urban Council area to a point near the junction of Poonagala Road and the Gansabhawa road leading to Gonamotawa, thence north westwards along the centre line of Poonagala Road to the centre of the junction with the Drive in lot 33 in Town Survey Sheet M 12/60 3 West

West From the last mentioned point northwards along the centre line of Poonagala Road to a point in prolongation of the eastern boundary of lot 30 in Town Survey Sheet M 12/60 3 West, thence again north westwards along the said prolongation and the eastern boundary of the said lot to Agalaawetenne Kandura, thence northwards along the centre line of the said Kandura to the centre of the Railway Line thence north westwards along the centre line of the Railway Line to a point due south of the centre of the junction of Pansala Road and the path east of lot 30 in Town Survey Sheet M 12/59 4 East, thence northwards in a straight line to the centre of the said junction, thence northwards across the said junction to the eastern boundary of the said lot 30, thence north eastwards along the eastern boundaries of the said lot 30 and of lot 24 to the centre of Kebillewela Kandura, thence north eastwards along the centre line of the said Kandura to the centre of the masonry diam east of lot 94 in Town Survey Sheet M 12/59 2 East, thence northwards along the centre line of the said diam to the starting point of the northern limit of the Division

Electoral Division No 2 *Sunday Fair*

North From the centre of the junction of Badulla Road and Pansala Road eastwards along the centre line of Badulla Road to the northern extremity of the western limit of Division No 1

East From the last mentioned point southwards along the western limit of Division No 1 to the centre of Pansala Road

South From the last mentioned point south westwards along the centre line of Pansala Road to the centre of the culvert over Kebillewela Kandura

West From the last mentioned point northwards along the centre line of Pansala Road to the starting point of the northern limit of the Division

Electoral Division No 3 Reservoir

North From the centre of Haputale Road where it meets the western limit of the Urban Council area north eastwards along the centre line of Haputale Road and Badulla Road to the northern extremity of the western limit of Division No 2, thence southwards and north eastwards along the western and southern limits of the said Division and south eastwards along the western limit of Division No 1 to the centre of the bridge on the railway line over Agalaarawetenne Kandura

East From the last mentioned point southwards and south eastwards along the western and the southern limits of Division No 1 to the southern limit of the Urban Council area

South From the last mentioned point westwards along the southern limit of the Urban Council area to Dambul kanda (old) Trig Station

West From the last mentioned point north westwards along the southern limit of the Urban Council area to the starting point of the northern limit of the Division

Electoral Division No 4 Price

North From the western extremity of the northern limit of the Urban Council area eastwards and north eastwards along the said limit to the centre of Ettampitiya Road

East From the last mentioned point southwards along the centre line of Ettampitiya Road to the centre of the junction with Esplanade Road, thence south eastwards along the centre line of the said road and Welimada Road to the northern limit of Division No 3

South From the last mentioned point south westwards along the northern limit of Division No 3 to the western limit of the Urban Council area, thence north westwards along the said limit to the centre of Price Road

West From the last mentioned point north westwards and northwards along the western limit of the Urban Council area to the starting point of the northern limit of the Division

Electoral Division No 5 Upper

North From the centre of Ettampitiya Road where it meets the northern limit of the Urban Council area south eastwards along the said limits to a distance of 28½ chains

East From the last mentioned point south eastwards along the northern limit of the Urban Council area to the centre of the path leading to Kebillewela through lot 5 in Town Survey Sheet M 12/59 2 East, thence southwards along the centre line of the said path to the centre of the junction with Grange Path, thence eastwards along the centre line of the said path to the centre of the junction with the path west of lot 6 in Town Survey Sheet M 12/59 2 East, thence southwards along the centre line of the said path to the centre of the junction of Upper Drive and the path leading to Grange Road, thence south westwards along the centre line of the said path and Grange Road to a point in prolongation of the western boundary of lot 57 in Town Survey Sheet No 12/59

2 East, thence southwards along the said produced line and western boundaries of lots 57 and 56 to the centre of Badulla Road

South From the last mentioned point south westwards along the centre line of Badulla Road to the southern extremity of the eastern limit of Division No 4

West From the last mentioned point north westwards along the eastern limit of Division No 4 to the starting point of the northern limit of the Division

Electoral Division No 6 Grange

North From a point on the northern limit of the Urban Council area at the centre of the path leading to Kebillewela through lot 5 in Town Survey Sheet M 12/59 2 East eastwards along the said limit to a point one chain and sixty links measured north westwards along the said limit from the centre of the path north of lot 3 in Town Survey Sheet M 12/60 1 West

East From the last mentioned point south eastwards along the northern limit of the Urban Council area to the eastern corner of lot 4 in Town Survey Sheet M 12/60 1 West

South From the last mentioned point north westwards along the northern boundary of lot 4 in Town Survey Sheet M 12/60 1 West and along the prolongation of the said boundary to the centre of Grange Road, thence south westwards and north westwards along the centre line of the said road to the centre of the junction of the path leading to lot 64 (St Anthony's Church Premises) in Town Survey Sheet M 12/59 2 East, thence southwards along the centre line of the said path to the northern boundary of the said lot 64, thence westwards and southwards along the northern and western boundaries of the said lot 64 to the centre of Badulla Road, thence westwards along the centre line of the said road to the southern extremity of the eastern limit of Division No 5

West From the last mentioned point north eastwards and northwards along the eastern limit of Division No 5 to the starting point of the northern limit of the Division

Electoral Division No 7 Bazaar End

North From the centre of the junction of Grange Road and the path leading to St Anthony's Church premises eastwards along the southern limit of Division No 6 to the northern limit of the Urban Council area, thence south eastwards along the said limit to the centre of the bridge on Badulla Road over Kebillewela Kandura

East — From the last mentioned point southwards along the centre line of Badulla Road to a point at the 17th mile stone on the said road

South — From the last mentioned point westwards along the centre line of Badulla Road to the southern limit of Division No 6 near the south western corner of St Anthony's Church premises

West — From the last mentioned point northwards along the southern limit of Division No 6 to the starting point of the northern limit of the Division

Kochchikade Ward

WHEREAS the Supreme Court has ordered that steps be taken under section 37 of the Colombo Municipal Council (Constitution) Ordinance on the footing that more than one candidate was nominated and that C A Perera was also duly nominated a candidate for the Kochchikade Ward of the Colombo Municipal Council, and whereas therefore my notification, under section 36 of the Colombo Municipal Council (Constitution) Ordinance appearing in *Government Gazette* No 9,198 and dated November 15, 1943, that Saptaratnajoti Saravanamuttu had been declared by the Returning Officer to be elected a Councillor for the Kochchikade Ward is of no effect, it is hereby notified that (1) in the Kochchikade Ward of the Colombo Municipal Council, the election of a councillor is contested, (2) that in the Kochchikade Ward, a poll will be taken between 8 A M and 5 P M on December 22, 1943, (3) that the names of candidates, the colours allotted, situations of polling stations, &c, are described in the schedule below
