WANTED BY THE POLICE.

Aromogam and David Gabriel. The Police Magistrate of Anuradhapura has issued warrant No. 17,511 for his arrest.

Gabriel *alias* Gabbo; charged with theft and escape from lawful custody of the rural police at Anuradhapura on October 14, 1895; is a Sinhalese; age, 18 years; height, 5 ft. 2 in.; make, stout; complexion, dark brown; nose, mouth; teeth, and eyes, ordinary; hair, cut; beard, scanty; sleepy look; birthplace, Anuradhapura; general residence, Anuradhapura; haunts Puttalam, Chilaw, Madampe, Kalpitiya, and Kurunegala; is unmarried; his mother is living at Anuradhapura, who is called Upasaka-amma, and is well-known to the Sergeant of the rural police, Anuradhapura, and Constables S. Aromagam and David Gabriel. The Police Magistrate of Anuradhapura has issued warrant No. 17,511 for his arrest.

Dompege Baron Perera; charged with voluntarily causing grievous hurt at Kotuwala on October 25, 1895; is a Sinhalese of the Wellala caste; religion, Buddhist; occupation, cultivator; age, 33 years; height, 5 ft. 5 in.; well built; complexion, brown; teeth, well set; eyes, black; hair, black, tied in a knot; wears a beard, moustaches, and whiskers; birthplace, Kotuwala, in

Ambatelanpahala in Coiombo District; haunts, Pamunuwela in Dalugama in Siyane korale west; is married; wife at Pamunuwela; is well known to the police vidane of Kotuwala. The Police Magistrate of Colombo has issued warrant No. 39,779 for his arrest.
