- (4) The lessee shall erect and complete upon the demised premises within one year from the commencement of the lease and in accordance with plans approved by the lessor or his agent a bought-leaf tea factory.
- (5) The lessee shall not sublet, sell, donate, mortgage or otherwise dispose of or deal with his interest in the lease without the written consent of the Land Commissioner on the lessor's behalf.
- (6) The lessee shall maintain all buildings erected by him upon the demised premises in good repair, pay all rates and taxes and erect and keep in good repair a substantial fence or boundary wall round the demised premises.
- (7) The lessee shall, at the expiry of the term of the lease or on its sooner determination, surrender the demised premises to the lessor, together with all buildings erected thereon and all additions, improvements and fixtures in good repair

and condition, and shall not be entitled to any payment of any compensation in respect of the said buildings, additions, improvements or fixtures or on any account whatever.
