THE EMERGENCY POWERS (DEFENCE) ACTS, 1939 AND 1940.

C.S.O.—CF. 204/105/38

DEFENCE Regulation made by the Governor by virtue of the powers vested in him by the Emergency Powers (Defence) Acts, 1939 and 1940, of the Imperial Parliament, as adapted, modified and extended to, Ceylon by the Emergency Powers (Colonial Defence) Order in Council, 1939, and the Emergency Powers (Colonial Defence) (Amendment) Order in Council, 1940.

Regulation.

The Defence (Detention of Aliens) Regulations, 1942, published in *Gazette* No. 8,900 of April 2, 1942, are hereby amended by the addition, at the end of those regulations, of the following new regulations:—

" 5. Where the Governor has reasonable cause to believe that any alien who is on board any vessel or aircraft arriving at any port or place in Ceylon has recently been concerned in acts prejudicial to the public safety or the defence of any part of His Majesty's dominions or the efficient prosecution of the war or in the preparation or instigation of such acts, the Governor may, by Order, direct the detention of the alien.

An authorised officer may arrest without warrant and may remove from such ship or aircraft any alien against whom an Order has been made under the preceding provisions of this regulation.

6. Any alien detained in pursuance of these regulations shall be deemed to be in lawful custody, and shall be detained in such place as may be authorised by the Governor and in accordance with instructions issued by him."

Order.

The Defence (Control of Maps) Order, 1942, published in *Gazette Extraordinary* No. 8,846 of January 12, 1942, is hereby amended as follows:—

(1) by the insertion, immediately after paragraph 5 of that Order, of the following new paragraph:—

" 5A. Exemption from this Part of this Order may be granted in writing by the Deputy Inspector-General of Police, Criminal Investigation Department, to any person who is an officer or a member of the crew of any ship or aircraft, and any exemption so granted may be for a specified period and subject to conditions and may be cancelled or varied by the said Deputy Inspector-General of Police."

(2) by the substitution, for paragraph 6 of that Order, of the following new paragraph:—

" 6. This part of this Order shall not apply to

(a) any person duly recognised as being a consul-general, consul, vice-consul or consular agent;

(b) any person who, being a national of any one of the States specified in the Schedule to this Order, has furnished a return in accordance with the provisions of the Aliens Registration Ordinance; or

(c) any person who is under fifteen years of age and is a national of any one of the States specified in the said Schedule.

Provided that the Governor may by Order direct, in relation to any particular person referred to in sub-paragraph (b) or sub-paragraph (c) of this paragraph, that this Part of this Order shall apply to that person."

(3) in paragraph 7 of that Order, by the insertion, immediately before the definition of " British Empire ", of the following:—

" " alien " has the same meaning as in the Aliens Registration Ordinance; " ; and

(4) by the addition, at the end of that Order, of the following Schedule:—

THE CONTROL OF PRICES ORDINANCE, No. 39 OF 1939.

STEEL OIL DRUMS.

Order.

BY virtue of the powers vested in me by section 3 of the Control of Prices Ordinance, No. 39 of 1939, I, Reginald Sydney Vernon Poulter, Controller of Prices, do, by this Order :—

- (i.) fix the prices specified in column 3 of the Schedule hereto to be the maximum retail price above which the article of the description and grade specified in the corresponding entry in column 1 and of the capacity specified in the corresponding entry in column 2 of that Schedule shall not be sold by retail within the Municipal limits of the town of Colombo ;
- (ii.) direct that for the purpose of this Order any sale of any quantity of Steel Oil Drums for the purpose of use shall be deemed to be a sale by retail ;
- (iii.) direct that any trader who, at any premises within the Municipal limits of the town of Colombo, exposes for sale any article of the description and grade mentioned in the Schedule hereto, shall exhibit in a conspicuous position at those premises, a notice on which there shall be set-out the maximum prices fixed by this Order in respect of that article of that description and grade ;
- (iv.) direct that every trader who sells any article of the description and grade mentioned in the Schedule hereto, shall give the purchaser of that article, on demand, a receipt in which there shall be set out—
 - (a) the date of the sale ;
 - (b) the number of drums sold ;
 - (c) the price paid for the quantity sold ; and
 - (d) the description and grade of the article sold.

WHOLE WHEAT.

Order.

BY virtue of the powers vested in the Controller of Prices by section 3 of the Control of Prices Ordinance, No. 39 of 1939, I, Reginald Sydney Vernon Poulter, Controller of Prices, do, by the Order :—

- (i.) fix the price specified in column 2 of the Schedule hereto to be the maximum retail price per measure above which the article of the description and grade specified in column 1 of the Schedule hereto shall not be sold within the Municipal limits of the town of Colombo ;
- (ii.) direct that no person shall sell the article of the description and grade mentioned in column 1 of the Schedule hereto which is adulterated with any other article ; and
- (iii.) direct that for the purpose of this Order "measure" shall be deemed to be the standard quart dry measure, equivalent to one-thirty-second part of a bushel.

THE CONTROL OF PRICES ORDINANCE, No. 39 OF 1939.

Order.

BY virtue of the powers vested in me by section 3 of the Control of Prices Ordinance, No. 39 of 1939, I, Reginald Sydney Vernon Poulter, Controller of Prices, do, by this Order :—

- (i.) fix the prices specified in columns 2, 3, and 4 of the Schedule hereto to be, respectively, the maximum price per bag (wholesale and retail), the maximum price per bushel (wholesale and retail), and the maximum retail price per measure above which the article of the description and grade mentioned in column 1 of the Schedule hereto shall not be sold within the Municipal limits of the town of Colombo ;
- (ii.) direct that for the purpose of this Order—
 - (a) any sale of any quantity of any article for the purpose of resale shall be deemed to be a sale by wholesale ;
 - (b) any sale of any quantity of any article for the purpose of consumption or use shall be deemed to be a sale by retail ;
 - (c) a measure shall be deemed to be the standard quart dry measure equivalent to one-thirty-second part of a bushel ;
- (iii.) direct that no trader shall sell the article of the description and grade mentioned in the Schedule hereto which is adulterated with any other article or with a similar article of an inferior description or grade or quality ;
- (iv.) direct that every trader who at any premises within the Municipal limits of the town of Colombo exposes for sale the article of the description and grade mentioned in the Schedule hereto shall exhibit in a conspicuous position at those premises a notice on which there shall be set out the maximum prices fixed by this Order in respect of that article ;
- (v.) direct that every trader who, within the Municipal limits of the town of Colombo, sells the article of the description and grade mentioned in the Schedule hereto shall give the purchaser of that article, on demand, a receipt in which there shall be set out—
 - (a) the date of the sale ;
 - (b) the quantity of the article sold ;
 - (c) the description and grade of the article sold ;
 - (d) the price paid for the quantity of the article sold ; and
 - (e) the nature of the transaction, that is to say, whether the sale was by wholesale or by retail.
