THE QUARANTINE AND PREVENTION OF DISEASES ORDINANCE.

Notification.

BY virtue of the powers vested in me by regulation 1 of the regulations under sections 2 and 8 of the Quarantine and Prevention of Diseases Ordinance (Chapter 173), published in the Supplement to Gazette No. 7,481 of August 28, 1925, I, Andrew Caldecott, Governor of Ceylon, do by this Notification confirm the declaration of the 'diseased localities' specified in the Schedule hereto, made by the Chairman of the Trincomalee Urban Council, the proper authority in that behalf, on January 27, 1944.

### Schedule.

1. The area within Ward No. 5 of the Trincomalee Urban Council limits, bounded as follows:—

North: Back Bay Beach.

113-J, N. 7022-1,478 (2/44)

East: The western side of the lane extending from Birch street to the Back Bay Beach.

South: North Coast road.

West: Along the barbed wire fence about 30 yards to the east of the boundary wall of the Urban Council cemetery running parallel to the said cemetery wall from the North Coast road to the Back Bay Beach.

2. The area within Ward No. 6 of the Urban Council limits, bounded as follows:—

North-east: North Coast road.

South-east: An imaginary line drawn along the western side of the arrack tavern at Uppuveli from the North Coast road along the footpath up to the boundary of the Railway Department land.

South-west: Railway Department land.

North-west: The barbed wire boundary fence along the eastern side of the Naval Department land at Uppuveli from the North Coast road thence along an imaginary line to meet the boundary of the Railway Department land.

# MUNICIPAL COUNCIL NOTICES.

Protective Zone.

WHEREAS the premises known as Royal Colombo Golf Links, situated within the Municipal limits of Colombo has been declared an infected area, I hereby under the provisions of section 6 (1) of the Contagious Diseases (Animals) Ordinance, 1909 (Chapter 327), establish the area enclosed within the boundaries herein set out as a protective zone namely:—

The area is bounded on the east and south by Kinda Ella. on the north by Castle street and part of Cotta road, on the north-west by Bullers road, on the west by Kanatte road.

This proclamation shall take effect from January 29, 1944.
